Cascade AIDS Project is the oldest and largest AIDS Service Organization serving Oregon and Southwest Washington. CAP's mission is to prevent HIV infections, support and empower people affected and infected by HIV/AIDS, and eliminate HIV/AIDS-related stigma. We carry out this work with a dedicated staff of over 60 employees, over 700 volunteers, and 19 Board of Directors. We operate with an annual budget of over \$5 million and provide housing and support services for people affected and infected by HIV/AIDS, prevention and education services to those at risk for HIV, and advocacy work. Many of our constituents face numerous barriers to their health, and ensuring culturally competent care is one way to begin to alleviate those barriers.

The best way to promote the Triple Aim goal of lower costs, better healthcare, and better outcomes is through providing the same high level of healthcare and human services to all Oregonians. Despite our work, some communities have poorer health outcomes than others and barriers to health include inaccurate and inconsistent data and a lack of culturally & linguistically appropriate care.
