- Design benefits, prepare specifications, analyze carrier responses
- Provide high-quality health, dental and other benefit plans for eligible employees at a cost affordable to districts, employees and taxpayers
- Prepare specifications, invite bids and take actions necessary to award contracts for health and dental benefit plan coverage of eligible employees
