- 6. Toxins
- 7. Mycotoxins

Scary fact: There are no ambient or occupational exposure limits for bioaerosols in the US. Since there is no limits, monitoring will be nonexistent, especially since the county and state agencies have been very clear they will not be monitoring due to lack of staff and funding.

I am very concerned for my health due to my diagnosis of severe psoriasis. For the record I have factual information about psoriasis from the Nation Psoriasis Foundation which states my condition which is as follows:

Psoriasis is a chronic, autoimmune disease that appears on the skin. It occurs when the immune system sends out faulty signals that speed up the growth cycle of skin cells. Psoriasis is not contagious.

There are five types of psoriasis. The most common form, plaque psoriasis, appears as raised, red patches covered with a silvery white buildup of dead skin cells. Psoriasis can occur on any part of the body and is associated with other serious health conditions, such as diabetes, heart disease and depression.

Psoriasis is the most common autoimmune disease in the U.S. As many as 7.5 million Americans have psoriasis.

This section below states what an autoimmune disease is and how it affects the body:

Autoimmune diseases arise from an inappropriate immune response of the body against substances and tissues normally present in the body. In other words, the immune system mistakes some part of the body as a pathogen and attacks its own cells. This may be restricted to certain organs (e.g. in autoimmune thyroiditis) or involve a particular tissue in different places the treatment of autoimmune diseases is typically with immunosuppressant—medication which decreases the immune response.

My son Anthony who is 12 was born with asthma and respiratory problems; he has a nebulizer and inhaler in the home. Was hospitalized for pneumonia and has communication delay

My 5 year old daughter Delaney has asthma issues and was hospitalized with pneumonia, she takes blood pressure medication on a daily basis. His immune system is compromised by the daily medication which leaves her susceptible to other health issues when exposed to the elements with the proposed composting site especially.

Our youngest daughter Maci who just turned 1 was hospitalized with pertussis (whooping cough), we do immunize out children but she was too young to get the vaccine when she contracted pertussis.

The fact we live so close to the proposed site will mean we have constant expose to the elements, page 2 last paragraph of the Cornell report states the result of a short term expose test to 17 healthy subjects not working in the wastes but were exposed to the site for 2 hours doing moderate exercise. Changes in their white blood cell counts, an increase in eosinophils were measured.
