HB2549 Fiscal Summary

HB2549 would require the Board of Parole & Post-Prison Supervision to conduct hearings, reclassify certain sex offenders, and to relieve certain sex offenders the obligation to register in Oregon as a sex offender.

CLASSIFICATION & ASSIGNMENT TO THE LEVEL SYSTEM

- All registered sex offenders in the state of Oregon will be assigned to a level within the registration system.
- The level will be based on the statistical likelihood of the sex offender committing another crime.
- The assignment to the level system will be based on an established assessment risk tool applicable to sex offenders.

Continued

- Level 1: Sex offenders who present the lowest risk of reoffending and requires a limited range of notification.
- Level 2: Sex offenders who present a moderate risk of reoffending and requires a moderate range of notification.
- Level 3: Sex offenders who present the highest risk of reoffender and requires the widest range of notification.

RELIEF FROM REGISTRATION

HB2549 establishes criteria that would allow Level 1 offenders to petition the Oregon Board of Parole & Post-Prison Supervision for relief from the obligation to report as a sex offender in Oregon.

RECLASSIFICATION

HB2549 establishes a process that would allow Level 2 & 3 offenders to petition the Oregon Board of Parole & Post-Prison Supervision to review and consider the reclassification to a lower level.

THE PROCESS

Classification & Level Assignment:

- Of the nearly 20,000 registered sex offenders, just over 16,000 have an applicable sex offender risk tool (Static99 or Static99R). The Oregon Board of Parole & Post-Prison Supervision will complete nearly 4,000 Static99R's on the remaining unclassified offenders in the state. This will be accomplished by December 1, 2016.
- The Oregon Board of Parole & Post-Prison Supervision will notify every registrant in the state advising of their assigned level by December 1, 2016.

Continued

Relief from Registration Process:

- On January 1, 2017, approximately 7,500 registered offenders will be eligible to petition the Oregon Board of Parole & Post-Prison Supervision for relief of their obligation to register as a sex offender.
- The Oregon Board of Parole & Post-Prison Supervision shall draft and establish rules for the hearing process in these matters. If the petitioner meets the criteria per statute a hearing will be conducted.
- If approved, the Oregon Board of Parole & Post-Prison Supervision shall grant relief from the obligation to register as a sex offender and notify the Oregon State Police regarding the decision.
- A filing fee in an amount determined by the Board will be applied for any such petition.

Continued

Reclassification Requests:

- On January 1, 2017, approximately 2,000 registered offenders will be eligible to petition the Oregon Board of Parole & Post-Prison Supervision for review and consideration of a reclassification to a lower level.
- The Oregon Board of Parole & Post-Prison Supervision shall draft and establish rules to make a determination in granting the reclassification petition.
- If approved, the Oregon Board of Parole & Post-Prison Supervision shall grant reclassification and notify the Oregon State Police regarding the decision.
- A filing fee in an amount determined by the Board will be applied for any such petition.

Appeal Process

Similar to the Oregon Board of Parole & Post-Prison Supervision's current practice, offenders may seek administrative review with the Board as a result of any disagreement with a Board action.

Revenue:

- There will be approximately 7,500 offenders who will be able to petition for relief on January 1, 2017. The anticipated filing fee rate is \$240 per petition. This equals 1.8 million dollars.
- There will be approximately 2,000 offenders who will be able to petition for their level to be re-classed on January 1, 2017. The anticipated filing fee rate is \$240 per petition. This equals \$400,000.
