WHAT THE MEASURE DOES: Abolishes Oregon Educator Professional Development Commission (OEPD). Transfers educator professional development responsibilities to Department of Education. Transfers all relevant records and property of OEPD chairperson to Superintendent of Public Instruction. Requires that Department of Education continue educator professional development program. Expands scope of that program. Declares an emergency; effective on passage.

ISSUES DISCUSSED:

- OEPD history, goal of having OEPD act as aggregator of best practices for educator professional development
- OEPD largely funded by private sources which "slipped away" over time; OEPD currently inactive
- Need for enhanced professional development programs for educators, both at the mentorship (1-2 years of experience) level and beyond
- Value of educator professional development, specifically lower teacher attrition over time leading to cost savings
- Department of Education as capable, enthusiastic, and logical organization for educator professional development program management
- Logic behind \$500,000 request; mention of potential supplanting issue, best resolved as part of existing subsequent referral

EFFECT OF COMMITTEE AMENDMENT: No amendment.

BACKGROUND: The OEPDC was formed as a result of Senate Bill 443 (2009), "for the purpose of providing statewide collaborative leadership for prekindergarten through post-secondary education in the areas of school improvement." The OEPDC was comprised of 16 members, 14 of whom were appointed by the Governor, with the Speaker of the House and the Senate President each appointing one member as well. Initial appointments to the OEPDC varied in length, with those terms ending on January 1 of 2011, 2012, or 2013. The OEPDC was explicitly required to create and maintain a website. There does not appear to have been much activity by the OEPDC recently. (The last update to the OEPDC website in the "What's New" section is dated April 25, 2011.) Senate Bill 271 transfers duties and responsibilities of OEPDC to the Oregon Department of Education.

Local Government Mandate:

This bill does not affect local governments' service levels or shared revenues sufficient to trigger Section 15, Article XI of the Oregon Constitution.

Analysis: SB 271 would abolish the Oregon Educator Professional Development Commission (OEPDC) and transfer the program to the Department of Education (ODE). In addition, ODE will maintain a website for posting professional development (PD) opportunities, assist school districts in developing PD plans, develop and share state standards for PD, coordinate and align the delivery of PD across the state, and provide recommend evaluative tools to determine the effectiveness of PD. OEPDC was established by the Legislature in 2009 and provided with \$130,000 for the first year's operation. Additional funding was not provided by the Legislature in subsequent years.

ODE cannot absorb the costs associated with the additional requirements of this bill. To meet the requirements of this bill ODE estimates that they will need an Education Program Specialist 2 (1.00 FTE) and an Office Specialist 2 (0.50 FTE) to develop and maintain the website and provide support for the various education partners. This bill has a subsequent referral to Joint Committee on Ways and Means.

SUMMARY

Abolishes Oregon Educator Professional Development Commission. Transfers educator professional development program to Department of Education. Expands scope of program. Declares emergency, effective on passage.

A BILL FOR AN ACT

Relating to educator professional development; creating new provisions; amending ORS 329.824; repealing ORS 329.822; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> (1) The Oregon Educator Professional Development Commission is abolished. 6 On the operative date of this section, the tenure of office of the members of the Oregon

7 Educator Professional Development Commission ceases.

8 (2) All the duties, functions and powers of the Oregon Educator Professional Develop-9 ment Commission are imposed upon, transferred to and invested in the Department of Edu-10 cation.

11 <u>SECTION 2.</u> (1) The chairperson of the Oregon Educator Professional Development 12 Commission shall deliver to the Superintendent of Public Instruction all records and property 13 within the jurisdiction of the chairperson that relate to the duties, functions and powers 14 transferred by section 1 of this 2013 Act.

(2) The superintendent shall take possession of the records and property transferred by
the provisions of this section.

SECTION 3. ORS 329.824 is amended to read:

18 329.824. (1) The Department of Education shall administer an educator professional de-19 velopment program that provides statewide collaborative leadership in educator professional 20 development for prekindergarten through post-secondary education and that emphasizes 21 school improvement. The department shall administer the program with a collaborative 22 group of state, school district, educator, administrator, community college and higher edu-23 cation representatives operating as a unit.

329.822] In administering the program described in subsection (1) of this section, the department shall:

SECTION 4. ORS 329.822 is repealed.

21 SECTION 5. (1) Sections 1 and 2 of this 2013 Act, the amendments to ORS 329.824 by section 3 of this 2013 Act and the repeal of ORS 329.822 by section 4 of this 2013 Act become 22 23 operative on January 1, 2014.

24 (2) The Superintendent of Public Instruction may take any action before the operative date specified in subsection (1) of this section that is necessary to enable the superintendent 2526to exercise, on and after the operative date specified in subsection (1) of this section, the 27duties, functions and powers of the superintendent under the provisions of section 1 of this 28 2013 Act.

29 SECTION 6. Subject to available moneys and requirements imposed by federal law, the 30 Department of Education shall biennially expend, for the purposes described in ORS 329.824, 31 at least \$500,000 of the moneys received from the United States Department of Education as 32grants to improve teacher and principal quality.

33 SECTION 7. This 2013 Act being necessary for the immediate preservation of the public 34 peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect 35 on its passage.
