

## Devil's Garden Ranger District – Modoc National Forest

- 2 permittee meetings (meetings were held during the fire not after per email District Ranger)
- 2 public meetings (meetings were held during the fire not after per email District Ranger)
- Cattle were moved from fire area to several vacant allotments on the Forest
- Surveyed 50 miles of fences for fire damage, found 25 miles of damaged fence line
- Under Master Participating Agreement #12-PA-11052009-019 with CAL Fire, the Modoc NF puts together contract for CAL Fire Conservation Crew to: "Remove all hazard trees near fence line that might take out the fence. Roll up unusable fence material and stockpile for Forest Service to remove. Reconstruct a new fence in the existing fence line." Crew costs = \$200/day – used appropriated dollars – contract created October 16 and finalized November 2, 2012
- BAER money for fence repair, materials and tree removal
- Suppression dollars were used to repair immediate area of fence impacted by cutting for dozer access
- Removed trees from fence on 17 miles of fence (as of end of February) – terrain and weather allowed fair access for most of winter
- Rebuilt 11 miles of fence so far, with 6.37 miles of fence line left to rebuild (as of end of February 2013)
- Worked with FWS Sheldon National Refuge to acquire excess fence materials – early after fire
- NRCS funding through the permittees will repair the "state-line" fence and the East Grizzlie/Beaver Dam division fence, which is 7.5 miles of fence
- Work in full progress as Fire crews, inmate crews and permittees are all working on fence removal, fence repairs, tree removals

## Lakeview Ranger District – Fremont-Winema National Forest Service

- Multiple community/stakeholder meetings during fire – 5 allotments on Fre-Win impacted
- September 4, 2012, Stakeholder meeting with funding/ advising agencies – NRCS, FSA, Extension Service
- Thursday, September 6, 2012, Fred Way, Barry Shullanberger and Noel Livingston tour Barry Point with County Commissioner, State Senator Doug Whitsett and impacted land owners.
- Fred visits Virgil and Sharon Harvey and Morris family lands to see impacts (between 6<sup>th</sup> and 12<sup>th</sup>)
- September 12, 2012, Fred contacts Collins about hazard trees along FS fence line where they are moving in and logging private
- September 15, 2012, Barry Shullanberger tours allotment with Ace Felder – recon'd 8 miles of fence line and identified top 3 miles to get hazard trees removed from immediately – was accomplished through above contract
- September 17, 2012, Contract awarded for Collins to remove hazard trees
- September 17, 2012, Public Tour of Barry Point hosted by Lakeview Stewardship Group
- September 18, 2012, Tour of fire on Collins' lands in California with Modoc NF, Fre-Win NF and Collins
- September 24, 2012, Regional Forester Kent Connaughton meets with Rep. Walden and landowners
- September 26, 2012, Fire crews began recon of over 75 miles FS fence lines – over 50 miles was identified as needing full replacement, fences run through heavy timber with high mortality – most trees need felled, fence needs removed and rebuilt through steep mountainous not easily accessed country
- October – additional miles of fences were recon'd throughout early October, hazard tree removal by fire crew in November
- November - December found Fre-Win range employees working with BLM and Modoc National Forest to identify alternate pastures for 2013
- As of end of February 10 miles had been cleared of hazard trees and worked continues using fire crews with, materials and supplies were ordered – these arrived in April and were distributed
- Appropriated dollars being used for contract for fence reconstruction on FS should be near awarding – weather conditions did not allow for work to resume after late fall until mid-May
- Suppression impacted fences – 10 miles of FS fence is being rebuild under suppression dollars due to suppression actions – hazard trees were cleared along these fence in November and December until weather stopped progress
- Agreement signed in fall to use Warner Creek Inmate Crews to remove damaged fence materials – work is commencing with weather
- Permittees using FSA and NRCS dollars through the Farm Bill for private boundary fence replacement
- As of May 25, 2013, work in full progress – grazing will not occur on five impacted allotments in 2013
