Subject: Health Care Programs, Oregon Health Authority Office of Private Health Partnerships

Dear Subcommittee Co-Chairs:

Thank you for the opportunity to provide information about the Office of Private Health Partnerships (OPHP) to your committee. The following are responses to the requests of committee members during the work session on June 4, 2013. Each question/request listed below is identified by a number and a corresponding response.

I. Representative Freeman: Can you please provide us with copies of the FMIP transition documents sent to enrollees?

Response: Copies of documents recently mailed to members are attached as Attachment A & B.

- 2. Representative Freeman: Asked about the increase in positions associated with OPHP displayed in the HB 5030 memo. The position count changed from 43 Pos/42.36 FTE in 2011-13 LAB to 61 Pos/59.75 FTE in 2013-15 CSL.
- Response: In 2011-13, the Healthy Kids Connect (HKC) program administration was blended with the Oregon Healthy Kids (OHK) program in the ORBITS budget structure 020-40-03 – "Oregon Healthy Kids." This resulted in complications since the OHK program is operated by the Medical Assistance Programs (MAP) division, and the HKC program is operated by the OPHP.

OPHP resolved this issue when constructing the 2013-15 Base budget build, where the programs were shifted from the blended structure to their own structures within their respective divisions (**020-01-06** – OHK in MAP, and **020-04-02** – HKC in OPHP). This resulted in a net-zero shift (within OHA) including all program positions, as detailed in the table below.

As noted in the table above, what appears to be an increase of positions between 2011-13 LAB and 2013-15 CSL is actually a shift of existing positions from non-OPHP budget structure to an OPHP budget structure.

There were a number of other structural shifts in both of the parent divisions – OPHP and MAP – between 2011-13 LAB and 2013-15 CSL. However, within OPHP, *there were no new positions/FTE added to OPHP between 2011-13 LAB and 2013-15 CSL*.

#### **ENROLLEE NOTICE OF TRANSITION**

Dear Enrollee,

We are writing to let you know that the Federal Medical Insurance Pool (FMIP) will end on June 30, 2013. You have the option to continue your health care coverage after June 30 through the federal Pre-Existing Condition Insurance Plan (PCIP).

# In June 2013, you will get more information about how you can continue your health coverage through the federal Pre-Existing Condition Insurance Plan.

## How to continue coverage - you do not have to reapply

In June, you will receive a letter from the National Finance Center. The National Finance Center runs the federal PCIP plan that is available to you. The June letter will have more information and the amount of your premium.

All you have to do to start coverage on July 1 through the PCIP is pay the first month's PCIP premium and have your FMIP premium paid through June 30<sup>th</sup>. The amount will be listed in the letter you will receive in June. To prevent a break in your coverage, you must pay the first month's premium by the deadline stated in the letter.

When you pay this first month's premium, you will automatically be a member of the Federal PCIP program. You will not have to complete a new application to qualify for the PCIP plan.

Since you pay your premiums one month in advance and your FMIP coverage ends on June 30, 2013, you will not receive a premium notice for FMIP in June. If your bank is set up to automatically withdraw your monthly premium, contact your bank to stop the withdraw. If you have already paid your July premium, you will receive reimbursement.

## Why is this happening

This is happening because of federal budget constraints. Oregon will no longer run the FMIP program. Instead, you can receive care through the federal Pre-Existing Condition Insurance Plan (PCIP).

## What to do for ongoing treatment

If you currently receive ongoing treatment, you will get information in the mail about transitioning your care.

It is important that you follow procedures around required pre-authorization of benefits. This includes scheduled treatment, or potential treatment, for the following items:

- Hospitalization
- Durable medical equipment or supplies
- Transplants
- Skilled nursing
- Long-term acute care or rehabilitation facility admission
- Spinal fusion surgery
- Cancer treatment plans anticipated to occur on or after July 1, 2013

In June, look for a letter in the mail from the National Finance Center. It is very important that you act quickly on the information given in this letter.

After you pay the premium mentioned in the letter, you will receive your enrollment packet from the PCIP. This includes your new PCIP ID card and information about your new benefit plan. You don't need to take any action right now.

## Please watch for the Federal PCIP letter in the mail, which will tell you exactly what you need to do to avoid losing your health coverage.

At FMIP, we have appreciated the opportunity to play a part in extending health care coverage to you and nearly 3,400 Oregonians. We also want to remind you that Cover Oregon, the state's health insurance exchange, opens for enrollment in October 2013. #### **ENROLLEE NOTICE OF TRANSITION**

Dear Enrollee,

We are writing to let you know that Oregon's Federal Medical Insurance Pool (FMIP) will end on June 30, 2013. You have the option to continue your health care coverage after June 30 through the federal Pre-Existing Condition Insurance Plan (PCIP). As a CAREAssist client, you can continue to have your premiums paid by CAREAssist.

## In June, you will get more information about how your health coverage will be moved to the federal Pre-Existing Condition Insurance Plan.

#### How to continue coverage - you do not have to reapply

In June, you will receive a letter from the National Finance Center. The National Finance Center runs the federal PCIP plan that is available to you. The June letter will have more information and the amount of your premium. CAREAssist will continue to pay your premium.

## Send CAREAssist a copy of the PCIP letter as soon as it arrives.

All you have to do to start coverage on July 1 through the PCIP is make sure CAREAssist pays your first month's premium. The amount CAREAssist must pay will be listed in the letter you will receive in June. To prevent a break in your coverage, you must provide CAREAssist a copy of your letter listing the first month's premium. CAREAssist must pay the premium by the deadline stated in the letter.

Once CAREAssist pays the first month's premium, you will automatically be a member of the Federal PCIP program. You will not have to complete a new application to qualify for the PCIP plan. Your PCIP coverage will begin on July 1, 2013.

#### Why this is happening

FMIP is a federal program. This is happening because of federal budget constraints. Oregon will no longer run the FMIP program. Instead, you can receive care through the federal Pre-Existing Condition Plan.

## What to do for ongoing treatment

If you are receiving ongoing treatment, you will get information in the mail about how to continue your care under PCIP.

PCIP has to give approval before you get certain kinds of treatments. PCIP will tell you how to get this approval, and it is important that you carefully follow those instructions. This includes scheduled treatment, or potential treatment, for the following items:

- Hospitalization
- Durable medical equipment or supplies
- Transplants
- Skilled nursing
- Long-term acute care or rehabilitation facility admission
- Spinal fusion surgery
- Cancer treatment plans anticipated to occur on or after July 1, 2013
