House Bill 2254 Relating to the urban growth boundary

HB 2254 directs Department of Land Conservation & Development (DLCD) to simplify methods for growing cities, outside of Metro, to evaluate the need for additional land and development capacity, based on population forecast and development of similar cities in the same area of the state. There are two new approaches, one designed for small cities and the other for larger cities. The methods allow cities to estimate how much future growth can be accommodated within existing boundaries based on the experience in similar cities. These planning methods also clarify how cities decide where to grow after demonstrating a need for additional land. These new tools are optional cities may continue to use the current system, should they so choose. The measure declares and emergency and becomes effective July 1, 2014.

The Subcommittee amended the bill to add an appropriation of \$250,000 General Funds to carry out requirements of the measure.

The Natural Resources Subcommittee recommends HB 2254 be amended and reported out do pass, as amended.

Summary of Revenue Changes

House Bill 2254 appropriates \$250,000 General Fund to the Department of Land Conservation and Development (DLCD) for carrying out the act in the 2013-15 biennium.

Summary of Natural Resources Subcommittee Action

House Bill 2254 directs DLCD to simplify methods for rural cites to evaluate or amend their urban growth boundary. The measure declares an emergency and becomes effective July 1, 2014. The legislation will result in rulemaking for DLCD and possibly amend statewide planning goals. Expenses associated with this process include statewide public hearings, consultation with professional services, data collection using geographic information systems, and Attorney General fees. Total expense is estimated at \$250,000 General Fund in the 2013-15 biennium. The bill appropriates \$250,000 General Fund to DLCD to carry out the act.
