Subject:	HB 2074 Relating to the regulation of health-related occupations Work Session Recommendation

HB 2074 changes the name of the Oregon Health Licensing Agency (OHLA) to the Health Licensing Office, changes the name of the Oregon Health Licensing Agency Account to Health Licensing Office Account, and moves the agency within the Oregon Health Authority (OHA). The responsibility of appointing the director of this health licensing entity transfers from the Department of Administrative Services to OHA. Certain sections of the bill become operative on January 1, 2014. The bill contains an emergency clause and takes effect on passage.

The measure previously had hearings in the House Committee on Health Care on 2/8/2013, and 2/12/2013. A public hearing was held for the bill in this Subcommittee on 4/10/2013.

Fiscal impact

Passage of this bill is anticipated to have minimal fiscal impact on OHA and OHLA. Both agencies will use existing staff and resources to carry out the provisions of the bill, including the costs associated with the name change on forms, letterhead, signs, brochures, and websites which is estimated to be approximately \$9,200.

<u>The – 1- amendment</u>

The –1 amendment is a conflict amendment in the event that HB 2101 becomes law. The amendment also removes the emergency clause, and changes the operative date of the bill from January 1 to July 1, 2014.

Changes name of Oregon Health Licensing Agency to Health Licensing Office and name of Oregon Health Licensing Agency Account to Health Licensing Office Account.

The responsibility of appointing the director of this health licensing entity transfers from the Department of Administrative Services to OHA. Certain sections of the bill become operative on January 1, 2014. The bill contains an emergency clause and takes effect on passage.

The – 1 amendment is a conflict amendment in the event that HB 2101 becomes law. The amendment also removes the emergency clause, and changes the operative date of the bill from January 1 to July 1, 2014. The – 1 amendment does not change the fiscal determination.

Both agencies will use existing staff and resources to carry out the provisions of the bill, including the costs associated with the name change on forms, letterhead, signs, brochures, and websites which is estimated to be approximately \$9,200.

<u>Department of Administrative Services (DAS), Legislative Fiscal Office (LFO)</u> Passage of this bill is anticipated to have minimal fiscal impact on DAS and LFO. Transfer of OHLA to OHA will only redistribute, not reduce, workload for DAS and LFO.
