HB 2636 -- Work Session Recommendations

Background Information

HB 2636-A establishes the STEM Investment Council to assist the OEIB, the Chief Education Officer (CEdO), and others in developing and overseeing a long-term starategy to advance state goals related to science, technology, engineering and math. The goals involve increasing the number of students who are either proficient in science and math or who earn post-secondary degrees in relevant areas. The CEdO is to appoint the Council, at least until march 2014 when the authority for the CEdO and the OEIB sunset. After that Council will assist the Community College Commissioner, Superintendent of Education, and the Chancellor.

The bill also establishes the STEM Investment Grant Program for funding STEM related programs in school districts, community colleges, and public universities. The Council assists in administering the grant program. Funding would flow through the Department of Education (with the passage of the amendment).

Recommended Changes HB 2636-A

LFO recommends one amendment (A6) of which it knows about. This amendment makes some minor changes to the responsibilities of the Council, makes the Council voluntary as well as members of the Council would not be eligible to receive compensation or reimbursement for expenses. It also removes the section which appropriates funding for the grant program. With the amendment the grant program would exist in Statute but will not have fudning for 2013-15 from the General Fund.

WHAT THE MEASURE DOES: Creates STEM Investment Council charged with advancement of educational initiatives in fields of science, technology, engineering and mathematics (STEM). Establishes STEM Investment Grant Program to fund programs and STEM Investment Account with moneys for account appropriated from General Fund and to Council for awarding grants. Emphasizes funding for STEM programs that are elements of partnerships or regional strategies to improve STEM achievement. Requires STEM Council to report progress annually to Legislative Assembly. Declares emergency, effective July 1, 2013.

ISSUES DISCUSSED:

- Scope of STEM programs
- Location of STEM hubs
- Current organizations addressing STEM issues

EFFECT OF COMMITTEE AMENDMENT: Emphasizes funding for STEM programs that are elements of partnerships or regional strategies to improve STEM achievement. Requires STEM Council to report progress annually to Legislative Assembly.

BACKGROUND: House Bill 4056 (2012) established the Joint Interim Task Force on STEM Access and Success to encourage students to study STEM subjects. Among the legislative recommendations are the following:

"The Task Force recommends the establishment of an entity within the office of the Chief Education Officer responsible for developing, coordinating and advancing STEM learning and industry engagement in Oregon. In this report, we refer to the entity as the STEM Council, which is envisioned as a partnership between the public and private sectors with responsibility for:

- Adopting and advancing an ambitious agenda for STEM education, including clearly articulated goals for K-12 and post-secondary education systems;
- Developing and managing the infrastructure for STEM Hubs;
- Administering moneys appropriated from the general fund for STEM development; and
- Ensuring appropriate resource distribution and accountability for STEM Hubs and other programs funded to advance STEM education through a competitive grant process."

House Bill 2636-A implements these recommendations.
