Testimony of Jil Heimensen in support of HB 3467 April 11, 2013

1 The purpose of my testimony is to strongly support HB 3467. Mug shots posted indefinitely on the internet

2 amount to a modern day Scarlet Letter - a never ending perp walk only ending when ransoms are paid, which

can easily run well over \$700 to remove even one mug shot from the internet: mugshots.com charges \$399,
 Busted charges \$99, Justmugshots charges 138.97, and Pdxmugshots is currently running a \$99 special! 1,2,3,45

6 The public and media outlets will still have access to mug shots with HB 3467. Before the internet, mug shots
7 were only available by going to the local police station and thumbing through physical photos of arrested
8 individuals or making individual requests for a particular person as contemplated by HB 3467. In contrast, the
9 internet allows mug shots to be widely publicized, resulting in the justification for spending tax dollars for
10 rehabilitating offenders being essentially nullified. Widely publishing mug shots is not in the best interest of
11 the public when the rehabilitated lack opportunities to move on with their life because they are branded with
a Scarlett Letter.⁶

Mugshots.com makes several misinformed claims intended to support their dubious business model.⁷ First, they claim that if they are not allowed to post mug shots (and charge for their removal) that the public will be less safe since people will not have the ability to identify the riff raff living in their neighborhoods. In reality, the vast majority of people only look at websites like mugshots.com to derive pleasure at the misfortune of others. Mugshots.com also suggests that posting mug shots online helps law enforcement keep people safe. Truth is, the police have many effective tools at their disposal (including their very own mug shot database) so it is highly unlikely that law enforcement would ever need to engage in research at mugshots.com to solve

21 a crime.

Ironically, mugshots.com cited the fact that the U.S. Marshals Service has on occasion published mug shots for apprehending dangerous criminals. What they failed to mention was that the agency's policy is to not

release mug shots. In fact, the US Marshalls Service states that mug shots are exempt from FOIA under

26 Exemption 7(c)'s protections against the invasion of personal privacy.8 To be clear, publishing mug shots to

27 apprehend dangerous criminals who are on the loose and doing very bad things is in the interest of public

28 safety. Posting all mug shots on the internet and leaving them there indefinitely⁹, especially for those who

29 have completed all of their court ordered requirements and pose no further risk to society, is a huge injustice

- 30 which destroys lives and families for years to come.

32 Mugshots.com expressed concern for maintaining public access by suggesting that the interests of society are

33 best served when the greatest number of people have the opportunity to view mug shots. It would also

34 appear that the interests of society would be served if updates are made once new information becomes

35 available. At the very least, mug shots should be removed from the internet for free upon completion of court

- 36 ordered requirements. This would incentivize offenders to complete mandated requirements which would
- 37 certainly be in the best interests of society.
