CALIFORNIA

System 1:

 - If debtor is not a person described in (a)(2) or (a)(3)
- \$100,000 (California Code Civ. Proc. § 704.730(a)(2))
 - "One hundred thousand dollars (\$100,000) if the judgment debtor or spouse of the judgment debtor who resides in the homestead is at the time of the attempted sale of the homestead *a member of a family unit*, and there is at least one member of the family unit who owns no interest in the homestead or whose only interest in the homestead is a community property interest with the judgment debtor."
- \$175,000 (California Code Civ. Proc. § 704.730(a)(3))
 - "One hundred seventy-five thousand dollars (\$175,000) if the judgment debtor or spouse of the judgment debtor who resides in the homestead is at the time of the attempted sale of the homestead any one of the following:
 - (A) A person 65 years of age or older.
 - (B) A person physically or mentally disabled who as a result of that disability is *unable to engage in substantial gainful employment*.
 - (C) A person 55 years of age or older with a *gross annual income of not more than twenty-five thousand dollars (\$25,000)* or, if the judgment debtor is married, a gross annual income, including the gross annual income of the judgment debtor's spouse, of not more than thirty-five thousand dollars (\$35,000) and the sale is an involuntary sale."
