Prohibits use of public funds to pay home care worker who has specified criminal history.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to prohibition on use of public funds to pay home care worker with

3 specified criminal history; amending ORS 443.004; and declaring an emer-

4 gency.

5 Be It Enacted by the People of the State of Oregon:

6 **SECTION 1.** ORS 443.004, as amended by section 17, chapter 70, Oregon 7 Laws 2012, is amended to read:

443.004. (1) The Department of Human Services or the Oregon Health
Authority shall complete a criminal records check under ORS 181.534 on:

10 (a) An employee of a residential facility or an adult foster home;

(b) Any individual who is paid directly or indirectly with public funds who has or will have contact with a recipient of support services or a resident of an adult foster home or a residential facility; and

(c) A home care worker registering with the Home Care Commission or
 renewing a registration with the Home Care Commission.

(2)(a) A home health agency shall conduct a criminal background check
before hiring or contracting with an individual and before allowing an individual to volunteer to provide services on behalf of the home health agency,
if the individual will have direct contact with a patient of the home health
agency.

(b) An in-home care agency shall conduct a criminal background check
before hiring or contracting with an individual and before allowing an individual to volunteer to provide services on behalf of the in-home care agency,
if the individual will have direct contact with a client of the in-home care
agency.

6 (c) The authority shall prescribe by rule the process for conducting a 7 criminal background check.

8 (3) Public funds may not be used to support, in whole or in part, the 9 employment in any capacity having contact with a recipient of **home care** 10 **services or** support services or a resident of a residential facility or an adult 11 foster home, of an individual, other than a mental health or substance abuse 12 treatment provider, who has been convicted:

(a) Of a crime described in ORS 163.095, 163.115, 163.118, 163.125, 163.145,
163.149, 163.165, 163.175, 163.185, 163.187, 163.200, 163.205, 163.225, 163.235,
163.263, 163.264, 163.266, 163.275, 163.465, 163.467, 163.535, 163.537, 163.547,
163.689, 163.700, 164.055, 164.057, 164.098, 164.125 (5)(c) or (d), 164.215, 164.225,
164.325, 164.377 (2) or (3), 164.405, 164.415, 165.013, 165.022, 165.032, 165.800,
165.803, 167.012, 167.017, 167.057, 167.320 or 167.322;

(b) Notwithstanding paragraph (a) of this subsection, of a crime described in ORS 163.465, 163.467, 163.700, 164.055, 164.125 or 164.377, the date of conviction for which was within the five years immediately preceding employment in any capacity of an individual, other than a mental health or substance abuse treatment provider, having contact with a recipient of support services, a resident of a residential facility or a resident of an adult foster home, when the recipient or resident is 65 years of age or older;

(c) Of a crime listed in ORS 181.594;

(d) In the last 10 years, of a crime involving the delivery or manufactureof a controlled substance;

(e) Of an attempt, conspiracy or solicitation to commit a crime described
in paragraphs (a) to (d) of this subsection; or

31 (f) Of a crime in another jurisdiction that is substantially equivalent, as

1 defined by rule, to a crime described in paragraphs (a) to (e) of this sub-2 section.

3 (4) If the criminal background check conducted by a home health agency 4 or in-home care agency under subsection (2) of this section reveals that the 5 individual who is subject to the criminal background check has been con-6 victed of any of the crimes described in subsection (3) of this section, the 7 home health agency or in-home care agency may not employ the individual.

8 (5) Public funds may not be used to support, in whole or in part, the 9 employment, in any capacity having contact with a recipient of **home care** 10 **services or** support services or a resident of a residential facility or an adult 11 foster home, of a mental health or substance abuse treatment provider who 12 has been convicted of committing, or convicted of an attempt, conspiracy or 13 solicitation to commit, a crime described in ORS 163.095, 163.115, 163.375, 163.405, 163.411 or 163.427.

(6) Upon the request of a mental health or substance abuse treatment provider, the department or authority shall maintain a record of the results of any fitness determination made under ORS 181.534 (11) and (12). The department or authority may disclose the record only to a person the provider specifically authorizes, by a written release, to receive the information.

20 (7) If the department or authority has a record of substantiated abuse 21 committed by an employee or potential employee of a home health agency, 22 in-home care agency, adult foster home or residential facility, regardless of 23 whether criminal charges were filed, the department or authority shall no-24 tify, in writing, the employer and the employee or potential employee.

25 (8) As used in this section:

(a) "Adult foster home" has the meaning given that term in ORS 443.705.
(b) "Home care services" has the meaning given that term in ORS 410.600.

[(b)] (c) "Home care worker" has the meaning given that term in ORS
410.600.

[(c)] (d) "Home health agency" has the meaning given that term in ORS

2 [(d)] (e) "In-home care agency" has the meaning given that term in ORS
3 443.305.

4 [(e)] (f) "Mental health or substance abuse treatment provider" means:

5 (A) A peer support specialist;

6 (B) An employee of a residential treatment facility or a residential treat-7 ment home that is licensed under ORS 443.415 to provide treatment for in-8 dividuals with alcohol or drug dependence;

9 (C) An individual who provides treatment or services for persons with 10 substance use disorders; or

11 (D) An individual who provides mental health treatment or services.

12 [(f)] (g) "Peer support specialist" means a person who:

13 (A) Is providing peer support services as defined by the authority by rule;

14 (B) Is under the supervision of a qualified clinical supervisor;

15 (C) Has completed training required by the authority; and

16 (D) Is currently receiving or has formerly received mental health services,

17 or is in recovery from a substance use disorder and meets the abstinence 18 requirements for staff providing services in alcohol or other drug treatment 19 programs.

[(g)] (h) "Residential facility" has the meaning given that term in ORS 443.400.

22 <u>SECTION 2.</u> This 2013 Act being necessary for the immediate pres-23 ervation of the public peace, health and safety, an emergency is de-24 clared to exist, and this 2013 Act takes effect on its passage.
