## PLEASE SAY "NO" TO SENATE BILL 132

The current one size fits all vaccination program is actually harming our kids. It is the medical establishment that needs to be educated on this issue NOT parents who have educated themselves and have chosen to DELAY or NOT VACCINATE their children with some or all vaccines. Each child is unique and should be treated as such. Parents should read various books and articles, both pro and con, before making such choices. This bill is wrong headed in its approach. The bottom line is that safety studies regarding vaccines have not been performed using proper scientific standards; those that have been done compare vaccinated populations only to other vaccinated populations, and only follow kids for 4-6 weeks. If the Senate is going to pass any bill perhaps it should be reversed and anyone who gives a child a vaccine should have to go through an educational course that is NOT CONTROLLED BY THE PHARMACEUTICAL COMPANIES. Under the National Childhood Vaccine Injury Act of 1986, over \$2 billion has been awarded to children and adults for whom the risks of vaccine injury was 100%. Vaccines are pharmaceutical products that carry risks, which can be greater for some than others. Parents should not be harassed if they choose to delay or not vaccinate their children with some or all vaccines.

When my brother was diagnosed with autism in the early 70's it was one out of every 10,000 kids. Now it is one out of 88 kids that are being diagnosed with autism. Autism is a "life sentence" to the child and to the family and anyone who thinks there is not a link to the vaccines has their head stuck in the sand. Given the research and the circumstances with my own brother there is no question in my mind about this. Unless the legislature is going to personally guarantee, in writing, that there will be no adverse reactions so parents can sue them if there are, they should not be making it harder on parents who choose to delay or not vaccinate their children.

In 1975, Japan eliminated all vaccines for children under two and when that happened; their infant mortality rate plummeted so that it was the lowest in the world. In 1995, Japan started allowing infant vaccines, though on a very limited scale. Japan, with their very non-aggressive early vaccination schedule fell behind from the lowest mortality rate in the world to a still impressive 3<sup>rd</sup> place. In American, by the time our children are one year old the CDC recommends 26 vaccine doses be administered to them. Some for diseases that are for the most part sexually transmitted. Babies in the United States have an infant mortality rate that ranks 34th in the World.

I am aware that there are many contributing factors that go into Infant Mortality Rates such as: Economic Factors, Environmental Factors, Diet and Nutrition but there is no denying that as the recommended vaccine doses have increased so has the cases of autism and other disorders in our children, some not showing up until years later. When you understand how these drugs are made and how they work it becomes more clear as to why this may be.
