Dear Honorable Members of the Ways & Means Human Services Sub Committee,

My name is Stuart Roberts. I currently serve as Chief of Police for the City of Pendleton. I have been employed as a law enforcement officer in Umatilla County for over twenty years, the last ten plus as Chief of Police. Although there are many challenges associated with administering emergency services in this economic climate, I cannot think of any greater deficiency in state or local services than those available to an ever-growing population of Oregonians in need of assistance to deal with addiction and/or mental illness issues.

It is not uncommon for law enforcement officers to deal with persons (veteran and non-veteran) suffering from drug/alcohol induced psychosis or more acute clinical mental illness on a daily basis as "gatekeepers' of the criminal justice system. The aforementioned statement is validated by the fact that the Pendleton Police Department struggled to deal with an alarming 39% increase in calls for service related to the mentally ill in 2012. Because, many of the persons in crisis whom law enforcement personnel encounter on a regular basis are self-medicating to cope with their respective conditions, all too often the significance of said contact(s) is a criminal charge and lodging in jail, which exacerbates the identified problem. The consequence is that criminal justice system, which is not designed or staffed to deal with the mentally ill, becomes over burdened with individual(s) who often times do not have the mental capacity to understand what they have done wrong, and/or do not have access to services that promote sobriety or selfsufficiency. Therefore, precious tax dollars and court time are wasted on evaluating competencies and/or trying to manage non-compliance with court ordered sanctions. The analogy I often use is; introducing mentally ill persons to the criminal justice system is like putting them on a merry-go-round and spinning it faster with every new criminal charge or judicial process. Pretty soon, the person becomes disoriented, as time passes things become a blur and pretty soon, there is no way to get them off without causing significant/irreversible damage.



The bottom line is that the criminal justice system can no longer be the primary mental health provider in Oregon by default. We, as elected or appointed leaders must identify viable programs or methods of ensuring that all populations of Oregonians have access to appropriate services. Meaning, that we must invest in innovation, because what we are doing today is not working. I strongly believe that mental health, criminal justice and social service providers serving Umatilla County have come up with an innovative concept aimed at preserving jobs, filling a void in mental health services and collaborating to save the taxpayers in Oregon hundreds of thousands of dollars annually in response to the pending closure of the Blue Mountain Recovery Center located in Pendleton scheduled for January 1, 2014.

Briefly, Greater Oregon Behavioral Health, Inc. (GOBHI) and a consortium of practitioners have been working very hard with the Oregon Health Authority to determine the optimum use of current staff and state owned facilities, which are currently vacant to create a Recovery Campus. The purpose of the recovery campus is to serve the population of citizens who do not qualify for mental health services and/or should not be introduced to the criminal justice system, but are in need of assistance. GOBHI and its Coordinated Care Organizations (CCO) are willing to take on the task of operating the proposed facility as a part of its overall system of care. The anticipated outcome is that the cost(s) associated with the treatment will be lower than less effective alternatives. Since treatment is a fundamental component of this proposal, the sustainability of lower costs is improved by providing clients with the skills and resources necessary for self-sufficiency.

Consequently, I offer this letter in support Blue Mountain Recovery Center's (BMRC) request for consideration of one biennium of funding equaling \$24 million. I would also encourage you to consider funding an additional one-time expenditure of \$4 million for the renovation of existing facilities to development the "Recovery Focused Campus" as part of the Coordinated Care Organization program.


