Chair Tomai, members of the Committee, thank you for the opportunity to testify. For the record, my name is Eduardo Angulo, chairman and executive director of the Salem/Keizer Coalition for Equality. Our member organizations are PCUN, Oregon Farmworkers Union, CAUSA, the largest pro-immigrants' right coalition in the Northwest, Mano a Mano Family Center, Latinos Unidos Siempre (LUS), Willamette University Latino Students and our Oregon Parent Organizing Project.

Our Coalition's organizations leaders and members and allies are all in full support of the HB 2980/2474 because ALL children deserve an opportunity to succeed in school and life, which is tied to having a stable home.

Through the passage of the Oregon Senate Bill 253, the 2011 Legislature affirmed a clear and ambitious educational goal for the state: It's known as the Governor's 40-40-20 aspirational vision. It states that by 2025 all adult Oregonians will hold a high school diploma, 40% will have an associate's degree or its equivalent, and 40% will have earned a bachelors or an advance degree.

The passage of the SB-253 last year has created a new drive for action and change with a lot of hope in the migrant, immigrant and communities of color throughout the state of Oregon.

The fact that many of the thousands of children who are residents of the farmworker housing developments around Oregon are English Language Learners or ELL students, and the Governor and the state education leaders are committed to address their education needs and bring them into the tent of education reform and equity, brings a renewed hope in our communities that all our children will have a chance to reach their full potential.

For the past year I have been part of a large group of leaders of community organizations of color part of the Oregon Alliance for Education Equity (OAEE) who have been working at being part of the solution to the growing achievement gap between students of color and English Language Learners and their white classmates.

I am herë today to express the united support of our communities for passage of HB 2980/2474 that will extend the tax credit for farmworkers housing around Oregon.

Prior to the 2001 creation of the tax credit there was not much decent housing for the farmworker families and children around Oregon, now we have more than 1,200 housing units built since 2001, thanks to the credit.

Currently we have 60,000 children who are ELLs throughout our state schools.

We need more decent and secure housing for the thousands of famworking families and children who are waiting for them to be built so we can guarantee that more children live in a decent house will come to school every day ready to learn.

We cannot expect to reach our 40-40-20 North Start aspirational goal by 2025 for all our children if they don't have their most primary need covered: decent and secure housing. Please support HB 2980/2474 and extension of the Farmworker Housing Tax Credit.

Please support safe, decent, and affordable housing for our children.
