This letter is being written to express our concern about the status of the Alsea Watershed Council (AWC) and to support its efforts to obtain council support funding through the Oregon Watershed Enhancement Board (OWEB). As a board, we believe in the concept of local self-determination and governance that was fundamental to the original legislation (which Commissioner Thompson helped pass as a State Representative) establishing the watershed council system.

The unwillingness of OWEB staff to provide council support funds to the AWC places our board in a difficult situation. We believed that by adopting a resolution recognizing the AWC, then modifying that resolution to recognize it as "the" watershed council for the Alsea basin, we were providing recognition of the AWC as the primary council for that basin. Now we learn that without specifically redrawing the MidCoast Watersheds Council's (MCWC) boundaries to exclude them from the Alsea basin, the AWC will be denied access to these important capacity-building funds. We understand OWEB at one point discussed mediation services between AWC and MCWC to resolve this funding issue, but nothing has gone forward. We would recommend OWEB offer a mediation effort as soon as possible and before any final decisions are made.

As a board, we have been impressed by the efforts of the AWC to build working relationships with landowners in the Alsea basin and other key partners. At the same time, we acknowledge that the MCWC has a strong track record of bringing major projects to fruition in the Alsea basin. Our reluctance to modify the MCWC recognition resolution reflects a desire not to negatively impact its operational capacity.

We have been told that several other watershed councils in the state are attempting to establish their independence from their umbrella councils. The concept of regionalization may be worthwhile in theory, but is apparently flawed in practice. We understand the fewer councils your department has to deal with reduces your workload, but obviously bigger is not always better. We would strongly urge OWEB to consider another model, perhaps something along the lines of a consortium, where local councils could pool financial resources and technical expertise but still have the autonomy to chart their own destiny.

We have been in communication the Benton and Lane County Boards of Commissioners on this issue and understand it is important we have consensus. The short timeline has not given us an opportunity to have a good public process allowing both councils to make their case and the general public to comment. If required to make a decision by your September 16, 2008 meeting, we will. We think it would be in the public's interest to allow us some additional time to make this important decision.

Although we believe the original enabling legislation for councils did not envision an ongoing oversight role for the recognizing local government, we feel strongly about this issue, will continue to monitor the situation, and may take further action at some point in the future.

Update on Alsea WSC council support funding

Good Day Commissioners,

OWEB has decreed the Alsea WSC will NOT receive a council support grant.

We went through OWEB directed mediation with a professional facilitator.

We finalized an MOU with MidCoast Watersheds Council.

We submitted a joint council support grant with MCWC, Salmon/Drift WSC and the AWC. We acted in good faith and spent many, many hours on this process.

In May OWEB met with us and said this joint grant will not work.

Their solution was to offer the AWC a one-time only, limited warranty, non-support grant for \$17,000/biennium from Salmon Recovery Funds. The OWEB Board approved this at the June meeting. There are strings attached.

The AWC is required to attend MCWC general meetings and give a report.

The AWC is required to attend all the MCWC tech team meetings; we might learn something. The AWC is required to meet with the MCWC quarterly to discuss planning. And so on. Oh, the AWC, if good, will receive a bit of funds for meeting planning and project planning. And did I mention the MCWC will receive full council support funding?

The contract features the MOU, which repeatedly references the joint support grant. When we questioned the validity of this, there was no real response.

We had a conversation with a legal professional about this "non-existent document" and decided the issue had to be addressed. So we added an addendum to the MOU stating all references to the joint council support grant are null and void.

The contract still has not arrived for signature, although we have been told twice "it is in the mail." We wait.

Now you know the saga of the AWC quest for council support funding. At least we know where we stand. From our position, it is not particularly encouraging, but we will persevere. We may seek your advice in future, after we regroup and tend to the wounded. Thanks for all your support.

The Siuslaw National Forest strongly supports the Alsea Watershed Collaborative Partnership Proposal. We have been collaborating with local watershed councils, state, and federal agencies to restore Oregon Coast coho salmon, a federally threatened species, for over a decade. Currently, National Forest System lands contain some of the best remaining coho salmon habitat on the Oregon Coast. Historically, most coho salmon production came from private land. Watershed councils are the primary organizations initiating and implementing watershed restoration activities on private land in Oregon. Watershed restoration activities on private land increase production of coho salmon on the Siuslaw National Forest. Coho salmon's extensive migratory behavior from freshwater spawning and rearing areas to the ocean, and then returning to freshwater streams to spawn, requires high quality habitat conditions throughout the stream network. The Alsea Watershed Council is working collaboratively with the Siuslaw National Forest to create high quality fish habitat conditions throughout the Alsea Watershed.

The Siuslaw National Forest and the Alsea Watershed Council have collaborated on several watershed restoration projects over the last few years. Projects have included landowner outreach to initiate and develop restoration on private land, technical assistance in designing stream restoration on private land, and employment of local contractors to add large wood to over 15 miles of coho habitat in the Alsea Watershed, primarily on Siuslaw National Forest lands. These projects benefit coho habitat and are part of a longer term process that develops mutual understanding and trust among diverse individuals and interest groups. We believe that mutual understanding and trust are needed to restore aquatic habitats in the Alsea Watershed considering the diverse land ownership patterns. The monthly Alsea Watershed Council meetings are an important forum for local landowners and restoration practitioners to share information about restoration issues, needs, opportunities, and funding sources.

We are impressed with the watershed restoration and education activities produced by the Council. The Alsea Watershed Council will continue to be an important partner with the Siuslaw National Forest as we continue to work collaboratively to facilitate watershed restoration throughout the Alsea Watershed.
