RE: House Bill 2870

Honorable Barnhart:

The Board of County Commissioners for Josephine County respectfully requests our comments be made a part of the Official Record regarding the above House Bill. We are writing in support of House Bill 2870 and request you move it forward, as it will remove an unfair restriction on counties' ability to use a method of raising revenue. Many rural counties, including ours, are experiencing financial difficulties as a result of lost revenue from the O&C Revenue Sharing (Federal payments) in lieu of taxes. This loss is having a severe impact on our ability to deliver basic services, and we need every means possible to replace that lost revenue.

By removing the prohibition against the imposition of taxes by a county on cigarettes and tobacco products, House Bill 2870 would give counties the option of considering a tax proposal that could benefit them in two ways: (1) by raising needed revenue for their General Funds; and (2) by dedicating at least 20% of that revenue to their Public Health Departments.

In Josephine County, our Public Health Department is experiencing serious financial problems. Under this Bill, if the County decides to implement such a tax, much needed assistance would be provided to that department, resulting in our ability to maintain adequate public health services for the citizens of Josephine County.
