Measure Description: Allows the Attorney General to issue an order disqualifying a charitable organization from receiving contributions that otherwise would be deductible under the Oregon income or corporate excise taxes. Such an order would be contingent upon the finding that the organization failed to spend at least 30 percent of its total annual functional expenses on program services when averaged over the most recent three fiscal years for which the Attorney General has relevant information. Requires organizations to disclose that such an order has been issued when making solicitations in Oregon. Requires the Attorney General to publish the identity of such organizations on the Internet and elsewhere, and file an annual report with the Department of Revenue. Requires individual and corporate taxpayers to include in taxable income the amount of contributions made to such organizations if made 30 days after the public notification.

Revenue Impact: Revenue gain of less than \$50,000 per biennium.

Impact Explanation: The revenue impact is based on the assumption that taxpayers are unlikely to change their behavior in such a way that their total amount of charitable contributions is significantly altered. Most taxpayers who would have made a contribution to an organization affected by this policy would likely make a similar contribution to a different charitable organization. The small revenue gain is based on the assumption that a few taxpayers would not simply redirect their contribution.
