SENATE AMENDMENTS TO RESOLVE CONFLICTS TO B-ENGROSSED HOUSE BILL 2101

2	"SECTION 30a. If House Bill 2102 becomes law, section 30 of this 2013 Act (amending ORS
3	688.720) is repealed and ORS 688.720, as amended by section 19, chapter 43, Oregon Laws 2012,
4	and section 2, chapter 62, Oregon Laws 2013 (Enrolled House Bill 2102), is amended to read:
5	"688.720. (1) The Oregon Health Licensing Agency shall issue a registration as an athletic
6	trainer under ORS 688.701 to 688.734 to an applicant who has:
7	"(a) Provided to the [Board of Athletic Trainers] agency adequate proof of:
8	"(A) Receipt of a bachelor's degree from an accredited four-year college or university and hav-
9	ing met the minimum athletic training curriculum requirements established by the Board of Athletic $% \left({{{\left[{{{\left[{{{\left[{{{c}} \right]}} \right]}} \right]}_{\rm{cl}}}}_{\rm{cl}}}} \right)$
10	Trainers by rule; or
11	"(B) Military experience or training that the board determines is substantially equivalent to the
12	education required by subparagraph (A) of this paragraph;
13	"(b) Successfully completed the certification examination administered by the national Board of
14	Certification, or an equivalent examination approved by the Board of Athletic Trainers;
15	"(c) Completed any other requirements for registration as determined by the Board of Athletic
16	Trainers by rule;
17	"(d) Submitted to the [board] agency adequate documentation that the applicant is at least 18
18	years of age; and
19	"(e) Paid [all fees required] the applicable fees for registration established under section 4
20	of this 2013 Act.
21	"(2) The agency shall issue a registration under this section to an applicant who has not suc-
22	cessfully completed an examination under subsection (1) of this section if the applicant:
23	"(a) Furnishes documentation that demonstrates that the applicant meets the education, experi-
24	ence or training requirements described in subsection (1)(a) of this section; and
25	"(b) Is registered as an athletic trainer in another state or by a national association and the
26	board determines that the registration requirements of the other state or the association are sub-
27	stantially equivalent to the registration requirements described in subsection $(1)(c)$ of this
28	section.".
29	On <u>page 35</u> , after line 22, insert:
30	"SECTION 65a. Notwithstanding section 8, chapter 82, Oregon Laws 2013 (Enrolled Senate
31	Bill 107) (amending ORS 694.185), if Senate Bill 107 becomes law, ORS 694.185 is repealed by
32	section 65 of this 2013 Act.".
