## HOUSE AMENDMENTS TO HOUSE BILL 2254

1	On page 1 of the printed bill, line 2, after the semicolon insert "creating new provisions;
<b>2</b>	amending ORS 197.015 and 197.298;".
3	Delete lines 4 through 30 and delete page 2 and insert:
4	"SECTION 1. As used in sections 1 to 8 of this 2013 Act:
5	"(1) 'Buildable lands' means land in urban or urbanizable areas that are suitable for ur-
6	ban uses.
7	"(2) 'Serviceable' means, with respect to land, that:
8	"(a) Adequate sewer, water and transportation capacity for planned urban development
9	is available or can be either provided or made subject to committed financing; or
10	"(b) Committed financing can be in place to provide adequate sewer, water and trans-
11	portation capacity for planned urban development.
12	"SECTION 2. The purpose of sections 1 to 8 of this 2013 Act is to direct the Land Con-
13	servation and Development Commission to develop and adopt simplified methods for a city
14	that is outside Metro to evaluate or amend the urban growth boundary of the city. The
15	commission should design the methods to:
16	"(1) Become, as a result of reduced costs, complexity and time, the methods that are
17	used by most cities with growing populations to manage the urban growth boundaries of the
18	cities;
19	"(2) Encourage, to the extent practicable given market conditions, the development of
20	urban areas in which individuals desire to live and work and that are increasingly efficient
21	in terms of land uses and in terms of public facilities and services;
22	"(3) Encourage the conservation of important farm and forest lands, particularly lands
23	that are needed to sustain agricultural and forest products industries;
24	"(4) Encourage cities to increase the development capacity within the urban growth
25	boundaries of the cities;
26	"(5) Encourage the provision of an adequate supply of serviceable land that is planned for
27	needed urban residential and industrial development; and
28	"(6) Assist residents in understanding the major local government decisions that are
29	likely to determine the form of a city's growth.
30	"SECTION 3. (1) In addition to and not in lieu of the method prescribed in ORS 197.295
31	to 197.314 and the statewide land use planning goals, the Land Conservation and Development
32	Commission shall adopt by rule methods by which a city that is outside Metro may evaluate
33	or amend the urban growth boundary of the city.
34	"(2) A city outside Metro may use the methods adopted pursuant to:
35	"(a) Section 4 of this 2013 Act if the city has a population of less than 10,000.

1 "(b) Section 5 of this 2013 Act if the city has a population of 10,000 or more.

"(3) A city that elects to include land within the urban growth boundary of the city under
a method established pursuant to section 4 or 5 of this 2013 Act:

4

"(a) May use the method again when:

5 "(A) The population of the city has grown by at least 50 percent of the amount of growth 6 forecast to occur in conjunction with the previous use of the method by the city; or

"(B) At least one-half of the lands identified as buildable lands during the previous use
of the method by the city have been developed.

9 "(b) Shall evaluate whether the city needs to include within the urban growth boundary 10 additional land for residential or employment uses before the population of the city has 11 grown by 100 percent of the population growth forecast to occur in conjunction with the 12 previous use of the method by the city.

13"(4) A city that elects to use a method established pursuant to section 4 or 5 of this 2013 Act shall notify the Department of Land Conservation and Development of the election in the 14 15 manner required by ORS 197.610 for notice of a post-acknowledgment plan amendment. The 16 city may revoke the election until the city makes a final decision whether to amend the urban growth boundary of the city. A city that has initiated, but not completed, an amendment 17 18 of its urban growth boundary before January 1, 2014, may withdraw the proposed amendment 19 and use a method established pursuant to section 4 or 5 of this 2013 Act by filing notice of the election with the department in the manner required by ORS 197.610 and 197.615 for no-20 21tice of a post-acknowledgment plan amendment.

"(5) Beginning on or before January 1, 2023, the commission shall:

"(a) Evaluate, every five years, the impact of the implementation of sections 4 (2) and 5
(2) of this 2013 Act on the population per square mile, livability in the area, the provision and
cost of urban facilities and services, the rate of conversion of agriculture and forest lands
and other considerations;

"(b) Consider changes to the statewide land use planning goals or rules to address adverse outcomes; and

"(c) Make recommendations to the Legislative Assembly, as necessary, for statutory
 changes.

31 "<u>SECTION 4.</u> (1) In addition to and not in lieu of the method prescribed in ORS 197.295 32 to 197.314 and the statewide land use planning goals, the Land Conservation and Development 33 Commission shall adopt a method by which a city outside Metro that has a population of less 34 than 10,000 may evaluate or amend its urban growth boundary.

"(2) The commission shall design the method so that:

36 "(a) A city using the method:

37 "(A) Will have within its boundaries sufficient buildable lands and other development 38 capacity, including land and capacity for needed housing and employment opportunities, to 39 meet the growth in population and employment forecast to occur over a 14-year period.

40 "(B) Will not become less efficient in its use of land as a result of a change to the urban
41 growth boundary.

42 "(b) The urban population per square mile will continue, subject to market conditions,
43 to increase over time on a statewide basis and in major regions of the state, including that
44 portion of the Willamette Valley outside of Metro.

45 "(c) The rate of conversion of agricultural and forest lands to urban uses does not in-

crease over time in any major region of the state. 1 2 "(3) Under the method adopted by the commission: 3 "(a) A city's determination of the amount of buildable lands needed for housing, employ-4 ment and other urban uses must be based on the population and employment growth forecast to occur over a 14-year period. 5 "(b) A city's determination of the supply and development capacity of lands within its 6 7 urban growth boundary must be based on: "(A) A simple inventory of vacant and partially vacant buildable lands within the urban 8 9 growth boundary; "(B) The comprehensive plan designation and the zoning of the portion of the buildable 10 11 lands that is urban; and "(C) Simple factors established by the commission for forecasting: 12"(i) The development and redevelopment capacity of urbanizable lands within the urban 13growth boundary; and 14 "(ii) The redevelopment capacity of developed urban lands within the urban growth 15 16 boundary. "(c) A city's determination of the supply and development capacity of lands the city 1718 proposes to include within the urban growth boundary must be based on: 19 "(A) A simple inventory of vacant and partially vacant lands; and "(B) Simple factors established by the commission for forecasting the development and 20 21redevelopment capacity of the lands. 22"(d) A city shall demonstrate that lands included within the urban growth boundary: 23 "(A) Include sufficient serviceable land for at least a seven-year period. "(B) Can all be serviceable over a 14-year period. 24 25"(e) Lands included within the urban growth boundary: "(A) Must be planned and zoned for categories of land uses in amounts that are roughly 26 proportional to the land need determined for each category of use; 27 28 "(B) Must be planned and zoned for an intensity of use that is generally consistent with 29 the estimates that were used to determine the amount of land needed; "(C) Must be planned and zoned to meet the requirements for needed housing, and those 30 requirements must be specified by rule of the commission in a manner that is as objective 3132as practicable; and 33 "(D) May be either: "(i) Planned and zoned, or otherwise conditioned, to avoid significantly affecting a state 34highway, a state highway interchange or a freight route designated in the Oregon Highway 35 Plan; or 36 37 "(ii) Allowed to significantly affect a state highway, a state highway interchange or a 38 freight route designated in the Oregon Highway Plan subject to mitigation, consistent with rules of the commission, if the lands are planned and zoned for compact urban development 39 40 or industrial uses. 41 "(4) For purposes of subsection (3)(a) of this section, population growth must be forecast as provided in ORS 195.034 or 195.036. Employment growth must be forecast based on the 42population growth forecast for the city or the employment growth forecast issued by the 43 44 Employment Department for the county or region. The commission shall establish factors, 45 by rule, for converting the forecasted population and employment growth into forecasts of

1 land need for housing, employment and other categories of uses. The factors must: 2 "(a) Be based on an empirical evaluation of the relation between population and employment growth and the rate and trends of land utilization in the recent past in the applicable 3 4 major region of the state; "(b) Reflect consideration by the commission of any significant changes occurring or ex-5 pected to occur in the markets for urban land uses in that major region of the state; 6 7 "(c) Be designed to encourage an increase in the land use efficiency of a city, subject to 8 market conditions; and "(d) Provide a range of policy choices for a city about the form of its future growth. 9 "(5) For purposes of subsection (3)(b) of this section, the commission shall establish fac-10 11 tors for supply and development capacity that are: "(a) Based on an empirical evaluation of the population and employment growth that has 1213occurred on similarly situated lands through development and redevelopment; "(b) Based on consideration by the commission of any significant changes occurring or 14 15expected to occur in the markets for urban land uses in that major region of the state; "(c) Designed to encourage an increase in the land use efficiency of the city, subject to 16 market conditions; and 17 18 "(d) Designed to provide a range of policy choices for a city about the form of its future growth. 19 "(6) For purposes of subsection (3)(c) of this section, the commission shall establish fac-2021tors that are: 22"(a) Based on an empirical evaluation of the population and employment growth that has 23occurred on similarly situated lands through development and redevelopment; "(b) Based on consideration by the commission of any significant changes occurring or 24 25expected to occur in the markets for urban land uses in each major region of the state; "(c) Designed to encourage an increase in the land use efficiency of the city, subject to 26market conditions; and 27 "(d) Designed to provide a range of policy choices for a city about the form of its future 28growth. 29 30 "(7) For lands that are included within an urban growth boundary pursuant to this section and not made serviceable within 20 years after the date of their inclusion, the commis-31sion may provide by rule that: 3233 "(a) The lands must be removed from within the urban growth boundary the next time the city evaluates the urban growth boundary; or 34(b) The planned development capacity of the lands must be reduced if there are signif-35 icant increases in the cost of making the lands serviceable. 36

37 "(8) When lands included within the urban growth boundary pursuant to this section are 38 planned and zoned for industrial or residential uses, the lands must remain planned and 39 zoned for the use unless a rule of the commission allows a change in planning and zoning 40 based on a significant change in circumstance.

41 "<u>SECTION 5.</u> (1) In addition to and not in lieu of the method prescribed in ORS 197.295
42 to 197.314 and the statewide land use planning goals, the Land Conservation and Development
43 Commission shall adopt a method by which a city outside Metro that has a population of
44 10,000 or more may evaluate or amend its urban growth boundary.

45 "(2) The commission shall design the method so that:

1 "(a) A city using the method:

2 "(A) Will have within its boundaries sufficient buildable lands and other development 3 capacity, including land and capacity for needed housing and employment opportunities, to 4 meet the growth in population and employment forecast to occur over a 14-year period.

5 "(B) Will not become less efficient in its use of land as a result of a change to the urban 6 growth boundary.

"(b) The urban population per square mile will continue to increase over time on a
statewide basis and in major regions of the state, including that portion of the Willamette
Valley outside of Metro.

10 "(c) The rate of conversion of agricultural and forest lands to urban uses does not in-11 crease over time in any major region of the state.

"(3) Under the method adopted by the commission:

"(a) A city's determination of the amount of buildable lands needed for housing, employ ment and other urban uses must be based on the population and employment growth forecast
 to occur over a 14-year period.

"(b) A city's determination of the supply and development capacity of lands within its
 urban growth boundary must be based on:

"(A) An inventory of vacant and partially vacant buildable lands within the urban growth
 boundary;

"(B) The comprehensive plan designation and the zoning of the portion of the buildable
 lands that is urban; and

22 "(C) Factors established by the commission for forecasting:

"(i) The development and redevelopment capacity of urbanizable lands within the urban
 growth boundary; and

25 "(ii) The redevelopment capacity of developed urban lands within the urban growth
 26 boundary.

"(c) A city shall consider a range or combination of measures identified by rule of the commission to accommodate future need for land within the urban growth boundary and implement at least one measure or satisfy an alternate performance standard established by the commission. The commission shall design the alternate performance standard so that the standard is satisfied when the city:

"(A) Has a development code that contains specified provisions designed to encourage the
 development of needed housing; and

"(B) Demonstrates that, during the preceding planning period, the city:

"(i) If located in the Willamette Valley, exceeded the median rate of redevelopment and infill for cities with a population of 10,000 or more in the Willamette Valley that are outside of the boundaries of Metro by an amount set by commission rule; and

38 "(ii) If located outside of the Willamette Valley, exceeded the median rate of redevelop-39 ment and infill for cities with a population of 10,000 or more that are outside the Willamette 40 Valley by an amount set by commission rule.

41 "(d) A city shall demonstrate that lands included within the urban growth boundary:

42 "(A) Include sufficient serviceable land for at least a seven-year period.

43 **"(B) Can all be serviceable over a 14-year period.** 

44 "(e) Lands included within the urban growth boundary:

45 "(A) Must be planned and zoned for categories of land uses in amounts that are roughly

1 proportional to the land need determined for each category of use;

2 "(B) Must be planned and zoned for an intensity of use that is generally consistent with 3 the estimates that were used to determine the amount of land needed;

4 "(C) Must be planned and zoned to meet the requirements for needed housing, and those 5 requirements must be specified by rule of the commission in a manner that is as objective 6 as practicable; and

"(D) May be either:

7

8 "(i) Planned and zoned, or otherwise conditioned, to avoid significantly affecting a state
9 highway, a state highway interchange or a freight route designated in the Oregon Highway
10 Plan; or

"(ii) Allowed to significantly affect a state highway, a state highway interchange or a freight route designated in the Oregon Highway Plan subject to mitigation, consistent with rules of the commission, if the lands are planned and zoned for compact urban development or industrial uses.

15 "(4) For purposes of subsection (3)(a) of this section, population growth must be forecast 16 as provided in ORS 195.034 or 195.036. Employment growth must be forecast based on the 17 population growth forecast for the city or the employment growth forecast issued by the 18 Employment Department for the county or region. The commission shall establish factors, 19 by rule, for converting the forecasted population and employment growth into forecasts of 20 land need for housing, employment and other categories of uses. The factors must:

"(a) Be based on an empirical evaluation of the relation between population and employ ment growth and the rate and trends of land utilization in the recent past in the applicable
 major region of the state;

24 "(b) Reflect consideration by the commission of any significant changes occurring or ex-25 pected to occur in the markets for urban land uses in that major region of the state;

26 "(c) Be designed to encourage an increase in the land use efficiency of a city, subject to 27 market conditions; and

28 "(d) Provide a range of policy choices for a city about the form of its future growth.

29 "(5) For purposes of subsection (3)(b) of this section, the commission shall establish fac-30 tors for supply and development capacity that are:

"(a) Based on an empirical evaluation of the population and employment growth that has
 occurred on similarly situated lands through development and redevelopment;

"(b) Based on consideration by the commission of any significant changes occurring or
 expected to occur in the markets for urban land uses in that major region of the state;

"(6) For purposes of subsection (3)(c) of this section, the commission shall establish fac tors that are:

43 "(b) Based on consideration by the commission of any significant changes occurring or

44 expected to occur in the markets for urban land uses in each major region of the state;

45 "(c) Designed to encourage an increase in the land use efficiency of the city, subject to

2 "(d) Designed to provide a range of policy choices for a city about the form of its future 3 growth.

4 "(7) For lands that are included within an urban growth boundary pursuant to this sec-5 tion and not made serviceable within 20 years after the date of their inclusion, the commis-6 sion may provide by rule that:

"(a) The lands must be removed from within the urban growth boundary the next time
the city evaluates the urban growth boundary; or

9 "(b) The planned development capacity of the lands must be reduced if there are signif-10 icant increases in the cost of making the lands serviceable.

"(8) When lands included within the urban growth boundary pursuant to this section are planned and zoned for industrial or residential uses, the lands must remain planned and zoned for the use unless a rule of the commission allows a change in planning and zoning based on a significant change in circumstance.

15 "SECTION 6. (1) As used in this section, 'district' means:

16 "(a) A domestic water supply district organized under ORS chapter 264.

17 "(b) A parks and recreation district organized under ORS chapter 266.

18 "(c) A sanitary district organized under ORS 450.005 to 450.245.

19 "(d) A rural fire protection district organized under ORS chapter 478.

20 "(2) When a city evaluates or amends the urban growth boundary of the city under sec-21 tion 5 of this 2013 Act, the city shall notify:

"(a) Each district that has territory within the study area established under section 7
of this 2013 Act.

24 "(b) Each county that has land use jurisdiction over any portion of the study area.

25 **"(3) The notification must:** 

26 "(a) Include a map showing the study area; and

"(b) State that, in order to execute or amend an urban services agreement concerning the study area, the district shall respond to the notice within 60 days of the date the notice is mailed if the district enters into or amends an urban services agreement concerning the study area.

31 "(4) An urban services agreement executed under this section must satisfy the require-32 ments of ORS 195.065 (1)(a) to (f). When a city and a district execute an urban services 33 agreement pursuant to this section, the city and the district are not required to participate 34 in the negotiation of an urban service agreement under ORS 195.065 to 195.085.

35 "(5) Before executing the urban service agreement, the city and the district shall consult 36 with community planning organizations that are recognized by the governing body of the city 37 and whose boundaries include territory in the study area that may be affected by the urban 38 service agreement.

39 "(6) If the special district chooses not to negotiate an urban service agreement or does 40 not respond to the notice within 60 days, the city may withdraw from the service territory 41 of the district any portion of the study area that is included within the urban growth 42 boundary of the city and annexed to the city.

43 "(7) If the district responds in writing to the notice within 60 days and requests to exe44 cute an urban service agreement for the study area with the city, the city and the district
45 shall meet to develop the agreement within 60 days after the district responds.

1 "(8) If the city and district are unable to develop the agreement within 180 days after the 2 date of the first meeting, the city or the district may require mediation. If mediation is re-3 quired, the city and the district shall each designate an individual to work with the city and 4 the district to develop an agreement. The city and the district are each responsible for the 5 costs of the mediator it selects.

6 "(9) If the city and the district are unable to develop the agreement after an additional 7 180 days, the city or the district may require arbitration. The mediators selected under subsection (8) of this section shall jointly select a third individual, and the three individuals 8 shall constitute an arbitration panel to develop the urban services agreement. If the 9 mediators are unable to agree on the third individual, the Director of the Department of 10 11 Land Conservation and Development shall select an individual from a list of qualified arbitrators provided by the Land Conservation and Development Commission. The city and 12the district shall bear the cost of the third individual equally. The arbitration panel: 13

"(a) Shall consider the provisions of ORS 222.460, 222.465, 222.510 to 222.570, 222.575 and
 222.580; and

"(b) May not:

16

"(A) Require the city or the district to pay the other party as part of the urban services
 agreement unless:

"(i) The urban services agreement requires a transfer of physical assets, in which case
 the agreement may require the payment of fair market value for the assets; or

21 "(ii) A party has offered a payment as part of prior negotiations and the arbitrators in-22 corporate all or a portion of the negotiated payment in the agreement;

"(B) Prevent a city from including land within the urban growth boundary of the city;
or

"(C) Prohibit a city from annexing territory that is within the urban growth boundary
 of the city.

27 "(10) A city may not withdraw territory from the service territory of a district:

28 "(a) Unless the district does not respond to the notice required by subsection (2) of this
29 section; or

"(b) Until the city and the district develop an urban services agreement under this sec tion.

"(11) Decisions related to the execution of an urban service agreement under this section
 are not land use decisions subject to the jurisdiction of the Land Use Board of Appeals.

34 "<u>SECTION 7.</u> (1) Notwithstanding the priority in ORS 197.298 for inclusion of land within 35 an urban growth boundary, a city outside of Metro shall comply with this section when de-36 termining which lands to include within the urban growth boundary of the city pursuant to 37 ORS 197.295 to 197.314 or section 4 or 5 of this 2013 Act.

38

"(2) The Land Conservation and Development Commission shall provide, by rule, that:

"(a) When evaluating lands for inclusion within the urban growth boundary, the city shall
establish a study area that includes all land that is contiguous to the urban growth boundary
and within a distance specified by commission.

42 "(b) The city shall evaluate all land in the study area for inclusion in the urban growth
43 boundary as provided in subsection (4) of this section, except for land excluded from the
44 study area because:

45

"(A) It is impracticable, as provided in subsection (3) of this section, to provide necessary

1 public facilities or services to the land.

"(B) The land is subject to significant development hazards, including a risk of land slides, a risk of flooding because the land is within the 100-year floodplain or is subject to inundation during storm surges or tsunamis, and other risks determined by the commission. "(C) The long-term preservation of significant scenic, natural, cultural or recreational resources requires limiting or prohibiting urban development of the land that contains the resources.

8 9

"(D) The land is owned by the federal government and managed primarily for rural uses. "(c) When evaluating the priority of land for inclusion under paragraph (b) of this sub-

10 section:

11 "(A) The city shall evaluate the land within the study area that is designated as an urban 12 reserve under ORS 195.145 in an acknowledged comprehensive plan, land that is subject to 13 an acknowledged exception under ORS 197.732 or land that is nonresource land and select 14 as much of the land as necessary to satisfy the need for land using criteria established by 15 the commission and criteria in an acknowledged comprehensive plan and land use regu-16 lations.

"(B) If the amount of land appropriate for selection under subparagraph (A) of this paragraph is not sufficient to satisfy the need for land, the city shall evaluate the land within the study area that is designated as marginal land under ORS 197.247 (1991 Edition) in the acknowledged comprehensive plan and select as much of the land as necessary to satisfy the need for land using criteria established by the commission and criteria in an acknowledged comprehensive plan and land use regulations.

"(C) If the amount of land appropriate for selection under subparagraphs (A) and (B) of this paragraph is not sufficient to satisfy the amount of land needed, the city shall evaluate land within the study area that is designated for agriculture or forest uses in the acknowledged comprehensive plan that is not predominantly high-value farmland, as defined in ORS 195.300, or does not consist predominantly of prime or unique soils, as determined by the United States Department of Agriculture Natural Resources Conservation Service, and select as much of that land as necessary to satisfy the need for land:

"(i) Using criteria established by the commission and criteria in an acknowledged com prehensive plan and land use regulations; and

"(ii) Using the predominant capability classification system or the predominant cubic site
 class, as appropriate for the acknowledged comprehensive plan designation, to select lower
 capability or cubic site class lands first.

35 "(D) If amount of land appropriate for selection under subparagraphs (A) to (C) of this paragraph is not sufficient to satisfy the need for land, the city shall evaluate land within 36 37 the study area that is designated as agricultural land in an acknowledged comprehensive plan 38 and is predominantly high value farmland and select as much of that land as necessary to 39 satisfy the need for land. A local government may not select land that is predominantly made 40 up of prime or unique farm soils, as defined by the United States Department of Agriculture 41 Natural Resources Conservation Service, unless there is an insufficient amount of other land 42to satisfy its land need.

43 "(3) For purposes of subsection (2)(b)(A) of this section, the commission shall determine
44 impracticability by rule, considering the likely amount of development that could occur on
45 the lands within the planning period, the likely cost of facilities and services, physical,

topographical or other impediments to service provision and whether urban development has 1 2 occurred on similarly situated lands such that it is likely that the lands will be developed at an urban level during the planning period. When impracticability is primarily a result of ex-3 4 isting development patterns, the rules of the commission shall require that the lands be included within the study area, but may allow the development capacity forecast for the lands 5 to be specified at a lower level over the planning period. The rules of the commission must 6 7 be based on an evaluation of how similarly situated lands have, or have not, developed over 8 time.

9 "(4) For purposes of subsection (2)(b)(C) of this section, the commission by rule shall 10 determine the circumstances in which and the resources to which this exclusion will apply.

11 "(5) Notwithstanding subsection (2)(c)(D) of this section, the rules must allow land that 12 would otherwise be excluded from an urban growth boundary to be included if:

(a) The land contains a small amount of resource land that is not important to the commercial agricultural enterprise in the area and the land must be included to connect a nearby and significantly larger area of land of higher priority for inclusion within the urban growth boundary; or

17 "(b) The land contains a small amount of resource land that is not predominantly high-18 value farmland or predominantly made up of prime or unique farm soils and the land is 19 completely surrounded by land of higher priority for inclusion into the urban growth bound-20 ary.

"(6) When the primary purpose for expansion of the urban growth boundary is to accommodate a particular industry use that requires specific site characteristics, or to accommodate a public facility that requires specific site characteristics and the site characteristics may be found in only a small number of locations, the city may limit the study area to land that has, or could be improved to provide, the required site characteristics. Lands included within an urban growth boundary for a particular industrial use, or a particular public facility, must remain planned and zoned for the intended use:

"(a) Except as allowed by rule of the commission that is based on a significant change
in circumstance or the passage of time; or
