# House Bill 2500

Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of House Interim Committee on Revenue)

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Expands types of costs that qualify as approved transportation costs for purposes of State School Fund distributions. Declares emergency, effective July 1, 2013.

 $\mathbf{5}$ SECTION 1. ORS 327.006 is amended to read:

6 327.006. As used in ORS 327.006 to 327.133, 327.348 and 327.731:

7 (1) "Aggregate days membership" means the sum of days present and absent, according to the 8 rules of the State Board of Education, of all resident pupils when school is actually in session during

9 a certain period. The aggregate days membership of kindergarten pupils shall be calculated on the

10 basis of a half-day program.

[(E)] (v) Students who require payment of room and board in lieu of transportation;

4 (3) "Average daily membership" or "ADM" means the aggregate days membership of a school 5 during a certain period divided by the number of days the school was actually in session during the 6 same period. However, if a district school board adopts a class schedule that operates throughout 7 the year for all or any schools in the district, average daily membership shall be computed by the 8 Department of Education so that the resulting average daily membership will not be higher or lower 9 than if the board had not adopted such schedule.

(4) "Consumer Price Index" means the Consumer Price Index for All Urban Consumers of the
Portland, Oregon, Metropolitan Statistical Area, as compiled by the United States Department of
Labor, Bureau of Labor Statistics.

(5) "Kindergarten" means a kindergarten program that conforms to the standards and rulesadopted by the State Board of Education.

(6) "Net operating expenditures" means the sum of expenditures of a school district in kindergarten through grade 12 for administration, instruction, attendance and health services, operation of plant, maintenance of plant, fixed charges and tuition for resident students attending in another district, as determined in accordance with the rules of the State Board of Education, but net operating expenditures does not include transportation, food service, student body activities, community services, capital outlay, debt service or expenses incurred for nonresident students.

(7)(a) "Resident pupil" means any pupil:

(A) Whose legal school residence is within the boundaries of a school district reporting the pupil, if the district is legally responsible for the education of the pupil, except that "resident pupil" does not include a pupil who pays tuition or for whom the parent pays tuition or for whom the district does not pay tuition for placement outside the district; or

(B) Whose legal residence is not within the boundaries of the district reporting the pupil but
who attends school in the district with the written consent of the district school board where the
school is located as provided by ORS 339.133 (5).

25 <u>SECTION 3.</u> The amendments to ORS 327.006 by section 1 of this 2013 Act first apply to 26 expenditures made on or after the effective date of this 2013 Act.

27 <u>SECTION 4.</u> This 2013 Act being necessary for the immediate preservation of the public 28 peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect 29 July 1, 2013.
