House Bill 2875

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Provides that expiring charter remains in effect for public charter school until new charter is negotiated following approval of renewal of charter. Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to renewals of charters for public charter schools; amending ORS 338.065; and declaring 3 an emergency.

Be It Enacted by the People of the State of Oregon: 4

SECTION 1. ORS 338.065 is amended to read: $\mathbf{5}$

338.065. (1)(a) Upon approval of a proposal by a school district board under ORS 338.055, the 6 7 school district board shall become the sponsor of the public charter school.

8 (b) Pursuant to ORS 338.075 (2) or (4), the State Board of Education shall become the sponsor of the public charter school. 9

(c) Pursuant to ORS 338.075 (5), the institution of higher education shall become the sponsor of 10 11 the public charter school.

12 (2) The sponsor and the applicant shall develop a written charter that contains the provisions of the proposal that have been duly approved by the sponsor and public charter school governing 1314 body. The sponsor and the applicant may agree to change elements of the proposal prior to incorporating them into the charter or exclude elements of the proposal from the charter. The charter, 15 16 when duly executed by the sponsor and the public charter school governing body, shall act as the 17legal authorization for the establishment of the public charter school. The charter shall be legally 18 binding on both the sponsor and the public charter school governing body.

19 (3) The sponsor and the public charter school governing body may amend a charter by joint 20 agreement.

21(4)(a) The initial charter shall be in effect for a period of not more than five years and shall be 22renewed upon the authorization of the sponsor using the process established under this section.

23(b) The first renewal of a charter shall be for the same time period as the initial charter.

(c) Subsequent renewals of a charter shall be for a minimum of five years but may not exceed 2425 10 years.

26 (5)(a) The renewal of a charter shall use the process required by this section.

27(b) The public charter school governing body shall submit a written renewal request to the sponsor for consideration at least 180 days prior to the expiration of the charter. 28

29 (c) Within 45 days after receiving a written renewal request from a public charter school gov-30 erning body, the sponsor shall hold a public hearing regarding the request for renewal.

31 (d) Within 10 days after the public hearing, the sponsor shall notify the public charter school

1 governing body of the sponsor's intent about the renewal of the charter.

2 (e) Within 20 days after the public hearing, the sponsor shall approve the renewal of the charter 3 or state in writing the reasons for denying the renewal of the charter.

4 (f) If the sponsor approves the renewal of the charter, the sponsor and the public charter school 5 governing body shall negotiate a new charter within 90 days after the date on which the sponsor 6 approved the renewal of the charter unless the sponsor and the public charter school governing 7 body agree to an extension of the time period. Notwithstanding the time period specified in the 8 charter, an expiring charter shall remain in effect until a new charter is negotiated.

9 (g) If the sponsor does not renew the charter, the public charter school governing body may 10 address the reasons stated under paragraph (e) of this subsection and any remedial measures sug-11 gested by the sponsor and submit a revised request for renewal to the sponsor.

(h) Notwithstanding paragraphs (b) to (g) of this subsection, a sponsor and a public charter
school governing body may agree in the charter of the school to a timeline for renewing the charter
that is different from the timeline required by paragraphs (b) to (g) of this subsection.

(6)(a) If the sponsor does not renew the charter based on the revised request for renewal submitted under subsection (5)(g) of this section, the public charter school governing body may appeal the decision of the sponsor to the State Board of Education for a review of whether the sponsor used the process required by this section in denying the renewal of the charter.

(b) If the state board finds that the sponsor used the process required by this section in denying the request for renewal, the state board shall affirm the decision of the sponsor. A public charter school governing body may seek judicial review of an order of the state board pursuant to ORS 183.484.

(c) If the state board finds that the sponsor did not use the process required by this section in
denying the request for renewal, the state board shall order the sponsor to reconsider the request
for renewal.

(d) If after reconsideration pursuant to paragraph (c) of this subsection the sponsor does not
 renew the charter, the public charter school governing body may seek judicial review of an order
 of the sponsor pursuant to ORS 183.484.

(7) If the State Board of Education is the sponsor of a public charter school and the state board does not renew the charter based on the revised request for renewal submitted under subsection (5)(g) of this section, the public charter school governing body may seek judicial review of an order of the state board pursuant to ORS 183.484 for a review of whether the state board used the process required by this section in denying the request for renewal.

(8)(a) The sponsor shall base the charter renewal decision on a good faith evaluation of whether
 the public charter school:

36 (A) Is in compliance with this chapter and all other applicable state and federal laws;

37 (B) Is in compliance with the charter of the public charter school;

(C) Is meeting or working toward meeting the student performance goals and agreements spec ified in the charter or any other written agreements between the sponsor and the public charter
 school governing body;

(D) Is fiscally stable and has used the sound financial management system described in the
 proposal submitted under ORS 338.045 and incorporated into the written charter under this section;
 and

44 (E) Is in compliance with any renewal criteria specified in the charter of the public charter 45 school.

1 (b) The sponsor shall base the renewal evaluation described in paragraph (a) of this subsection 2 primarily on a review of the public charter school's annual performance reports, annual audit of 3 accounts and annual site visit and review as required by ORS 338.095 and any other information 4 mutually agreed upon by the public charter school governing body and the sponsor.

5 <u>SECTION 2.</u> This 2013 Act being necessary for the immediate preservation of the public 6 peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect 7 on its passage.
