"(c) Shall continuously maintain a registered agent and a registered office in this state and file 23a statement that identifies the person's registered agent and lists the address of the person's regis-24 tered office with the Secretary of State, if the trustee is a person described in paragraph (b)(B) of 2526this subsection, or with the Director of the Department of Consumer and Business Services under 27ORS 731.434, if the trustee is a person described in paragraph (b)(C) of this subsection.".
