## House Bill 3113

Sponsored by COMMITTEE ON REVENUE

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Eliminates requirement that statements regarding measures authorizing bonds or certain taxes be printed on envelopes in which ballot titles are delivered. Eliminates requirement that ballot title for measure authorizing local option tax contain certain additional statement.

Declares emergency, effective on passage.

## A BILL FOR AN ACT

2 Relating to taxation-related elections; creating new provisions; amending ORS 250.037, 250.038 and

4 Be It Enacted by the People of the State of Oregon:

**SECTION 1.** ORS 250.037 is amended to read:

(2) The words of the statement required by subsection (1) of this section are not counted forpurposes of ORS 250.035.

(3) The ballot title statement for any measure requesting elector approval of bonds, the principal
and interest on which is to be payable from taxes imposed on property or property ownership that
are not subject to the limitations of Article XI, sections 11 and 11b, [Article XI] of the Oregon
Constitution, shall contain, in addition to the other requirements of ORS 250.035 and this section,
a reasonably detailed, simple and understandable description of the use of proceeds.

2 (a) The tax rate per \$1,000 of assessed value of the proposed permanent rate limitation.

3 (b) The first fiscal year in which the proposed permanent rate limitation will be imposed.

4 [(7)] (6) The ballot title for a measure authorizing the imposition of local option taxes or a 5 permanent rate limitation shall be in compliance with ORS 250.036.

6 <u>SECTION 4.</u> The amendments to ORS 250.037, 250.038 and 280.070 by sections 1 to 3 of this 7 2013 Act apply to elections held on or after the effective date of this 2013 Act.

8 <u>SECTION 5.</u> This 2013 Act being necessary for the immediate preservation of the public 9 peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect 10 on its passage.
