House Bill 3217

Sponsored by COMMITTEE ON HUMAN SERVICES AND HOUSING

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Expands definition of abuse of individuals with mental illness. Recognizes responsibility of Oregon Health Authority to investigate abuse of individuals with mental illness. Declares emergency, effective on passage.

Any actions taken to 11 12 protect an adult shall be undertaken in a manner that is least intrusive to the adult and provides 13 for the greatest degree of independence.
