

HOUSE AMENDMENTS TO A-ENGROSSED HOUSE BILL 3453

July 7

1 On page 1 of the printed A-engrossed bill, delete lines 15 through 19 and insert:

2 “(2) Prior to declaring a public safety fiscal emergency, the Governor shall consult with the
3 Senate President, the Majority and Minority Leaders of the Senate, the Speaker of the House of
4 Representatives, the Majority and Minority Leaders of the House of Representatives, each Senator
5 and Representative whose district is wholly or partially within a county that is proposed to be
6 subject to the public safety fiscal emergency and each sheriff of a county that is proposed to be
7 subject to the public safety fiscal emergency.”.

8 On page 2, after line 4, insert:

9 “**SECTION 2a. Notwithstanding section 2 of this 2013 Act, the Governor may not proclaim**
10 **a public safety fiscal emergency that affects more than two counties before July 15, 2014.**”.

11 In line 12, after the period insert “The Governor shall consult with each sheriff affected by the
12 proclamation prior to executing the intergovernmental agreement.”.

13 After line 27, insert:

14 “(4) For purposes of this section:

15 “(a) The sheriff of a county affected by a public safety fiscal emergency shall be considered a
16 nonvoting ex officio member of the governing body; and

17 “(b) The sheriff must be given notice of any meeting of the governing body if the governing body
18 is meeting for purposes of deliberating or making a decision on:

19 “(A) Whether to enter into an intergovernmental agreement under this section;

20 “(B) The terms and conditions of an intergovernmental agreement entered into under this sec-
21 tion; or

22 “(C) Any extension or modification of an intergovernmental agreement entered into under this
23 section.”.

24 On page 3, after line 24, insert:

25 “**SECTION 6a. (1) If an intergovernmental agreement is entered into under section 3 of**
26 **this 2013 Act, the Governor shall report to the Legislative Assembly as provided in ORS**
27 **192.245. The report shall include a copy of the intergovernmental agreement.**

28 “(2)(a) **If an intergovernmental agreement is entered into under section 3 of this 2013**
29 **Act during a regular session of the Legislative Assembly, the intergovernmental agreement**
30 **may not take effect until after adjournment sine die of that regular session.**

31 “(b) **If an intergovernmental agreement is entered into under section 3 of this 2013 Act**
32 **during the interim, the intergovernmental agreement may not take effect until after**
33 **adjournment sine die of the next regular session of the Legislative Assembly.**”.

34 On page 4, delete lines 17 and 18 and insert:

35 “(a) For cellular, wireless or other radio common carriers, the tax applies on a per instrument

1 basis and only if the subscriber's place of primary use, as defined under 4 U.S.C. 124, is within the
2 county imposing the tax;

3 “(b) For all other subscriber lines, the tax applies to lines designated for a particular subscriber
4 located within the county imposing the tax; and”.

5 In line 19, delete “(b)” and insert “(c)”.

6 On page 5, delete lines 5 through 9.
