# House Bill 3485

Sponsored by Representative DOHERTY

### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** 

Prohibits person from sending advertisement that is for mortgage loan services or other extensions of credit that are secured by real property and that has certain characteristics unless person has previous business relationship with recipient or unless advertisement meets certain criteria.

#### A BILL FOR AN ACT

2 Relating to advertisements for credit services; creating new provisions; and amending ORS 646.608.

**Be It Enacted by the People of the State of Oregon:** 

4 **<u>SECTION 1.</u>** (1) As used in this section:

5 (a) "Advertisement" means a written or graphic statement or representation that a 6 person makes to a recipient in order to solicit a business transaction with the recipient or 7 with the intent or expectation that the recipient will respond in such a way as to enable the 8 person to solicit or enter into a business transaction with the recipient.

9 (b) "Communicate" means to send or transmit a message to a recipient through a me-10 dium that includes, but is not limited to, direct mail, electronic mail or other electronic 11 communication via the Internet.

(c) "Official message" means a statement of account, account summary or account record, notice or other message that a person in the ordinary course of the person's business might send to a recipient with whom the person has a previous business relationship, or to whom the person has a fiduciary duty or an obligation that exists as a consequence of a law, regulation or rule.

(d) "Person" means an individual, public or private corporation, nonprofit corporation,
joint stock or limited liability company, partnership, firm, association, trust company, business trust or other business entity, government, political subdivision, governmental agency
or public body, as defined in ORS 174.109.

(e) "Previous business relationship" means a previous transaction or series of transactions of a commercial or pecuniary character between a person and a recipient that occurred within the 18 months that preceded the date on which the recipient received an advertisement from the person.

(f) "Recipient" means an individual who resides in this state, or a member of the individual's family, to whom a person communicates, or who receives, an advertisement that is subject to this section.

(2)(a) Except as provided in paragraph (b) of this subsection, a person may not commu nicate to a recipient in this state with whom the person does not have a previous business
 relationship an advertisement concerning a mortgage loan or other extension of credit that
 is or would be secured by real property if the advertisement:

(A) Mimics or resembles, or is intended to mimic or resemble, in a reasonable person's estimation, an official message; (B) Includes a logo, trademark, name, title, symbol, device or other designation that identifies or belongs to a person other than the person that communicates the advertisement: (C) Conceals, obscures or makes unobtrusive or inconspicuous the purpose of the advertisement or the identity of the person that communicates the advertisement in such a way that a reasonable person: (i) Would be misled as to the purpose of the advertisement or as to the identity of the person that communicates the advertisement; or (ii) Would have to give close or sustained attention to the advertisement in order to discover the purpose of the advertisement or the identity of the person that communicates the advertisement; (D) Instructs the recipient to reply to the advertisement to check the status of the recipient's mortgage loan or account or keep the advertisement or a copy of the advertisement; or (E) Does not include or displays information about the origin of the advertisement that a reasonable person would deem incomplete, inconsistent or misleading in: (i) A return address on an envelope that contains the advertisement; or (ii) An electronic mail address or uniform resource locator for an Internet site. (b) A person may send an advertisement described in paragraph (a) of this subsection to a recipient if the advertisement conforms, as appropriate for the medium in which the person communicates the advertisement, to the following requirements: (A) The words "THIS IS AN ADVERTISEMENT" must appear in capital letters at the top of any written material, without any other text on the same line and in a font or typeface that has the same color and weight as and is as large as or larger than the font or typeface that is otherwise most prominent in the written material. (B) The name or other identity of the person that communicated the advertisement must appear in the text of the advertisement before the text refers to the person with a pronoun or refers to a government, political subdivision, governmental agency or public body, as defined in ORS 174.109. (C) A genuine return address for the person that communicated the advertisement must appear on any envelope that contains the advertisement or a genuine electronic mail address or uniform resource locator that would enable the recipient to identify and contact the person that communicated the advertisement must appear in any electronic communication. (3) A person's violation of this section is an unlawful practice under ORS 646.608 that is subject to enforcement under ORS 646.632 or an action under ORS 646.638. SECTION 2. ORS 646.608, as amended by section 6, chapter 52, Oregon Laws 2012, is amended to read:

40 646.608. (1) A person engages in an unlawful practice when in the course of the person's busi-41 ness, vocation or occupation the person does any of the following:

42 (a) Passes off real estate, goods or services as those of another.

(b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, ap proval, or certification of real estate, goods or services.

45 (c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or asso-

ciation with, or certification by, another. 1

2 (d) Uses deceptive representations or designations of geographic origin in connection with real estate, goods or services. 3

(e) Represents that real estate, goods or services have sponsorship, approval, characteristics, 4 ingredients, uses, benefits, quantities or qualities that [they] the real estate, goods or services do 5 not have or that a person has a sponsorship, approval, status, qualification, affiliation, or connection 6 7 that the person does not have.

(f) Represents that real estate or goods are original or new if [they] the real estate or goods 8 9 are deteriorated, altered, reconditioned, reclaimed, used or secondhand.

10 (g) Represents that real estate, goods or services are of a particular standard, quality, or grade, or that real estate or goods are of a particular style or model, if [they] the real estate, goods or 11 12 services are of another.

13 (h) Disparages the real estate, goods, services, property or business of a customer or another by false or misleading representations of fact. 14

15 (i) Advertises real estate, goods or services with intent not to provide [them] the real estate, goods or services as advertised, or with intent not to supply reasonably expectable public demand, 16 17 unless the advertisement discloses a limitation of quantity.

18 (j) Makes false or misleading representations of fact concerning the reasons for, existence of, or amounts of price reductions. 19

(k) Makes false or misleading representations concerning credit availability or the nature of the 20transaction or obligation incurred. 21

22(L) Makes false or misleading representations relating to commissions or other compensation to be paid in exchange for permitting real estate, goods or services to be used for model or demon-23stration purposes or in exchange for submitting names of potential customers. 24

25(m) Performs service on or dismantles any goods or real estate when [not authorized by] the owner or apparent owner [thereof] of the goods or real estate does not authorize the service 2627or dismantling.

(n) Solicits potential customers by telephone or door to door as a seller unless the person pro-28vides the information required under ORS 646.611. 29

30 (o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give 31 a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of 32the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate, 33 34 discount or other value is contingent upon occurrence of an event [subsequent to] occurring after 35 the time the customer enters into the transaction.

(p) Makes any false or misleading statement about a prize, contest or promotion used to publi-36 37 cize a product, business or service.

38 (q) Promises to deliver real estate, goods or services within a certain period of time with intent not to deliver [them] the real estate, goods or services as promised. 39

(r) Organizes or induces or attempts to induce membership in a pyramid club.

(s) Makes false or misleading representations of fact concerning the offering price of, or the 41 person's cost for real estate, goods or services. 42

(t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any 43 known material defect or material nonconformity. 44

(u) Engages in any other unfair or deceptive conduct in trade or commerce. 45
