## Senate Bill 107

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with presession filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Governor John A. Kitzhaber, M.D., for Oregon Health Licensing Agency)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies certain provisions relating to Nursing Home Administrators Board, Respiratory Therapist and Polysomnographic Technologist Licensing Board, Board of Cosmetology, Board of Body Art Practitioners and Oregon Health Licensing Agency.

6	NURSING HOME ADMINISTRATORS BOARD

8	SECTION 1. ORS 678.770 is amended to read:
9	678.770. (1) The Nursing Home Administrators Board may establish by rule standards for the
10	issuance of a license by endorsement[, without examination,] to an applicant who:
11	(a) Meets the requirements as established by the board; and
12	(b) On the date of making application, is a nursing home administrator licensed under the laws
13	of any other state or territory of the United States if the requirements for licensing of nursing home
14	administrators in the state or territory in which the applicant is licensed are not less than those
15	required by ORS 678.710 to 678.820.
16	(2) Each applicant under this section shall pay to the Oregon Health Licensing Agency at the
17	time of filing the application a fee determined by the agency under ORS 678.775.

22	SECTION 2. ORS 688.819, as amended by section 21, chapter 43, Oregon Laws 2012, is amended

24	688.819. (1) An applicant for a polysomnographic technologist license shall:
25	(a) Submit to the Oregon Health Licensing Agency written evidence that the applicant:
26	(A) Is at least 18 years of age;
27	(B) Has completed an approved four-year high school course of study or the equivalent as de-
28	termined by the appropriate educational agency; and
29	(C) Has completed a polysomnography education or training program, or a polysomnography
30	program that combines education and training, approved by the Respiratory Therapist and

1 Polysomnographic Technologist Licensing Board; and

2 (b) Pass an examination approved by the board.

3 (2) An applicant meets the requirements of subsection (1)(a)(C) of this section if the applicant 4 provides the agency with documentation of military training or experience that the board determines 5 is substantially equivalent to the education **or training** required by subsection (1)(a)(C) of this sec-

6 tion.

7 (3) The agency may issue a polysomnographic technologist license by endorsement or reciprocity8 to:

9 (a) An applicant who is currently licensed to practice polysomnography under the laws of an-10 other state, territory or country if the qualifications of the applicant are considered by the agency 11 to be equivalent to those required in this state; or

12 (b) An applicant holding an active credential approved by the board.

(4) Except as provided in subsection (8) of this section, all licenses expire on the last day of themonth, one year from the date of issuance.

(5) To renew a polysomnographic technologist license, a licensee must submit to the agency a completed renewal application, required renewal fee and satisfactory evidence of completion of any required continuing education credits on or before the expiration date of the license as specified by agency rule.

(6) The agency shall adopt by rule requirements for late renewal of a license, reactivation of
an expired license or reinstatement of a license that has been expired for more than three consecutive years.

(7) If a polysomnographic technologist license has been denied, suspended or revoked for commission of a prohibited act under ORS 676.612, the agency may refuse to issue or renew the license
for up to one year from the date of denial, suspension or revocation.

(8) The agency may vary the date of license renewal by giving the applicant written notice ofthe renewal date being assigned and by making prorated adjustments to the renewal fee.

(9) The agency may issue a temporary permit to practice polysomnography in accordance withrules adopted by the agency.

(5) "Demonstration permit" means a written authorization for a person to practice, demonstrate 3 and teach one or more fields of practice on a temporary basis. 4 (6) "Esthetics" means any of the following skin care or facial care practices performed on the 5 human body or face for the purpose of keeping the skin of the human body or face healthy and 6 attractive and not for medical diagnosis or treatment of disease or physical or mental ailments: 7 (a) The use of the hands or mechanical or [electrical] electric apparatuses or appliances for 8 9 cleansing, stimulating, manipulating, exfoliating or applying lotions or creams. (b) Esthetics. 19 (c) Hair design. 20(d) Nail technology. 21 22(9) "Freelance authorization" means a written authorization that allows a practitioner to practice outside or away from a licensed facility. 23(10) "Hair design" means any of the following practices, when done upon the human body for 94 cosmetic purposes and not for medical diagnosis or treatment of disease or physical or mental 2526ailments: 27(a) Shaving, trimming or cutting of the beard or mustache. (b) Styling, permanent waving, relaxing, cutting, singeing, bleaching, coloring, shampooing, con-28ditioning, applying hair products or similar work upon the hair of an individual. 2930 (c) Massaging the scalp and neck when performed in conjunction with activities in paragraph 31 (a) or (b) of this subsection. (11) "Independent contractor" means a practitioner who qualifies as an independent contractor 32under ORS 670.600 and who is not under the control and direction of a facility license holder. 33 34 (12) "License" means a written authorization issued under ORS 690.055 to a person to operate 35a facility for providing services related to one or more fields of practice to the public. (13) "Nail technology" means any of the following manicuring or pedicuring practices performed 36 37 for cosmetic purposes and not for medical diagnosis or treatment of disease or physical or mental 38 ailments: (a) Cutting, trimming, polishing, coloring, tinting, cleansing or otherwise treating the nails of the 39 hands or feet. 40 (b) Massaging, cleansing, treating or beautifying the hands, arms below the elbow, feet or legs 41 below the knee. 42 (c) Applying, sculpturing or removing artificial nails of the hands or feet. 43 (14) "Practitioner" means a person certified to perform services included within a field of prac-44 tice. 45
