SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Directs Department of Education to conduct study on instruction of talented and gifted children.] [Requires department to submit report to interim legislative committees no later than July 1, 2014.]

[Declares emergency, effective on passage.]

Directs Department of Education to develop uniform statewide plan for education of talented and gifted children.

Requires school districts' written plans of instruction for talented and gifted children to align with uniform statewide plan.

Directs Department of Education to expend specified amount from State School Fund to provide administration of and support for talented and gifted education.

Appropriates moneys to Department of Education for uniform statewide plan and school district plans.

Declares emergency, effective July 1, 2013.

5 Whereas Oregon has 42,375 talented and gifted children, who constitute 7.3 percent of this 6 state's learners; and

7 Whereas talented and gifted children are in all socioeconomic groups, all races and all 8 ethnicities and are in every school in this state; and

9 Whereas services for talented and gifted children are instrumental in helping this state meet its 10 40-40-20 goal; and

11 Whereas inconsistent attention to the needs of talented and gifted children has resulted in lim-12 iting talented and gifted children's access to challenging learning opportunities; and

Whereas the federal government does not provide any funding for talented and gifted education;and

15 Whereas this state has not funded talented and gifted education in school districts since 2004; 16 and

17 Whereas Oregon mandates that school districts identify talented and gifted children and provide

18 services to talented and gifted children, but does not provide any direct funding to school districts

19 to implement those mandates; and

20 Whereas this state has quietly failed its talented and gifted children; now, therefore,

Be It Enacted by the People of the State of Oregon: 1 2 SECTION 1. Section 2 of this 2013 Act is added to and made a part of ORS 343.391 to 343.413. 3 SECTION 2. (1) The Department of Education shall develop a uniform statewide plan for 4 the education of talented and gifted children. $\mathbf{5}$ (2) The plan developed as provided by subsection (1) of this section shall establish re-6 quirements for: 7 (a) Assessments to identify students who may be talented and gifted children; 8 9 (b) The delivery of services to talented and gifted children; (c) Curriculum and instruction for talented and gifted children that may be adapted to 10 match a child's varied and diverse needs; 11 12(d) Professional development to assist teachers to: 13 (A) Identify talented and gifted children; (B) Provide services to talented and gifted children; 14 (C) Develop curriculum and provide instruction for talented and gifted children; 15 (D) Address special needs of talented and gifted children from different socioeconomic, 16 racial and cultural backgrounds; 1718 (E) Improve teacher proficiencies in teaching talented and gifted children; and (F) Meet any specialty certification requirements for teaching talented and gifted chil-19 dren that may be established by the Teacher Standards and Practices Commission; and 20(e) Improving the involvement of family and communities in the education of talented 2122and gifted children. 23(3) The plan developed as provided by subsection (1) of this section shall be a guide by which school districts shall align their practices for educating talented and gifted children. 24A school district must align its practices for educating talented and gifted children with the 25plan to receive funding for talented and gifted education. 2627SECTION 3. (8) The total amount of the State School Fund that is distributed as facility grants may not exceed \$25 million in any biennium. If the total amount to be distributed as facility grants exceeds this limitation, the Department of Education shall prorate the amount of funds available for facility grants among those school districts that qualified for a facility grant.

(9) Each fiscal year, the Department of Education shall transfer the amount of \$18 million from
the State School Fund to the High Cost Disabilities Account established in ORS 327.348.

(10) Each fiscal year, the Department of Education may expend up to \$550,000 from the State School Fund for the contract described in ORS 329.488. The amount distributed to education service districts from the State School Fund under this section and ORS 327.019 shall be reduced by the amount expended by the department under this subsection.

(11) Each biennium, the Department of Education may expend up to [\$350,000] \$1,350,000 from
the State School Fund to provide administration of and support for [the development of] talented and
gifted education under ORS 343.404.

(12) Each biennium, the Department of Education may expend up to \$150,000 from the State
School Fund for the administration of a program to increase the number of speech-language
pathologists and speech-language pathology assistants under ORS 348.394 to 348.406.

(3) There shall be apportioned from the State School Fund to each education service district a

If the total amount to be distributed as facility grants exceeds this limitation, the Department of Education shall prorate the amount of funds available for facility grants among those school districts that qualified for a facility grant.

(9) Each fiscal year, the Department of Education shall transfer the amount of \$18 million from
the State School Fund to the High Cost Disabilities Account established in ORS 327.348.

(10) Each fiscal year, the Department of Education may expend up to \$550,000 from the State School Fund for the contract described in ORS 329.488. The amount distributed to education service districts from the State School Fund under this section and ORS 327.019 shall be reduced by the amount expended by the department under this subsection.

(11) Each biennium, the Department of Education may expend up to [\$1,350,000] \$5,850,000 from
the State School Fund to provide administration of and support for talented and gifted education
under ORS 343.404.

(12) Each biennium, the Department of Education may expend up to \$150,000 from the State
 School Fund for the administration of a program to increase the number of speech-language
 pathologists and speech-language pathology assistants under ORS 348.394 to 348.406.

33 <u>SECTION 12.</u> (1) The amendments to ORS 327.008 by section 11 of this 2013 Act become 34 operative on July 1, 2016.

(2) The amendments to ORS 327.008 by section 11 of this 2013 Act apply to State School
 Fund distributions commencing with the 2016-2017 distributions.

37 <u>SECTION 13.</u> In addition to and not in lieu of any other appropriation, there is appro-38 priated to the Department of Education, for the biennium beginning July 1, 2013, out of the 39 General Fund, the amount of \$1,000,000, which may be expended as follows:

40 (1) \$500,000 for the development of the uniform statewide plan described in section 2 of
41 this 2013 Act.

42 (2) \$500,000 to assist school districts to develop district plans that align with the uniform
43 statewide plan described in section 2 of this 2013 Act.

44 <u>SECTION 14.</u> This 2013 Act being necessary for the immediate preservation of the public 45 peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect
