# Senate Bill 358

Sponsored by Senator GEORGE (Presession filed.)

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Directs Joint Legislative Audit Committee to select Legislative Auditor to serve as director of Government Accountability Office. Authorizes Legislative Auditor to conduct performance and management audits of state agencies and programs and other state-funded programs. Modifies membership of Joint Legislative Audit Committee. Declares emergency, effective on passage.

4	Be It Enacted by the People of the State of Oregon:

6	LEGISLATIVE AUDITOR
7	
8	SECTION 1. As used in sections 1 to 6 of this 2013 Act:
9	(1) "Committee" means the Joint Legislative Audit Committee.
10	(2) "State agency" has the meaning given that term in ORS 291.272.
11	SECTION 2. (1) The Joint Legislative Audit Committee shall select a Legislative Auditor,
12	who shall serve as the director of the Government Accountability Office. The Legislative
13	Auditor shall serve at the pleasure of the committee and under the committee's direction.
14	(2) A person selected as Legislative Auditor must have a degree from an accredited col-
15	lege or university with a major in accounting or an allied field and have at least two years'
16	experience in the field of governmental accounting and auditing.
17	(3) Pursuant to the policies and directions of the committee, the Legislative Auditor shall
18	conduct performance and management audits of state agencies and programs and other
19	state-funded programs. During sessions of the Legislative Assembly, the Government Ac-
20	countability Office shall assist members and committees in gathering and analyzing infor-
21	mation relating to the performance and management of state agencies.
22	(4) Pursuant to the policies and directions of the committee, the Legislative Auditor may
23	enter into contracts to carry out the functions of the Government Accountability Office.
24	SECTION 3. (1) Subject to the approval of the Joint Legislative Audit Committee, the
25	Legislative Auditor may employ and fix the compensation of such professional assistants and
26	clerical and other employees as the Legislative Auditor finds necessary for the operation of
27	the Government Accountability Office.
28	(2) The committee shall fix the salary of the Legislative Auditor.
29	(3) Subject to the limitations otherwise provided by law for expenses of state officers, the
30	Legislative Auditor and employees of the Government Accountability Office shall be reim-

1 bursed for all actual and necessary expenses incurred in performing their duties.

2 <u>SECTION 4.</u> (1) Every biennium, the Legislative Auditor shall conduct audits of at least 3 two state agencies identified by the Joint Legislative Audit Committee. One of the state 4 agencies shall be a large agency, and one of the state agencies shall be a small agency, as 5 described by committee rules.

6 (2) The committee may not audit a state agency more than once every four years, unless 7 the committee approves a special audit under subsection (3) of this section.

(3) The committee may require the Legislative Auditor to conduct a special audit at any
time that the committee determines that circumstances exist that require the audit.

10 (4) The Legislative Auditor shall make a written report on each audit conducted by the 11 Legislative Auditor. The Legislative Auditor shall provide a copy of the report to the audited 12 state agency, to the Oregon Department of Administrative Services and to each member of 13 the committee. The report may include comments and recommendations. If the report con-14 tains recommendations that have a fiscal impact, the Legislative Auditor shall provide an 15 estimate of the fiscal impact.

(5) If at any time the Legislative Auditor has reason to believe that an officer or employee of a state agency has engaged in malfeasance, has failed to perform required duties or has violated a law, the Legislative Auditor shall immediately give written notice to the Attorney General, to the Governor and to each member of the committee and shall provide the Attorney General with all information that the Legislative Auditor has relating to the matter.

**SECTION 5.** (1) In conducting an audit under sections 1 to 6 of this 2013 Act:

(a) The Legislative Auditor may examine and inspect all accounts, books, records, files,
 papers and documents of any public body as defined in ORS 174.109.

(b) The Legislative Auditor may cause a search to be made of and extracts to be taken from any account, book, record, file, paper or document in the custody of any public officer without paying any fee for the search or extract. Any public officer having the custody of the account, book, record, file, paper or document shall make any search requested by the Legislative Auditor and furnish the extracts as requested.

(c) The Legislative Auditor may issue subpoenas compelling at a specified time and place
 the appearance and sworn testimony of any person whom the Legislative Auditor reasonably
 believes may be able to provide information relating to any audit or other investigation being
 undertaken under this section.

(d) The Legislative Auditor may issue subpoenas duces tecum compelling the production
of any account, book, record, file, paper, document or other evidence that the Legislative
Auditor reasonably believes may relate to an audit or other investigation being undertaken
under this section.

(2) If a person fails to comply with any subpoena issued under subsection (1) of this
 section, a judge of the circuit court of any county, on application of the Legislative Auditor,
 shall compel obedience by proceedings for contempt as in the case of disobedience of the
 requirements of a subpoena issued from the circuit court.

(2) Not more than three of the appointees made from each chamber of the Legislative
 Assembly may be from the same political party.

14 [(2)] (3) The committee has a continuing existence and may meet, act and conduct its business 15 during sessions of the Legislative Assembly or any recess thereof and in the interim between ses-16 sions.

[(3)] (4) The term of a member shall expire upon the date of the convening of the odd-numbered year regular session of the Legislative Assembly next following the commencement of the member's term. When a vacancy occurs in the membership of the committee in the interim between oddnumbered year regular sessions, until such vacancy is filled, the membership of the committee shall be considered not to include the vacant position for the purpose of determining whether a quorum is present and a quorum is a majority of the remaining members.

[(4)] (5) Members of the committee shall receive an amount equal to that authorized under ORS 171.072 from funds appropriated to the Legislative Assembly for each day spent in the performance of their duties as members of the committee or any subcommittee thereof in lieu of reimbursement for in-state travel expenses. However, when engaged in out-of-state travel, members shall be entitled to receive their actual and necessary expenses therefor in lieu of the amount authorized by this subsection. Payment shall be made from funds appropriated to the [Legislative Assembly] Government Accountability Office.

[(5)] (6) The committee may not transact business unless a quorum is present. A quorum consists
 of a majority of committee members from the House of Representatives and a majority of committee
 members from the Senate.

[(6)] (7) Action by the committee requires the affirmative vote of a majority of committee mem bers from the House of Representatives and a majority of committee members from the Senate.

[(7)] (8) The [Legislative Fiscal Office] Government Accountability Office shall furnish to the committee such services of personnel and such other facilities as are necessary to enable the committee to carry out its functions as directed by law, with such assistance as the Division of Audits and Oregon Department of Administrative Services can provide.
