

Senate Bill 426

Sponsored by Senator PROZANSKI (at the request of Kristie Kilcullen and John Kilcullen) (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Increases from 180 days to two years maximum period of indefinite commitment of persons who lack capacity to stand trial due to mental illness and have been charged with certain crimes. Updates terminology.

10 **Be It Enacted by the People of the State of Oregon:**

11 12 INCREASE IN MAXIMUM TERM OF INDEFINITE COMMITMENT 13 OF PERSON WITH MENTAL ILLNESS CHARGED WITH CERTAIN CRIMES 14

15 **SECTION 1.** ORS 426.307 is amended to read:

16 426.307. If *[the]* a person **with mental illness** requests a hearing under ORS 426.301 or if the
17 court proceeds under ORS 426.275 (5), the following provisions apply *[as described]*:

18 (1) The hearing shall be conducted as promptly as possible and at a time and place as the court
19 may direct.

20 (2) If the person requests a continuance in order to prepare for the hearing or to obtain legal
21 counsel to represent the person, the court may grant postponement and detention during
22 postponement as provided under ORS 426.095.

23 (3) The person has the right to representation by or appointment of counsel as provided under
24 ORS 426.100 subject to ORS 135.055, 151.216 and 151.219.

25 (4) If the person requests an examination by a physician or other qualified *[person]* **professional**
26 as recommended by the Oregon Health Authority and is without funds to retain a physician or other
27 qualified *[person]* **professional** for purposes of the examination, the court shall appoint a physician
28 or other qualified *[person]* **professional**, other than a member of the staff from the facility where
29 the person is confined, to examine the person at no expense to the person and to report to the court
30 the results of the examination.

31 (5) The provisions of ORS 40.230, 40.235, 40.240 and 40.250 do not apply to the use of medical

1 records from the current period of commitment or to testimony related to such records or period
 2 of commitment in connection with hearings under this section. The court may consider as evidence
 3 such reports and testimony.

4 (6) The court shall then conduct a hearing and after hearing the evidence and reviewing the
 5 recommendations of the treating and examining physicians or other qualified *[persons]*
 6 **professionals**, the court shall determine whether the person is still a *[mentally ill person]* **person**
 7 **with mental illness** and **is** in need of further treatment. If in the opinion of the court the individual
 8 is still a *[mentally ill person]* **person with mental illness** by clear and convincing evidence and **is**
 9 in need of further treatment, the court may order commitment to the authority for an additional
 10 indefinite period of time up to 180 days **or, for a person committed pursuant to ORS 161.370**
 11 **who was charged with a crime other than a crime listed in ORS 137.700, up to two years.**

12 (7) At the end of the *[180-day]* period **specified in subsection (6) of this section**, the person
 13 shall be released unless the authority or facility again certifies to the committing court that the
 14 person is still a *[mentally ill]* person **with mental illness** and **is** in need of further treatment, in
 15 which event the procedures set forth in ORS 426.301 to 426.307 shall be followed.

16 **SECTION 2.** ORS 161.370 is amended to read:

17 161.370. (1) When the defendant's fitness to proceed is drawn in question, the issue shall be de-
 18 termined by the court. If neither the prosecuting attorney nor counsel for the defendant contests the
 19 finding of the report filed under ORS 161.365, the court may make the determination on the basis
 20 of the report. If the finding is contested, the court shall hold a hearing on the issue. If the report
 21 is received in evidence in the hearing, the party who contests the finding has the right to summon
 22 and to cross-examine any psychiatrist or psychologist who submitted the report and to offer evidence
 23 upon the issue. Other evidence regarding the defendant's fitness to proceed may be introduced by
 24 either party.

25 (2) If the court determines that the defendant lacks fitness to proceed, the criminal proceeding
 26 against the defendant shall be suspended and:

27 (a) If the court finds that the defendant is dangerous to self or others as a result of mental
 28 disease or defect, or that the services and supervision necessary to restore the defendant's fitness
 29 to proceed are not available in the community, the court shall commit the defendant to the custody
 30 of the superintendent of a state mental hospital or director of a facility, designated by the Oregon
 31 Health Authority, if the defendant is at least 18 years of age, or to the custody of the director of
 32 a secure intensive community inpatient facility designated by the authority if the defendant is under
 33 18 years of age; or

34 (b) If the court does not make a finding described in paragraph (a) of this subsection, or if the
 35 court determines that care other than commitment for incapacity to stand trial would better serve
 36 the defendant and the community, the court shall release the defendant on supervision for as long
 37 as the unfitness endures.

38 (3) When a defendant is released on supervision under this section, the court may place condi-
 39 tions that the court deems appropriate on the release, including the requirement that the defendant
 40 regularly report to the authority or a community mental health program for examination to deter-
 41 mine if the defendant has regained capacity to stand trial.

42 (4) When the court, on its own motion or upon the application of the superintendent of the
 43 hospital or director of the facility in which the defendant is committed, a person examining the de-
 44 fendant as a condition of release on supervision, or either party, determines, after a hearing, if a
 45 hearing is requested, that the defendant has regained fitness to proceed, the criminal proceeding

1 shall be resumed. If, however, the court is of the view that so much time has elapsed since the
2 commitment or release of the defendant on supervision that it would be unjust to resume the crim-
3 inal proceeding, the court on motion of either party may dismiss the charge and may order the de-
4 fendant to be discharged or cause a proceeding to be commenced forthwith under ORS 426.070 to
5 426.170 or 427.235 to 427.290.

6 (5) The superintendent of a state hospital or director of a facility to which the defendant is
7 committed shall cause the defendant to be evaluated within 60 days from the defendant's delivery
8 into the superintendent's or director's custody, for the purpose of determining whether there is a
9 substantial probability that, in the foreseeable future, the defendant will have the capacity to stand
10 trial. In addition, the superintendent or director shall:

11 (a) Immediately notify the committing court if the defendant, at any time, gains or regains the
12 capacity to stand trial or will never have the capacity to stand trial.

13 (b) Within 90 days of the defendant's delivery into the superintendent's or director's custody,
14 notify the committing court that:

15 (A) The defendant has the present capacity to stand trial;

16 (B) There is no substantial probability that, in the foreseeable future, the defendant will gain
17 or regain the capacity to stand trial; or

18 (C) There is a substantial probability that, in the foreseeable future, the defendant will gain or
19 regain the capacity to stand trial. If the probability exists, the superintendent or director shall give
20 the court an estimate of the time in which the defendant, with appropriate treatment, is expected
21 to gain or regain capacity.

22 (6)(a) If the superintendent or director determines that there is a substantial probability that,
23 in the foreseeable future, the defendant will gain or regain the capacity to stand trial, unless the
24 court otherwise orders, the defendant shall remain in the superintendent's or director's custody
25 where the defendant shall receive treatment designed for the purpose of enabling the defendant to
26 gain or regain capacity. In keeping with the notice requirement under subsection (5)(b) of this sec-
27 tion, the superintendent or director shall, for the duration of the defendant's period of commitment,
28 submit a progress report to the committing court, concerning the defendant's capacity or incapacity,
29 at least once every [180 days] **two years** as measured from the date of the defendant's delivery into
30 the superintendent's or director's custody.

31 (b) Notwithstanding paragraph (a) of this subsection, if the superintendent or director deter-
32 mines that a defendant committed under this section is no longer dangerous to self or others as a
33 result of mental disease or defect, or that the services and supervision necessary to restore the
34 defendant's fitness to proceed are available in the community, the superintendent or director shall
35 file notice of that determination with the court. Upon receipt of the notice, the court shall order
36 the person released on supervision as described in subsection (3) of this section.

37 (7)(a) A defendant who remains committed under subsection (6) of this section shall be dis-
38 charged within a period of time that is reasonable for making a determination concerning whether
39 or not, and when, the defendant may gain or regain capacity. However, regardless of the number
40 of charges with which the defendant is accused, in no event shall the defendant be committed for
41 longer than whichever of the following, measured from the defendant's initial custody date, is
42 shorter:

43 (A) Three years; or

44 (B) A period of time equal to the maximum sentence the court could have imposed if the de-
45 fendant had been convicted.

1 (b) For purposes of calculating the maximum period of commitment described in paragraph (a)
 2 of this subsection:

3 (A) The initial custody date is the date on which the defendant is first committed under this
 4 section on any charge alleged in the accusatory instrument; and

5 (B) The defendant shall be given credit against each charge alleged in the accusatory instrument
 6 for each day the defendant is committed under this section, whether the days are consecutive or are
 7 interrupted by a period of time during which the defendant has regained fitness to proceed.

8 (8) The superintendent or director shall notify the committing court of the defendant's impending
 9 discharge 30 days before the date on which the superintendent or director is required to discharge
 10 the defendant under subsection (7) of this section.

11 (9) When the committing court receives a notice from the superintendent or director under
 12 subsection (5) or (8) of this section concerning the defendant's progress or lack thereof, the com-
 13 mitting court shall determine, after a hearing, if a hearing is requested, whether the defendant
 14 presently has the capacity to stand trial.

15 (10) If at any time the court determines that the defendant lacks the capacity to stand trial, the
 16 court shall further determine whether there is a substantial probability that the defendant, in the
 17 foreseeable future, will gain or regain the capacity to stand trial and whether the defendant is en-
 18 titled to discharge under subsection (7) of this section. If the court determines that there is no
 19 substantial probability that the defendant, in the foreseeable future, will gain or regain the capacity
 20 to stand trial or that the defendant is entitled to discharge under subsection (7) of this section, the
 21 court shall dismiss, without prejudice, all charges against the defendant and:

22 (a) Order that the defendant be discharged; or

23 (b) Initiate commitment proceedings under ORS 426.070 or 427.235 to 427.290.

24 (11) All notices required under this section shall be filed with the clerk of the court and deliv-
 25 ered to both the district attorney and the counsel for the defendant.

26 (12) If the defendant regains fitness to proceed, the term of any sentence received by the de-
 27 fendant for conviction of the crime charged shall be reduced by the amount of time the defendant
 28 was committed under this section to the custody of a state mental hospital, or to the custody of a
 29 secure intensive community inpatient facility, designated by the Oregon Health Authority.

30 (13) Notwithstanding the suspension of the criminal proceeding under subsection (2) of this
 31 section, the fact that the defendant is unfit to proceed does not preclude any objection through
 32 counsel and without the personal participation of the defendant on the grounds that the indictment
 33 is insufficient, that the statute of limitations has run, that double jeopardy principles apply or upon
 34 any other ground at the discretion of the court which the court deems susceptible of fair determi-
 35 nation prior to trial.

 39 **SECTION 3.** ORS 21.010 is amended to read:

40 21.010. (1) Except as provided in this section, the appellant in an appeal or the petitioner in a
 41 judicial review in the Supreme Court or the Court of Appeals shall pay a filing fee of \$355 in the
 42 manner prescribed by ORS 19.265. The respondent in such case and any other person appearing in
 43 the appeal, upon entering first appearance or filing first brief in the court, shall pay to the State
 44 Court Administrator a filing fee of \$355. The party entitled to costs and disbursements on such ap-
 45 peal shall recover from the opponent the amount so paid.

(2) Filing and appearance fees may not be assessed in appeals from habeas corpus proceedings under ORS 34.710, post-conviction relief proceedings under ORS 138.650, juvenile court under ORS 419A.200, the involuntary commitment of persons determined to be *mentally ill* **persons with mental illness** under ORS 426.135 or persons determined to have an intellectual disability under ORS 427.295 or orders of the State Board of Parole and Post-Prison Supervision or on judicial review of orders entered under ORS 161.315 to 161.351 by the Psychiatric Security Review Board or the Oregon Health Authority.

(3) Filing and appearance fees shall be assessed in an appeal from an appeal to a circuit court from a justice court or municipal court in an action alleging commission of a state offense designated as a violation or an action alleging violation of a city charter or ordinance, but not in an action alleging commission of a state crime.

(4) Filing and appearance fees shall only be assessed in an appeal in a contempt proceeding seeking imposition of remedial sanctions under the provisions of ORS 33.055.

(5) The filing and appearance fees established by this section apply to cases of original jurisdiction in the Supreme Court.

SECTION 4. ORS 109.322 is amended to read:

109.322. (1) If a parent has been adjudged *mentally ill or mentally retarded* **to be a person with mental illness under ORS 426.130 or a person with an intellectual disability who is in need of commitment for residential care, treatment and training under ORS 427.290**, and remains so at the time of the adoption proceedings, or if a parent is imprisoned in a state or federal prison under a sentence for a term of not less than three years and has actually served three years, the petitioner, in accordance with ORS 109.330, shall serve on the parent, if the parent has not consented in writing to the adoption, a summons and a motion and order to show cause why the adoption of the child should not be ordered without the parent’s consent.

(2) In the case of a parent adjudged *mentally ill or mentally retarded* **to be a person with mental illness under ORS 426.130 or a person with an intellectual disability who is in need of commitment for residential care, treatment and training under ORS 427.290**, the petitioner shall also serve the summons and the motion and order to show cause upon the guardian of the parent. If the parent has no guardian, the court shall appoint a guardian ad litem to appear for the parent in the adoption proceedings.

(3) Upon hearing, if the court finds that the adoption is in the best interests of the child, the consent of the parent who is imprisoned or adjudged *mentally ill or mentally retarded* **to be a person with mental illness or an intellectual disability** is not required, and the court may proceed regardless of the objection of the parent.

(4) This section does not apply when consent is given in loco parentis under ORS 109.316 or 109.318.

SECTION 5. ORS 135.775 is amended to read:

135.775. The Agreement on Detainers is hereby enacted into law and entered into by this state with all other jurisdictions legally joining therein in the form substantially as follows:

AGREEMENT ON DETAINERS

The contracting states solemnly agree that:

ARTICLE I

The party states find that charges outstanding against a prisoner, detainees based on untried

1 indictments, informations or complaints, and difficulties in securing speedy trial of persons already
2 incarcerated in other jurisdictions, produce uncertainties which obstruct programs of prisoner
3 treatment and rehabilitation. Accordingly, it is the policy of the party states and the purpose of this
4 agreement to encourage the expeditious and orderly disposition of such charges and determination
5 of the proper status of any and all detainees based on untried indictments, informations or com-
6 plaints. The party states also find that proceedings with reference to such charges and detainees,
7 when emanating from another jurisdiction, cannot properly be had in the absence of cooperative
8 procedures. It is the further purpose of this agreement to provide such cooperative procedures.

9 ARTICLE II

10 As used in this agreement:

11 (a) "State" shall mean a state of the United States; the United States of America; a territory
12 or possession of the United States; the District of Columbia; the Commonwealth of Puerto Rico.

13 (b) "Sending state" shall mean a state in which a prisoner is incarcerated at the time that the
14 prisoner initiates a request for final disposition pursuant to Article III of this agreement or at the
15 time that a request for custody or availability is initiated pursuant to Article IV of this agreement.

16 (c) "Receiving state" shall mean the state in which trial is to be had on an indictment, infor-
17 mation or complaint pursuant to Article III or Article IV of this agreement.

18 (d) "Department of Corrections institution" of this state shall mean any institution operated by
19 the Department of Corrections.

20 ARTICLE III

21 (a) Whenever a person has entered upon a term of imprisonment in a penal or correctional in-
22 stitution of a party state, and whenever during the continuance of the term of imprisonment there
23 is pending in any other party state any untried indictment, information or complaint on the basis
24 of which a detainer has been lodged against the prisoner, the prisoner shall be brought to trial
25 within 180 days after the prisoner shall have caused to be delivered to the prosecuting officer and
26 the appropriate court of the prosecuting officer's jurisdiction written notice of the place of
27 imprisonment and the request of the prisoner for a final disposition to be made of the indictment,
28 information or complaint: Provided, that for good cause shown in open court, the prisoner or the
29 counsel of the prisoner being present, the court having jurisdiction of the matter may grant any
30 necessary or reasonable continuance. The request of the prisoner shall be accompanied by a certif-
31 icate of the appropriate official having custody of the prisoner, stating the term of commitment un-
32 der which the prisoner is being held, the time already served, the time remaining to be served on
33 the sentence, the amount of good time earned, the time of parole eligibility of the prisoner, and any
34 decisions of the state parole agency relating to the prisoner.

35 (b) The written notice and request for final disposition referred to in paragraph (a) of this Ar-
36 ticle shall be given or sent by the prisoner to the warden or other official having custody of the
37 prisoner, who shall promptly forward it together with the certificate to the prosecuting official and
38 court by registered or certified mail, return receipt requested.

39 (c) The warden or other official having custody of the prisoner shall promptly inform the pris-
40 oner of the source and contents of any detainer lodged against the prisoner and shall also inform
41 the prisoner of the right to make a request for final disposition of the indictment, information or
42 complaint on which the detainer is based.

43 (d) Any request for final disposition made by a prisoner pursuant to paragraph (a) of this Article
44 shall operate as a request for final disposition of all untried indictments, informations or complaints
45 on the basis of which detainees have been lodged against the prisoner from the state to whose

1 prosecuting official the request for final disposition is specifically directed. The warden or other
2 official having custody of the prisoner shall forthwith notify all appropriate prosecuting officers and
3 courts in the several jurisdictions within the state to which the prisoner's request for final disposi-
4 tion is being sent of the proceeding being initiated by the prisoner. Any notification sent pursuant
5 to this paragraph shall be accompanied by copies of the prisoner's written notice, request and the
6 certificate. If trial is not had on any indictment, information or complaint contemplated hereby prior
7 to the return of the prisoner to the original place of imprisonment, such indictment, information or
8 complaint shall not be of any further force or effect, and the court shall enter an order dismissing
9 the same with prejudice.

10 (e) Any request for final disposition made by a prisoner pursuant to paragraph (a) of this Article
11 shall also be deemed to be a waiver of extradition with respect to any charge or proceeding con-
12 templated thereby or included therein by reason of paragraph (d) of this Article, and a waiver of
13 extradition to the receiving state to serve any sentence there imposed upon the prisoner, after
14 completion of the term of imprisonment in the sending state. The request for final disposition shall
15 also constitute a consent by the prisoner to the production of the body of the prisoner in any court
16 where the presence of the prisoner may be required in order to effectuate the purposes of this
17 agreement and a further consent voluntarily to be returned to the original place of imprisonment in
18 accordance with the provisions of this agreement. Nothing in this paragraph shall prevent the im-
19 position of a concurrent sentence if otherwise permitted by law.

20 (f) Escape from custody by the prisoner subsequent to the execution of the request for final
21 disposition referred to in paragraph (a) of this Article shall void the request.

22 ARTICLE IV

23 (a) The appropriate officer of the jurisdiction in which an untried indictment, information or
24 complaint is pending shall be entitled to have a prisoner against whom the officer has lodged a
25 detainer and who is serving a term of imprisonment in any party state made available in accordance
26 with paragraph (a) of Article V of this agreement upon presentation of a written request for tem-
27 porary custody or availability to the appropriate authorities of the state in which the prisoner is
28 incarcerated: Provided, that the court having jurisdiction of such indictment, information or com-
29 plaint shall have duly approved, recorded and transmitted the request; And provided further, that
30 there shall be a period of 30 days after receipt by the appropriate authorities before the request be
31 honored, within which period the governor of the sending state may disapprove the request for
32 temporary custody or availability, either upon the own motion of the governor or upon motion of
33 the prisoner.

34 (b) Upon receipt of the officer's written request as provided in paragraph (a) of this Article, the
35 appropriate authorities having the prisoner in custody shall furnish the officer with a certificate
36 stating the term of commitment under which the prisoner is being held, the time already served, the
37 time remaining to be served on the sentence, the amount of good time earned, the time of parole
38 eligibility of the prisoner and any decisions of the state parole agency relating to the prisoner. Such
39 authorities simultaneously shall furnish all other officers and appropriate courts in the receiving
40 state who have lodged detainers against the prisoner with similar certificates and with notices in-
41 forming them of the request for custody or availability and of the reasons therefor.

42 (c) In respect of any proceeding made possible by this Article, trial shall be commenced within
43 120 days of the arrival of the prisoner in the receiving state, but for good cause shown in open
44 court, the prisoner or the counsel of the prisoner being present, the court having jurisdiction of the
45 matter may grant any necessary or reasonable continuance.

1 (d) Nothing contained in this Article shall be construed to deprive any prisoner of any right
2 which the prisoner may have to contest the legality of the delivery of the prisoner as provided in
3 paragraph (a) of this Article, but such delivery may not be opposed or denied on the ground that the
4 executive authority of the sending state has not affirmatively consented to or ordered such delivery.

5 (e) If trial is not had on any indictment, information or complaint contemplated hereby prior to
6 the prisoner's being returned to the original place of imprisonment pursuant to paragraph (e) of
7 Article V of this agreement, such indictment, information or complaint shall not be of any further
8 force or effect, and the court shall enter an order dismissing the same with prejudice.

9 ARTICLE V

10 (a) In response to a request made under Article III or Article IV of this agreement, the appro-
11 priate authority in a sending state shall offer to deliver temporary custody of such prisoner to the
12 appropriate authority in the state where such indictment, information or complaint is pending
13 against such person in order that speedy and efficient prosecution may be had. If the request for
14 final disposition is made by the prisoner, the offer of temporary custody shall accompany the written
15 notice provided for in Article III of this agreement. In the case of a federal prisoner, the appropriate
16 authority in the receiving state shall be entitled to temporary custody as provided by this agreement
17 or to the prisoner's presence in federal custody at the place for trial, whichever custodial arrange-
18 ment may be approved by the custodian.

19 (b) The officer or other representative of a state accepting an offer of temporary custody shall
20 present the following upon demand:

21 (1) Proper identification and evidence of authority to act for the state into whose temporary
22 custody the prisoner is to be given.

23 (2) A duly certified copy of the indictment, information or complaint on the basis of which the
24 detainer has been lodged and on the basis of which the request for temporary custody of the pris-
25 oner has been made.

26 (c) If the appropriate authority shall refuse or fail to accept temporary custody of such prisoner,
27 or in the event that an action on the indictment, information or complaint on the basis of which the
28 detainer has been lodged is not brought to trial within the period provided in Article III or Article
29 IV of this agreement, the appropriate court of the jurisdiction where the indictment, information or
30 complaint has been pending shall enter an order dismissing the same with prejudice, and any
31 detainer based thereon shall cease to be of any force or effect.

32 (d) The temporary custody referred to in this agreement shall be only for the purpose of per-
33 mitting prosecution on the charge or charges contained in one or more untried indictments, infor-
34 mations or complaints which form the basis of the detainer or detainers or for prosecution on any
35 other charge or charges arising out of the same transaction. Except for attendance of the prisoner
36 at court and while being transported to or from any place at which the presence of the prisoner
37 may be required, the prisoner shall be held in a suitable jail or other facility regularly used for
38 persons awaiting prosecution.

39 (e) At the earliest practicable time consonant with the purposes of this agreement, the prisoner
40 shall be returned to the sending state.

41 (f) During the continuance of temporary custody or while the prisoner is otherwise being made
42 available for trial as required by this agreement, time being served on the sentence shall continue
43 to run but good time shall be earned by the prisoner only if, and to the extent that, the law and
44 practice of the jurisdiction which imposed the sentence may allow.

45 (g) For all purposes other than that for which temporary custody as provided in this agreement

1 is exercised, the prisoner shall be deemed to remain in the custody of and subject to the jurisdiction
 2 of the sending state and any escape from temporary custody may be dealt with in the same manner
 3 as an escape from the original place of imprisonment or in any other manner permitted by law.

4 (h) From the time that a party state receives custody of a prisoner pursuant to this agreement

30 mental health program director does not make the request [*authorized by this paragraph*], the phy-
31 sician shall notify, immediately and in writing, the circuit court in the county in which the person
32 was taken into custody.

33 (c) If, at any time prior to the hearing under ORS 426.070 to 426.130, the physician responsible
34 for a person admitted or retained under ORS 426.232 determines that the person is not dangerous
35 to self or [*others*] **to any other person** and is not in need of emergency care or treatment for mental
36 illness, the physician may release the person from the detention authorized by ORS 426.232. The
37 physician shall immediately notify the circuit court notified under this subsection and the commu-
38 nity mental health program director of the person's release from detention.

39 (3)(a) At the time the person is admitted to or retained in a nonhospital facility under ORS

 5 United States, the District of Columbia and the Commonwealth of Puerto Rico joining therein, in the
 6 form substantially as follows:

 9 The contracting states solemnly agree that:

10 ARTICLE I

11 The party states find that the proper and expeditious treatment of [*the mentally ill and mentally*
 12 *deficient*] **persons with mental illness or intellectual disabilities** can be facilitated by cooperative
 13 action, to the benefit of the patients, their families, and society as a whole. Further, the party states
 14 find that the necessity of and desirability for furnishing such care and treatment bears no primary
 15 relation to the residence or citizenship of the patient but that, on the contrary, the controlling fac-
 16 tors of community safety and humanitarianism require that facilities and services be made available
 17 for all who are in need of them. Consequently, it is the purpose of this compact and of the party
 18 states to provide the necessary legal basis for the institutionalization or other appropriate care and
 19 treatment of [*the mentally ill and mentally deficient*] **persons with mental illness or intellectual**
 20 **disabilities** under a system that recognizes the paramount importance of patient welfare and to es-
 21 tablish the responsibilities of the party states in terms of such welfare.

22 ARTICLE II

23 As used in this compact:

24 (a) "Sending state" shall mean a party state from which a patient is transported pursuant to the
 25 provisions of the compact or from which it is contemplated that a patient may be so sent.

26 (b) "Receiving state" shall mean a party state to which a patient is transported pursuant to the
 27 provisions of the compact or to which it is contemplated that a patient may be so sent.

28 (c) "Institution" shall mean any hospital or other facility maintained by a party state or political
 29 subdivision thereof for the care and treatment of mental illness or [*mental deficiency*] **intellectual**
 30 **disabilities**.

31 (d) "Patient" shall mean any person subject to or eligible as determined by the laws of the
 32 sending state, for institutionalization or other care, treatment or supervision pursuant to the pro-
 33 visions of this compact.

34 (e) "After-care" shall mean care, treatment and services provided a patient, as defined herein,
 35 on convalescent status or conditional release.

36 (f) "Mental illness" shall mean mental disease to such extent that a person so afflicted requires
 37 care and treatment for his own welfare, or the welfare of others, or of the community.

38 (g) [*Mental deficiency*] "**Intellectual disability**" shall mean [*mental deficiency*] **intellectual**
 39 **disability** as defined by appropriate clinical authorities to such extent that a person so afflicted is
 40 incapable of managing himself and his affairs, but shall not include mental illness as defined herein.

41 (h) "State" shall mean any state, territory or possession of the United States, the District of
 42 Columbia and the Commonwealth of Puerto Rico.

43 ARTICLE III

44 (a) Whenever a person physically present in any party state shall be in need of
 45 institutionalization by reason of mental illness or [*mental deficiency*] **intellectual disability**, the

1 person shall be eligible for care and treatment in an institution in that state irrespective of the
2 residence, settlement or citizenship qualifications of the person.

3 (b) The provisions of paragraph (a) of this article to the contrary notwithstanding, any patient
4 may be transferred to an institution in another state whenever there are factors based upon clinical
5 determinations indicating that the care and treatment of said patient would be facilitated or im-
6 proved thereby. Any such institutionalization may be for the entire period of care and treatment or
7 for any portion or portions thereof. The factors referred to in this paragraph shall include the
8 patient's full record with due regard for the location of the patient's family, character of the illness
9 and probable duration thereof, and such other factors as shall be considered appropriate.

10 (c) No state shall be obliged to receive any patient pursuant to the provisions of paragraph (b)
11 of this article unless the sending state has given advance notice of its intention to send the patient;
12 furnished all available medical and other pertinent records concerning the patient; given the quali-
13 fied medical or other appropriate clinical authorities of the receiving state an opportunity to ex-
14 amine the patient if said authorities so wish; and unless the receiving state shall agree to accept
15 the patient.

16 (d) In the event that the laws of the receiving state establish a system of priorities for the ad-
17 mission of patients, an interstate patient under this compact shall receive the same priority as a
18 local patient and shall be taken in the same order and at the same time that the patient would be
19 taken if the patient were a local patient.

20 (e) Pursuant to this compact, the determination as to the suitable place of institutionalization
21 for a patient may be reviewed at any time and such further transfer of the patient may be made as
22 seems likely to be in the best interest of the patient.

23 ARTICLE IV

24 (a) Whenever, pursuant to the laws of the state in which a patient is physically present, it shall
25 be determined that the patient should receive after-care or supervision, such care or supervision
26 may be provided in a receiving state. If the medical or other appropriate clinical authorities having
27 responsibility for the care and treatment of the patient in the sending state shall have reason to
28 believe that after-care in another state would be in the best interest of the patient and would not
29 jeopardize the public safety, they shall request the appropriate authorities in the receiving state to
30 investigate the desirability of affording the patient such after-care in said receiving state, and such
31 investigation shall be made with all reasonable speed. The request for investigation shall be ac-
32 companied by complete information concerning the patient's intended place of residence and the
33 identity of the person in whose charge it is proposed to place the patient, the complete medical
34 history of the patient, and such other documents as may be pertinent.

35 (b) If the medical or other appropriate clinical authorities having responsibility for the care and
36 treatment of the patient in the sending state and the appropriate authorities in the receiving state
37 find that the best interest of the patient would be served thereby, and if the public safety would not
38 be jeopardized thereby, the patient may receive after-care or supervision in the receiving state.

39 (c) In supervising, treating or caring for a patient on after-care pursuant to the terms of this
40 article, a receiving state shall employ the same standards of visitation, examination, care and
41 treatment that it employs for similar local patients.

42 ARTICLE V

43 Whenever a dangerous or potentially dangerous patient escapes from an institution in any party
44 state, that state shall promptly notify all appropriate authorities within and without the jurisdiction
45 of the escape in a manner reasonably calculated to facilitate the speedy apprehension of the escapee.

1 Immediately upon the apprehension and identification of any such dangerous or potentially danger-
 2 ous patient, the patient shall be detained in the state where found pending disposition in accordance
 3 with law.

4 ARTICLE VI

5 The duly accredited officers of any state party to this compact, upon the establishment of their
 6 authority and the identity of the patient, shall be permitted to transport any patient being moved
 7 pursuant to this compact through any and all states party to this compact, without interference.

8 ARTICLE VII

9 (a) No person shall be deemed a patient of more than one institution at any given time. Com-
 10 pletion of transfer of any patient to an institution in a receiving state shall have the effect of mak-
 11 ing the person a patient of the institution in the receiving state.

12 (b) The sending state shall pay all costs of and incidental to the transportation of any patient
 13 pursuant to this compact, but any two or more party states may, by making a specific agreement for
 14 that purpose, arrange for a different allocation of costs as among themselves.

15 (c) No provision of this compact shall be construed to alter or affect any internal relationships
 16 among the departments, agencies and officers of and in the government of a party state, or between
 17 a party state and its subdivisions, as to the payment of costs, or responsibilities therefor.

18 (d) Nothing in this compact shall be construed to prevent any party state or subdivision thereof
 19 from asserting any right against any person, agency or other entity in regard to costs for which
 20 such party state or subdivision thereof may be responsible pursuant to any provision of this com-
 21 pact.

22 (e) Nothing in this compact shall be construed to invalidate any reciprocal agreement between
 23 a party state and a nonparty state relating to institutionalization, care or treatment of [*the mentally*
 24 *ill or mentally deficient*] **persons with mental illness or intellectual disabilities**, or any statutory
 25 authority pursuant to which such agreements may be made.

26 ARTICLE VIII

27 (a) Nothing in this compact shall be construed to abridge, diminish, or in any way impair the
 28 rights, duties and responsibilities of any patient's guardian on the guardian's own behalf or in re-
 29 spect of any patient for whom the guardian may serve, except that where the transfer of any patient
 30 to another jurisdiction makes advisable the appointment of a supplemental or substitute guardian,
 31 any court of competent jurisdiction in the receiving state may make such supplemental or substitute
 32 appointment and the court which appointed the previous guardian shall upon being duly advised of
 33 the new appointment, and upon the satisfactory completion of such accounting and other acts as
 34 such court may by law require, relieve the previous guardian of power and responsibility to what-
 35 ever extent shall be appropriate in the circumstances; provided, however, that in the case of any
 36 patient having settlement in the sending state, the court of competent jurisdiction in the sending

45 (a) No provision of this compact except Article V shall apply to any person institutionalized

1 while under sentence in a penal or correctional institution or while subject to trial on a criminal
 2 charge, or whose institutionalization is due to the commission of an offense for which, in the absence
 3 of mental illness or [*mental deficiency*] **intellectual disability**, said person would be subject to
 4 incarceration in a penal or correctional institution.

5 (b) To every extent possible, it shall be the policy of states party to this compact that no patient
 6 shall be placed or detained in any prison, jail or lockup, but such patient shall, with all expedition,
 7 be taken to a suitable institutional facility for mental illness or [*mental deficiency*] **intellectual**

9 ARTICLE X

10 (a) Each party state shall appoint a “compact administrator” who, on behalf of the state of the
 11 compact administrator, shall act as general coordinator of activities under the compact in the state
 12 of the compact administrator and who shall receive copies of all reports, correspondence, and other
 13 documents relating to any patient processed under the compact by the state of the compact admin-
 14 istrator either in the capacity of sending or receiving state. The compact administrator or the duly
 15 designated representative of the compact administrator shall be the official with whom other party
 16 states shall deal in any matter relating to the compact or any patient processed thereunder.

17 (b) The compact administrators of the respective party states shall have power to promulgate
 18 reasonable rules and regulations to carry out more effectively the terms and provisions of this
 19 compact.

20 ARTICLE XI

21 The duly constituted administrative authorities of any two or more party states may enter into
 22 supplementary agreements for the provision of any service or facility or for the maintenance of any
 23 institution on a joint or cooperative basis whenever the states concerned shall find that such
 24 agreements will improve services, facilities, or institutional care and treatment in the fields of
 25 mental illness or [*mental deficiency*] **intellectual disability**. No such supplementary agreement shall
 26 be construed so as to relieve any party state of any obligation which it otherwise would have under

29 This compact shall enter into full force and effect as to any state when entered into according
 30 to law and such state shall thereafter be a party thereto with any and all states legally joining

33 (a) A state party to this compact may withdraw therefrom as provided by law and such
 34 renunciation shall be by the same authority which executed it. Such withdrawal shall take effect

The party states, desiring by common action to fully utilize and improve their institutional facilities and provide adequate programs for the confinement, treatment and rehabilitation of various types of offenders, declare that it is the policy of each of the party states to provide such facilities and programs on a basis of cooperation with one another, thereby serving the best interests of such offenders and of society and effecting economies in capital expenditures and operational costs. The purpose of this compact is to provide for the mutual development and execution of such programs of cooperation for the confinement, treatment and rehabilitation of offenders with the most economical use of human and material resources.

ARTICLE II

DEFINITIONS

As used in this compact, unless the context clearly requires otherwise:

(1) "State" means a state of the United States, the United States of America, a territory or possession of the United States, the District of Columbia, the Commonwealth of Puerto Rico.

(2) "Sending state" means a state party to this compact in which conviction or court commitment was had.

(3) "Receiving state" means a state party to this compact to which an inmate is sent for confinement other than a state in which conviction or court commitment was had.

(5) "Institution" means any penal or correctional facility, including but not limited to a facility for [*the mentally ill or mentally defective*] **persons with mental illness or intellectual disabilities**, in which inmates as defined in subsection (4) of this Article may lawfully be confined.

ARTICLE III

CONTRACTS

(1) Each party state may make one or more contracts with any one or more of the other party states for the confinement of inmates on behalf of a sending state in institutions situated within receiving states. Any such contract shall provide for:

(a) Its duration.

(b) Payments to be made to the receiving state by the sending state for inmate maintenance, extraordinary medical and dental expenses, and any participation in or receipt by inmates of rehabilitative or correctional services, facilities, programs or treatment not reasonably included as part of normal maintenance.

(c) Participation in programs of inmate employment, if any, the disposition or crediting of any payments received by inmates on account thereof, and the crediting of proceeds from or disposal of any products resulting therefrom.

(d) Delivery and retaking of inmates.

26 to the provisions of this subdivision, the officials of the receiving state shall act solely as agents
27 of the sending state and no final determination shall be made in any matter except by the appro-
28 priate officials of the sending state. Costs of records made pursuant to this subdivision shall be
29 borne by the sending state.

30 (g) Any inmate confined pursuant to this compact shall be released within the territory of the
31 sending state unless the inmate, and the sending and receiving states, shall agree upon release in
32 some other place. The sending state shall bear the cost of such return to its territory.

33 (h) Any inmate confined pursuant to the terms of this compact shall have any and all rights to
34 participate in and derive any benefits or incur or be relieved of any obligations or have such obli-
35 gations modified or the status of the inmate changed on account of any action or proceeding in
36 which the inmate could have participated if confined in any appropriate institution of the sending
37 state located within such state.

38 (i) The parent, guardian, trustee, or other person or persons entitled under the laws of the

40 prived of or restricted in the exercise of any power in respect of any inmate confined pursuant to

42 ARTICLE V

44 (a) Any decision of the sending state in respect of any matter over which it retains jurisdiction

1 but if at the time the sending state seeks to remove an inmate from an institution in the receiving
2 state there is pending against the inmate within such state any criminal charge or if the inmate is

ARTICLE X

CONSTRUCTION AND SEVERABILITY

The provisions of this compact shall be liberally construed and shall be severable. If any phrase, clause, sentence or provision of this compact is declared to be contrary to the constitution of any participating state or of the United States or the applicability thereof to any government, agency, person or circumstance is held invalid, the validity of the remainder of this compact and the applicability thereof to any government, agency, person or circumstance shall not be affected thereby. If this compact shall be held contrary to the constitution of any state participating therein, the compact shall remain in full force and effect as to the remaining states and in full force and effect as to the state affected as to all severable matters.

421.296. The Interstate Forest Fire Suppression Compact is enacted into law and entered into on behalf of this state with all other states legally joining therein in a form substantially as follows:

ARTICLE I

Purpose

The purpose of this compact is to provide for the development and execution of programs to facilitate the use of offenders in the forest fire suppression efforts of the party states for the ultimate protection of life, property and natural resources in the party states. The purpose of this compact is also, in emergent situations, to allow a sending state to cross state lines with an inmate when, because of weather or road conditions, it is necessary to cross state lines to facilitate the transport of an inmate.

ARTICLE II

Definitions

(1) "Sending state" means a state party to this compact from which a fire suppression unit is traveling.

(2) "Receiving state" means a state party to this compact to which a fire suppression unit is traveling.

(3) "Inmate" means a male or female offender who is under sentence to or confined in a prison or other correctional institution.

(4) "Institution" means any prison, reformatory, honor camp or other correctional facility, except facilities for *[the mentally ill or mentally handicapped]* **persons with mental illness or intellectual disabilities**, in which inmates may lawfully be confined.

(5) "Fire suppression unit" means a group of inmates selected by the sending states, corrections personnel and any other persons deemed necessary for the transportation, supervision, care, security and discipline of inmates to be used in forest fire suppression efforts in the receiving state.

1 (6) "Forest fire" means any fire burning in any land designated by a party state or the federal
 2 land management agencies as forestland.

3 ARTICLE III

4 Contracts

5 (1) Each party state may make one or more contracts with any one or more of the other party
 6 states for the assistance of one or more fire suppression units in forest fire suppression efforts. Any
 7 such contract shall provide for matters as may be necessary and appropriate to fix the obligations,
 8 responsibilities and rights of the sending and receiving states.

9 (2) The terms and provisions of this compact shall be part of any contract entered into by the
 10 authority of, or pursuant to, this compact. Nothing in any such contract may be inconsistent with
