5 <u>SECTION 1.</u> In addition to and not in lieu of any other appropriation, there is appropri-

6 ated to the Department of Education, for the biennium beginning July 1, 2013, out of the

7 General Fund, the amount of \$\_\_\_\_\_, which may be expended for the purpose of awarding

8 grants under the Career and Technical Education Revitalization Grant Program established

10 <u>SECTION 2.</u> This 2013 Act being necessary for the immediate preservation of the public 11 peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect 12 July 1, 2013.
