Senate Bill 622

Sponsored by COMMITTEE ON JUDICIARY (at the request of Oregon Law Commission)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Defines "record of the case" and "supplemental confidential file" in juvenile court proceedings. Clarifies when exhibit or judicially noticed fact or law becomes part of record of case. Clarifies when record and file are subject to inspection or disclosure, and who may obtain copies. Requires summary sheet in guardianship report.

(5)(a) Upon motion of a person, other than the state, entitled to appeal under subsection (1) of

1 this section, the appellate court shall grant the person leave to file a notice of appeal after the time 2 limits described in subsection (2) of this section if

2 limits described in subsection (3) of this section if:

3 (A) The person shows a colorable claim of error in the proceeding from which the appeal is4 taken; and

5 (B) The person shows that the failure to file a timely notice of appeal is not personally attrib-6 utable to the person.

7 (b) A person other than the state is not entitled to relief under this subsection for failure to file 8 timely notice of cross-appeal when the state appeals pursuant to ORS 419A.208.

9 (c) The request for leave to file a notice of appeal after the time limits prescribed in subsection 10 (3) of this section must be filed no later than 90 days after entry of the judgment being appealed and 11 must be accompanied by the notice of appeal sought to be filed. A request for leave under this 12 subsection may be filed by mail and is deemed filed on the date of mailing if the request is mailed 13 as provided in ORS 19.260.

(d) The court may not grant relief under this subsection unless the state has notice and oppor-tunity to respond to the person's request for relief.

(6) An appeal to the Court of Appeals must be conducted in the same manner as an appeal under
ORS chapter 19 except that the court shall advance the appeal on the court's docket in the same
manner as appeals in criminal cases.

19 (7)(a) Except as provided in ORS 419A.208 (2), or when otherwise ordered by the appellate court, the filing of an appeal does not suspend an order or judgment of the juvenile court nor discharge 20the ward or youth offender from the custody of the person, institution or agency in whose custody 2122the ward or youth offender may have been placed nor preclude the juvenile court after notice and 23hearing from entering such further orders relating to the ward or youth offender's custody pending final disposition of the appeal as it finds necessary by reason only of matters transpiring subsequent 24 to the order or judgment appealed from. (9) The district attorney or Attorney General shall represent the state in the appeal.

42 (10)(a) The court from which an appeal is taken shall prepare and transmit a record on appeal 43 in the manner provided in ORS 19.365, except that, when the appeal is to the circuit court from a 44 county court, the record on appeal shall be prepared and transmitted by the county court to the 45 circuit court.

(b) The court to which an appeal is taken under this section shall keep a record of the case on 1 2 appeal that includes but is not limited to notices of appeal, briefs, motions, orders of the court and other papers filed with the court on appeal. 3
