In line 35, delete "sodomy or sexual abuse" and insert "a crime or an attempt to commit a crime 23listed in subsection (1) of this section". 24 On page 4, delete lines 15 and 16 and insert: 25(b) 'Past sexual behavior' means sexual behavior other than the sexual behavior with respect 26to which the crime or attempt to commit the crime listed in subsection (1) of this section is 2728 alleged.". In line 30, after "166.720," insert "167.008,". 29 30 On page 13, after line 43, insert: "SECTION 15. (1) The amendments to ORS 163.266, 167.008 and 181.594 by sections 1, 2 3132 and 8 of this 2013 Act apply to prosecutions for offenses committed on or after the effective date of this 2013 Act. 33 "(2) The amendments to ORS 40.210, 133.724, 137.106, 147.015 by sections 3, 4, 5 and 7 of 34

1 this 2013 Act apply to prosecutions commenced on or after the effective date of this 2013 Act.

2 "SECTION 16. If House Bill 3277 becomes law, sections 5 (amending ORS 137.106) and 12

3 (amending ORS 144.275) of this 2013 Act are repealed.".
