SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Imposes on nonschool athletic teams requirements for recognizing and responding to possible concussions.

A BILL FOR AN ACT

2 Relating to youth athletic team safety.

3 Be It Enacted by the People of the State of Oregon:

4 **SECTION 1.** (1) As used in this section:

5 (a) "Coach" means a person who volunteers or is paid to instruct or train members of a

6 nonschool athletic team.

7 (b) "League governing body" means a governing body that:

8 (A) Oversees an association of nonschool athletic teams that provide instruction or 9 training for team members and that may compete with each other; and

(B) Is affiliated with, or otherwise sponsored or organized by, a nonprofit corporation
established as provided by ORS chapter 65.

12 (c) "Nonschool athletic team" means an athletic team that includes members who are 13 under 18 years of age and that is not affiliated with a public school in this state.

(d) "Referee" means a person who volunteers or is paid to act as a referee, as an umpire
or in a similar supervisory position for events involving nonschool athletic teams.

(e) "Referee governing body" means a governing body that:

(A) Trains and certifies individuals to serve as referees for nonschool athletic team
events; and

(B) Is affiliated with, or otherwise sponsored or organized by, a nonprofit corporation
established as provided by ORS chapter 65.

(2)(a) Each league governing body and each referee governing body shall ensure that the
coaches and the referees, respectively, receive annual training to learn how to recognize the
symptoms of a concussion and how to seek proper medical treatment for a person suspected
of having a concussion.

(b) Each league governing body and each referee governing body shall adopt a policy that
establishes:

(A) The requirements of the training described in paragraph (a) of this subsection; and

2 (B) Procedures that ensure that every coach and referee receives the training described in paragraph (a) of this subsection. 3

(3)(a) A coach may not allow a member of a nonschool athletic team to participate in any 4 athletic event or training on the same day that the member: 5

(A) Exhibits signs, symptoms or behaviors consistent with a concussion following an ob-6 served or suspected blow to the head or body; or 7

(B) Has been diagnosed with a concussion.

9 (b) A coach may allow a member of a nonschool athletic team who is prohibited from participating in an athletic event or training, as described in paragraph (a) of this subsection, 10 to participate in an athletic event or training no sooner than the day after the member ex-11 12 perienced a blow to the head or body and only after the member:

13

(A) No longer exhibits signs, symptoms or behaviors consistent with a concussion; and (B) Receives a medical release form from a health care professional. 14

(4) A referee may not allow a member of a nonschool athletic team to participate in any 15 athletic event during which the member exhibited signs, symptoms or behaviors consistent 16 with a concussion following an observed or suspected blow to the head or body. 17

18 (5) The league governing body shall develop or use existing guidelines and other relevant materials, and shall make available those guidelines and materials, to inform and educate 19 persons under 18 years of age desiring to be a member on a nonschool athletic team, the 20parents and legal guardians of the persons and the coaches about the symptoms and warning 2122signs of a concussion.

23(6) For each year of participation, and prior to a person under 18 years of age participating as a member on a nonschool athletic team, at least one parent or legal guardian of 24the person must acknowledge the receipt of the guidelines and materials described in sub-25section (5) of this section and the review of those guidelines and materials by: 26

(a) The parent or legal guardian of the person; and

(b) If the person is 12 years of age or older, the person.

(7) A league governing body may hold an informational meeting prior to the start of any 2930 season for each nonschool athletic team regarding the symptoms and warning signs of a 31 concussion.

32(8)(a) Any person who regularly serves as a coach or as a referee and who complies with the provisions of this section is immune from civil or criminal liability related to a head in-33 34 jury unless the person acted or failed to act because of gross negligence or willful or wanton 35 misconduct.

(b) Nothing in this section shall be construed to affect the civil or criminal liability re-36 37 lated to a head injury of a person who does not regularly serve as a coach or a referee.
