Senate Bill 815

Sponsored by Senator THOMSEN

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Provides that agri-tourism provider is not liable for injury to or death of participant arising out of inherent risks of agri-tourism activities if agri-tourism provider posts certain notices. Provides exceptions.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to agri-tourism; and declaring an emergency.

3 Be It Enacted by the People of the State of Oregon:

4 <u>SECTION 1.</u> As used in sections 1 to 3 of this 2013 Act:

5 (1) "Agri-tourism activity" means an activity carried out on a farm or ranch that allows

6 members of the general public, for recreational, entertainment or education purposes, to

observe or engage in rural activities, including but not limited to farming, ranching, historic,
cultural or harvest-your-own activities.

9 (2) "Agri-tourism provider" means a person that provides an agri-tourism activity, 10 whether or not for compensation.

(3) "Inherent risks of agri-tourism activity" means:

(a) Dangers or conditions that are an integral part of an agri-tourism activity, including
 but not limited to surface and subsurface conditions, natural conditions of land, vegetation
 and waters, the behavior of wild or domestic animals and ordinary dangers of structures or
 equipment ordinarily used in farming and ranching operations.

(b) The potential that a participant may act in a negligent manner that may contribute to injury to the participant or others, including but not limited to failing to follow instructions given by an agri-tourism provider or failing to exercise reasonable caution while engaging in an agri-tourism activity.

(4) "Participant" means an individual, other than an agri-tourism provider, who engages
 in an agri-tourism activity.

22 <u>SECTION 2.</u> (1) Except as provided in subsections (2) and (3) of this section, an agri-23 tourism provider that posts the notices required under section 3 of this 2013 Act is not liable 24 for an injury to or the death of a participant arising from the inherent risks of an agri-25 tourism activity.

(2) Subsection (1) of this section does not limit the liability of an agri-tourism provider
 if the agri-tourism provider:

(a) Commits an act or omission that constitutes willful or wanton disregard for the
safety of the participant and that act or omission is a cause of injury to the participant;
(b) Intentionally injures the participant;

1	(c) Provides equipment to the participant and fails to make reasonable and prudent in-
2	spection of the equipment, and that failure is a cause of the injury to the participant; or
3	(d) Owns, leases, rents or otherwise is in possession and control of the land or facilities
4	upon which the participant sustains injuries because of a dangerous latent condition that is
5	known to or should be known to the agri-tourism provider and for which warning signs are
6	not conspicuously posted.
7	(3) Subsection (1) of this section does not limit the liability of an agri-tourism provider
8	under the product liability provisions of ORS 30.900 to 30.920.
9	SECTION 3. (1) An agri-tourism provider shall conspicuously post the notice specified in
10	subsection (2) of this section:
11	(a) At the entrance to the agri-tourism site;
12	(b) At any location where an agri-tourism activity takes place; and
13	(c) In every written contract entered into between the agri-tourism provider and a par-
14	ticipant.
