"(b) 'Autism spectrum disorder' has the meaning given that term 15in the fifth edition of the Diagnostic and Statistical Manual of Mental 16 Disorders (DSM-5) published by the American Psychiatric Association. 17 "(c) 'Behavioral health treatment' means counseling and treatment 18 programs, including applied behavior analysis and other evidence-19 based behavioral interventions, that are necessary to improve the 20functioning of an individual with serious behavioral impairments and 21that are provided by: 22

"(A) A licensed health care professional approved by the Behavior
 Analyst Board under section 3 of this 2013 Act;

"(B) A behavior analyst or an assistant behavior analyst licensed
under section 3 of this 2013 Act; or

5 "(C) A behavior analysis interventionist registered under section 3
6 of this 2013 Act.

7 "(d) 'Diagnosis' means medically necessary assessment, evaluation
8 or testing.

9 "(e) 'Health benefit plan' has the meaning given that term in ORS
10 743.730.

"(f) 'Medically necessary' means in accordance with the definition of medical necessity that is specified in the policy or certificate for the health benefit plan and that applies to all covered services under the plan.

"(g) 'Treatment for autism spectrum disorder' includes behavioral
 health treatment and any mental health services or other medical
 services identified in the individualized treatment plan, as described
 in subsection (10) of this section.

19 "(2) A health benefit plan shall provide coverage of:

"(a) The screening for and diagnosis of autism spectrum disorder
 by a licensed neurologist, pediatric neurologist, developmental pedia trician, psychiatrist or psychologist, who has experience and training
 in the diagnosis of autism spectrum disorder; and

"(b) Medically necessary treatment for autism spectrum disorder
 and the management of care, including any periodic updating of an
 individualized treatment plan that is required by the insurer.

"(3) An insurer may not terminate coverage or refuse to issue or
renew coverage for an individual solely because the individual has received a diagnosis of autism spectrum disorder or has received treatment for autism spectrum disorder.

"(4) Coverage under this section may be subject to utilization con trols that are reasonable in the context of individual determinations
 of medical necessity. An insurer may require:

"(a) Confirmation of an autism spectrum disorder diagnosis by a
professional described in subsection (2)(a) of this section if the original
diagnosis was not made by a professional described in subsection (2)(a)
of this section, provided the requirement does not delay the provision
of applied behavior analysis services by more than 60 days.

9 "(b) Prior authorization for coverage of 25 hours or less per week 10 of applied behavior analysis recommended in an individualized treat-11 ment plan approved by a professional described in subsection (2)(a) of 12 this section for an individual with autism spectrum disorder who is 13 younger than nine years of age, as long as the insurer makes a prior 14 authorization determination no later than 30 calendar days after re-15 ceiving the request for prior authorization.

"(c) Prior authorization, according to the terms of the policy that
 apply to other medical conditions, for coverage of:

"(A) Hours in excess of 25 hours per week of applied behavior
 analysis for individuals who are younger than nine years of age; or

"(B) Applied behavior analysis for individuals who are nine years
of age or older.

"(5)(a) Once coverage for applied behavior analysis has been approved, the coverage continues as long as:

"(A) The individual continues to make progress toward the majority
 of the goals of the individualized treatment plan; and

²⁶ "(B) Applied behavior analysis is medically necessary.

"(b) This subsection does not require coverage of applied behavior
analysis that is being provided by the Oregon Health Authority, the
Department of Human Services, a school district or an education service district.

1 "(c) An insurer may require periodic review of an individualized 2 treatment plan, as described in subsection (10) of this section, and 3 modification of the individualized treatment plan if the review shows 4 that the individual receiving the treatment is not making substantial 5 progress toward the goals of the individualized treatment plan.

6 "(6) Coverage under this section may be subject to requirements 7 and limitations no more restrictive than those imposed on coverage 8 or reimbursement of expenses arising from the treatment of other 9 medical conditions under the policy or certificate, including but not 10 limited to:

"(a) Requirements and limitations regarding in-network providers;
 and

13 "(b) Provisions relating to deductibles, copayments and
14 coinsurance.

"(7) This section does not limit coverage for any services, other
 than applied behavior analysis, that are otherwise available to an in dividual under ORS 743A.168 or 743A.190.

"(8) A claim for services described in this section may not be denied
 on the basis that the service is habilitative or rehabilitative and does
 not fully restore function.

"(9) Coverage under this section includes treatment provided in the 21individual's home or a licensed health care facility or, for treatment 22provided by a licensed health care professional approved by the Be-23havior Analyst Board under section 3 of this 2013 Act, at the office of 24the health care professional. This section may not be construed as 25affecting any obligation to provide services to an individual under an 26individualized family service plan or an individualized education pro-27gram. Nothing in this section requires coverage for: 28

29 "(a) Services provided by a family or household member;

30 "(b) Services that are custodial in nature or that constitute marital,

1 family, educational or training services;

"(c) Custodial or respite care, equine assisted therapy, creative arts
therapy, wilderness or adventure camps, social counseling or telemedicine; or

5 "(d) Services or supplies that are not medically necessary.

"(10) If an individual is receiving treatment for autism spectrum 6 disorder, an insurer may require submission of an individualized 7 treatment plan, which shall include all elements necessary for the 8 insurer to appropriately determine coverage under the health benefit 9 plan. The individualized treatment plan must be based on evidence-10 based screening criteria. An insurer may require an updated individ-11 ualized treatment plan, not more than once every six months, that 12includes observed progress as of the date the updated plan was pre-13 pared, for the purpose of performing utilization review and medical 14 management. The insurer may require the individualized treatment 15 plan to include the: 16

17 **"(a) Diagnosis;**

18 **"(b) Proposed treatment by type;**

19 "(c) Frequency and anticipated duration of treatment;

"(d) Anticipated outcomes stated as goals, including specific cogni tive, social, communicative, self-care and behavioral goals that are
 clearly stated, directly observed and continually measured and that
 address the characteristics of the autism spectrum disorder; and

24 "(e) Signature of the treating provider.

"(11) This section applies to health benefit plans and to self-insured
health plans offered by the Public Employees' Benefit Board and the
Oregon Educators Benefit Board.
