PROPOSED AMENDMENTS TO HOUSE BILL 3075

1 On page 1 of the printed bill, line 2, after "332.505" insert "and sections 2 14 and 16, chapter 36, Oregon Laws 2012".

3 On page 2, after line 8, insert:

4 "SECTION 3. Section 16, chapter 36, Oregon Laws 2012, is amended to 5 read:

"Sec. 16. (1) Each school district and education service district shall form
an achievement compact advisory committee.

8 "(2) An achievement compact advisory committee shall be responsible for 9 developing an achievement compact and ensuring that an achievement com-10 pact is implemented.

"(3) The governing body of a district shall appoint the members of an 11 achievement compact advisory committee. The members shall consist of 12teachers, administrators and other appropriate education personnel who are 13 employed by the district. When an employee organization represents educa-14 tors of a district, the superintendent of the district, at the direction of the 15governing board of the district, shall collaborate with the local president of 16 the employee organization to recommend the appointment of educators to the 17 achievement compact advisory committee. 18

19 "(4) An achievement compact advisory committee shall:

"(a) Develop plans for achieving the district's outcomes, measures of
 progress, goals and targets expressed in an achievement compact, including
 methods of assessing and reporting progress toward the achievement of goals

1 and targets; and

2 "(b) Recommend outcomes, measures of progress, goals and targets to be 3 contained in the district's achievement compact for the next fiscal year.

"(5) Each achievement compact advisory committee shall present its rec-4 ommendations in a report to the governing board of the district no later than $\mathbf{5}$ [February] May 1 of each year. An achievement compact advisory 6 committee's report and recommendations shall be considered by the govern-7 ing board of the district when entering into an achievement compact for the 8 next fiscal year. The governing board shall file the achievement compact 9 advisory committee's report with each achievement compact it adopts and 10 forwards to the Oregon Education Investment Board. 11

"(F) For the Oregon Health and Science University, the Oregon Health
and Science University Board of Directors.

"(2)(a) Prior to the beginning of each fiscal year, the governing body of each education entity must enter into an achievement compact with the Oregon Education Investment Board for the fiscal year.

"(b) Governing bodies of education entities identified in subsection (1)(b)(A) to (C) of this section shall enter into achievement compacts as part of the budgeting process under ORS 294.305 to 294.565 and shall submit achievement compacts to the board prior to:

"(A) October 15 of each year for governing bodies of education entities identified in subsection (1)(b)(A) or (B) of this section; or

"(B) July 1 of each year for governing bodies of education entities
identified in subsection (1)(b)(C) of this section.

"(c) The board shall specify a process for adoption and a timeline for submission of achievement compacts for education entities identified in subsection (1)(b)(D) to (F) of this section.

"(d) The board shall provide to each school district a number quantifying the district's estimated level of funding for the next fiscal year compared to the determination of funding needed to ensure that the state's system of kindergarten through grade 12 public education meets the quality goals specified under ORS 327.506.

"(3)(a) The board shall establish the terms for achievement compacts.
"(b) The terms of an achievement compact may include:

"(A) A description of goals for outcomes that are consistent with the educational goals identified in ORS 329.015, the findings described in ORS
351.003 and the mission of education provided in ORS 351.009.

4 "(B) A description of the outcomes and measures of progress that will
5 allow each education entity to quantify:

6 "(i) Completion rates for:

7 "(I) Critical stages of learning and programs of study;

8 "(II) The attainment of diplomas, certificates and degrees; and

9 "(III) Achieving the high school and post-secondary education goals es-10 tablished in ORS 351.009 and a projection of the progress needed to achieve 11 those goals by 2025;

"(ii) Validations of the quality of knowledge and skills acquired by stu dents of the education entity; and

"(iii) The relevance of the knowledge and skills acquired by the students of the education entity and the means by which those skills and knowledge will contribute to the workforce, the economy and society as described in state policy.

"(C) Other information suggested by the governing body of an educationentity and approved by the board.

"(c) Notwithstanding the terms described in paragraph (b) of this subsection, for an achievement compact entered into by an education entity identified in subsection (1)(b)(F) of this section, the terms of the achievement compact shall be limited to the enrollment of, and attainment of degrees by, Oregon residents in programs for which the state provides funding.

"(4)(a) The governing body of each education entity shall identify a target number and percentage of students for achievement of the outcomes, measures of progress and goals specified in the achievement compact for the fiscal year.

29 "(b) The governing body of each education entity shall provide a target 30 number and percentage of students for the aggregate of all disadvantaged subgroups, as defined by federal law or specified by rules adopted by the board. The target number and percentage of students must reflect the education entity's goals of improving education outcomes for disadvantaged student groups and closing any student achievement gaps between disadvantaged student groups and other student groups.

"(5) As part of the process of entering into an achievement compact, the 6 governing body of an education entity shall ensure that open communi-7 cations are provided to parents, students, teachers or faculty, employees, 8 exclusive bargaining representatives and community representatives for the 9 purposes of explaining and discussing the outcomes, measures of progress, 10 goals and targets specified in the achievement compact for the fiscal year. 11 The open communications must be provided during each education entity's 12 public budget process. 13

"(6) The board shall specify the format of the achievement compacts and
 provide model achievement compacts to the governing body of each education
 entity.

"(7) The board may adopt a timeline and method for governing bodies of education entities to provide the board with a report at the end of a fiscal year that describes the achievements made by the education entities during the fiscal year. The report:

"(a) Must include disaggregated data for each disadvantaged student group specified by the board; and

"(b) May state achievements in numbers and percentages and in relation
to the outcomes, measures of progress, goals and targets specified in the
achievement compact for the fiscal year.".
