Notwithstanding this sub-24section, the department may return a bank check or money order when re-2526 ceived in incorrect or incomplete form or when not accompanied by the proper application. 27

"(2) The department shall pay the following approved expenses and dis bursals from the Department of Transportation Driver and Motor Vehicle
 Suspense Account before payment of the general administrative expenses of

"(b) Amounts transferred to the State Treasurer under ORS 319.410 (2) for
the purpose of carrying out the state aviation laws, amounts transferred to

amounts transferred to the Department of Transportation Operating Fund

"(c) After deduction of expenses of collection, transfer and administration, the department shall pay moneys collected from the Student Driver Training Fund eligibility fee under ORS 807.040, 807.150 and 807.370 to the State Treasurer for deposit in the Student Driver Training Fund. The moneys deposited in the Student Driver Training Fund under this paragraph are continuously appropriated to the department for the following purposes:

"(A) To the extent of not more than 10 percent of the amount transferred
into the Student Driver Training Fund in any biennium, to pay the expenses
of administering ORS 336.795, 336.800, 336.805, 336.810 (2) and 336.815.

"(B) The remaining moneys, for reimbursing school districts and com mercial driver training schools as provided under ORS 336.805.

"(d) After deduction of expenses of collection, transfer and administration, the department shall pay moneys collected for the Motorcycle Safety Subaccount under ORS 807.170 to the State Treasurer for deposit in the Motorcycle Safety Subaccount of the Transportation Safety Account. Moneys paid to the State Treasurer under this paragraph shall be used for the purpose of ORS 802.320.

"(e) After deduction of expenses for the administration of the issuance of customized registration plates under ORS 805.240, the department shall place moneys received from the sale of customized registration plates in the Passenger Rail Transportation Account. The moneys placed in the account are continuously appropriated to the department and shall be used for the pay ment of expenses incurred in administering passenger rail programs.

"(f) After deduction of expenses of collection, transfer and administration, 3 the department shall pay moneys from any registration fees established by 4 the governing bodies of counties or a district, as defined in ORS 801.237, $\mathbf{5}$ under ORS 801.041 or 801.042 to the appropriate counties or districts. The 6 department shall make the payments on at least a monthly basis unless an-7 other basis is established by the intergovernmental agreements required by 8 ORS 801.041 and 801.042 between the department and the governing bodies 9 of a county or a district. 10

"(g) After deducting the expenses of the department in collecting and transferring the moneys, the department shall make disbursals and payments of moneys collected for or dedicated to any other purpose or fund except the State Highway Fund, including but not limited to, payments to the Department of Transportation Operating Fund established by ORS 184.642 (1) and (2).

"(3) The department shall refund from the Department of Transportation 17 Driver and Motor Vehicle Suspense Account any excess or erroneous pay-18 ment to a person who made the payment or to the person's legal represen-19 tative when the department determines that money has been received by it 20in excess of the amount legally due and payable or that it has received 21money in which it has no legal interest. Refunds payable under this sub-22section are continuously appropriated for such purposes in the manner for 23payment of refunds under this section. If the department determines that a 24refund is due, the department may refund the amount of excess or erroneous 25payment without a claim being filed. Except as provided in ORS 319.290, 26319.375, 319.820 and 319.831, any claim for a refund from the department must 27be filed within 12 months after the date payment is received by the depart-28ment. 29

"(b) Moneys received from the registration of snowmobiles that is not to
be used for payment of administrative expenses of the department shall be
transferred within 30 days after the end of the quarter.

"(c) Moneys received from the issuance of winter recreation parking permits that is not used for payment of administrative expenses of the department shall be transferred within 30 days after the end of the quarter.

"(7) The following moneys transferred to the State Highway Fund under
 this section may be used only for the purposes described as follows:

"(a) Moneys collected from the issuance of winter recreation parking permits, and the interest on such moneys, shall be used to enforce the requirement for winter recreation parking permits and to remove snow from winter recreation parking locations designated under ORS 810.170. Any remaining moneys shall, upon approval by the Winter Recreation Advisory Committee:

"(A) Be used to maintain parking locations developed with moneys obtained under ORS 810.170 and snowmobile facilities that are parking lots
developed with moneys as provided under this section;

"(B) Be used to develop additional winter recreation parking locations
 under ORS 810.170; or

"(C) Be carried over to be used in subsequent years for the purposes and
 in the manner described in this paragraph.

"(b) Moneys received from the registration of snowmobiles or under ORS 14 802.120 may be used for development and maintenance of multiuse trails 15 within urban growth boundaries described in ORS 367.017 or for the devel-16 opment and maintenance of snowmobile facilities, including the acquisition 17 of land therefor by any means other than the exercise of eminent domain. 18 Moneys received under ORS 802.120 may also be used for the enforcement 19 of ORS 811.590, 821.100 to 821.120, 821.140, 821.150, 821.190, 821.210 and 20821.240 to 821.290. 21

"(8) The department shall maintain the Revolving Account for Emergency 22Cash Advances separate from other moneys described in this section. From 23the account, the department may pay for the taking up of dishonored remit-24tances returned by banks or the State Treasurer and for emergency cash 25advances to be subsequently reimbursed. The account shall be used only as 26a revolving fund. The department shall at all times be accountable for the 27amount of the account, either in cash or unreimbursed items and advances. 28The moneys in the account are continuously appropriated for the purposes 29 of this subsection. The amount of the account under this subsection shall 30

not exceed \$40,000 from moneys received by the department in the performance of its driver and motor vehicle services functions and moneys otherwise appropriated for purposes of this subsection. The account under this subsection shall be kept on deposit with the State Treasurer. The State Treasurer is authorized to honor and pay all properly signed and indorsed checks or warrants drawn against the account.

"SECTION 8. ORS 390.555 is amended to read:

"390.555. The All-Terrain Vehicle Account is established as a separate 8 account in the State Parks and Recreation Department Fund, to be accounted 9 for separately. Interest earned by the All-Terrain Vehicle Account shall be 10 credited to the account. "SECTION 11. (1) A person commits the offense of operating an
all-terrain vehicle in a restricted area if the person operates any Class
I, Class II, Class III or Class IV all-terrain vehicle on lands not owned
by the operator or owner of the all-terrain vehicle or on any nonhighway road or trail, when the road or trail is restricted to pedestrian
or animal travel.

"(2) In addition to other penalties provided by this section, the

 vehicle may be liable as provided under ORS 821.310.

"(3) The offense described in this section, operating an all-terrain
 vehicle in a restricted area, is a Class B traffic violation.

(1) Notwithstanding any other provision of law, a 17 citation for violation of ORS 821.192, 821.280, 821.285 or section 11 of 18 this 2013 Act may be issued without the presence of a police officer if 19 there is reasonable evidence presented to the police officer that the 20 operator of the all-terrain vehicle committed a violation of ORS 21 821.192, 821.280, 821.285 or section 11 of this 2013 Act.

"(2) At a minimum, the evidence must include information relating 22to the time and location at which the violation occurred or a de-23scription of the vehicle involved in the violation. If, after an investi-24gation of a reported violation of ORS 821.192, 821.280, 821.285 or section 2511 of this 2013 Act, the police officer is able to identify the operator 26of the all-terrain vehicle and has probable cause to believe a violation 27of ORS 821.192, 821.280, 821.285 or section 11 of this 2013 Act has oc-28curred, the police officer shall prepare a citation of the traffic vio-29 lation and have it served upon the operator of the all-terrain vehicle. 30

"821.310. The operator or the owner of a snowmobile or all-terrain vehicle used with the permission of the owner shall be liable for three times the amount of any damage to trees, shrubs, growing crops or other property injured as the result of travel by such snowmobile or all-terrain vehicle over the property involved. The liability under this section is in addition to any penalties provided in ORS 821.150, 821.190, 821.210 or 821.250 to 821.290 or section 11 of this 2013 Act.".
