

**PROPOSED AMENDMENTS TO
HOUSE BILL 2640**

1 On page 1 of the printed bill, delete lines 5 through 29 and delete pages
2 2 and 3 and insert:

3 **“SECTION 1.** Section 1, chapter 519, Oregon Laws 2011, as amended by
4 section 8, chapter 519, Oregon Laws 2011, and section 20, chapter 36, Oregon
5 Laws 2012, is amended to read:

6 **“Sec. 1.** (1) The Oregon Education Investment Board is established for the
7 purpose of ensuring that all public school students in this state reach the
8 education outcomes established for the state. The board shall accomplish this
9 goal by overseeing a unified public education system that begins with early
10 childhood services and continues throughout public education from
11 kindergarten to post-secondary education.

12 **“(2)(a)** The board consists of [~~13~~] **15** members as follows:

13 **“(A)** The Governor, or the designee of the Governor; and

14 **“(B)** [~~Twelve~~] **Fourteen** members who are appointed by the Governor,
15 subject to confirmation by the Senate in the manner provided in ORS 171.562
16 and 171.565, and who serve at the pleasure of the Governor.

17 **“(b)** When determining who to appoint to the board, the Governor shall:

18 **“(A)** Ensure that each congressional district of this state is represented
19 by at least one member of the board; [~~and~~]

20 **“(B)** **Consult with the oldest nonprofit network of parents in Oregon**
21 **that provides statewide representation of parents to select one member**
22 **who is a parent of a student in a public school in this state in any**

1 **grade from kindergarten through grade 12;**

2 **“(C) Consult with an organization that represents school district**
3 **boards in this state to select one member of a school district board;**
4 **and**

5 **“[(B)] (D) Solicit recommendations from:**

6 **“(i) The Speaker of the House of Representatives for at least two members**
7 **[and from]; and**

8 **“(ii) The President of the Senate for at least two members.**

9 **“(3) The Governor, or the Governor’s designee, shall serve as chairperson**
10 **of the Oregon Education Investment Board.**

11 **“(4) The duties of the board include:**

12 **“(a) Ensuring that early childhood services are streamlined and connected**
13 **to public education from kindergarten through grade 12 and that public ed-**
14 **ucation from kindergarten through grade 12 is streamlined and connected to**
15 **post-secondary education. To assist the board in fulfilling this duty, the**
16 **board shall oversee:**

17 **“(A) The Early Learning Council established by section 4, chapter 519,**
18 **Oregon Laws 2011.**

19 **“(B) The Higher Education Coordinating Commission established by ORS**
20 **351.715.**

21 **“(b) Recommending strategic investments in order to ensure that the**
22 **public education budget is integrated and is targeted to achieve the educa-**
23 **tion outcomes established for the state.**

24 **“(c) Providing an integrated, statewide, student-based data system that**
25 **monitors expenditures and outcomes to determine the return on statewide**
26 **education investments. The board shall provide the data system described in**
27 **this paragraph by:**

28 **“(A) Developing the data system or identifying or modifying an existing**
29 **data system that accomplishes the goals of the data system; and**

30 **“(B) Ensuring that the data system is maintained.**

1 “(d) Entering into achievement compacts and administering sections 14,
2 15 and 18, **chapter 36, Oregon Laws 2012** [*of this 2012 Act*].

3 “(e) Working with the Quality Education Commission to identify best
4 practices for school districts and the costs and benefits of the adoption of
5 those best practices by school districts.

6 “(5) An appointed member of the board is entitled to compensation and
7 expenses as provided in ORS 292.495.

8 “(6) A majority of the members of the board constitutes a quorum for the
9 transaction of business.

10 “(7) The board shall meet at such times and places specified by the call
11 of the chairperson or of a majority of the members of the board.

12 “(8) In accordance with applicable provisions of ORS chapter 183, the
13 board may adopt rules necessary for the administration of the laws that the
14 board is charged with administering, including any rules necessary for the
15 oversight of the direction and control of the Higher Education Coordinating
16 Commission.

17 “**SECTION 2.** Section 1, chapter 519, Oregon Laws 2011, as amended by
18 section 8, chapter 519, Oregon Laws 2011, and sections 20 and 21, chapter 36,
19 Oregon Laws 2012, is amended to read:

20 “**Sec. 1.** (1) The Oregon Education Investment Board is established for the
21 purpose of ensuring that all public school students in this state reach the
22 education outcomes established for the state. The board shall accomplish this

27 “(A) The Governor, or the designee of the Governor; and

28 “(B) [*Twelve*] **Fourteen** members who are appointed by the Governor,

30 and 171.565, and who serve at the pleasure of the Governor.

1 “(b) When determining who to appoint to the board, the Governor shall:

22 **preservation of the public peace, health and safety, an emergency is**
23 **declared to exist, and this 2013 Act takes effect on its passage.”.**
