The Governor shall ensure that membership of the council 14 satisfies any federal requirements for membership of a state advisory com-15mittee on juvenile justice[,] and shall include a minimum of three repre-16 sentatives of county departments and boards of county commissioners 17 from diverse regions of this state and tribal representation in the mem-18 bership of the council. When determining whom to appoint to the 19 council, the Governor shall ensure that each congressional district of 20this state is represented by at least one member of the council. 21

The youth development programs, services and ini-15 tiatives that are to be provided pursuant to such agreements under 16 section 21 (4)(d), chapter 37, Oregon Laws 2012, as amended by section 17 1 of this 2013 Act, must be provided by September 30, 2013. 18

"<u>SECTION 5.</u> This 2013 Act being necessary for the immediate
 preservation of the public peace, health and safety, an emergency is
 declared to exist, and this 2013 Act takes effect on its passage.".
