On page 1 of the printed A-engrossed bill, delete lines 4 through 22 and 1 delete pages 2 through 4 and insert: $\mathbf{2}$ 3 **"OREGON HATCHERY RESEARCH CENTER** 4 ADVISORY COMMITTEE $\mathbf{5}$ 6 "SECTION 1. Establishment of Oregon Hatchery Research Center 7 Advisory Committee. (1) There is established the Oregon Hatchery 8 **Research Center Advisory Committee within the State Department of** 9 Fish and Wildlife. The committee shall consist of 14 members ap-10 pointed by the State Fish and Wildlife Director under subsection (2) 11 of this section and one member specified in subsection (3) of this sec-12tion. Members of the committee must be residents of this state who 13 are well informed on matters related to fish management policy and 14 demonstrate an interest in the propagation of fish in hatcheries. 15"(2) The 14 members appointed by the director shall be represen-16 tative of each of the following interests: 17 "(a) One member shall represent the Oregon Salmon Commission 18 established under ORS 576.062. 19 "(b) One member shall represent the Columbia River gillnet salmon 20fishery established under ORS 508.775 to 508.796. 21

22 "(c) Two members shall represent wild fish advocacy organizations.

1 "(d) Two members shall represent statewide sport angling organ-2 izations.

3 "(e) One member shall represent the agricultural industry.

4 "(f) One member shall represent coastal ports.

5 "(g) One member shall represent the forest products industry.

6 "(h) One member shall represent Oregon Indian tribes, to be ap-7 pointed by the director after consultation with the Commission on 8 Indian Services.

9 "(i) One member shall represent Oregon State University.

10 "(j) Two members shall represent the independent scientific com-11 munity and have scientific backgrounds related to fish management 12 and the propagation of fish in hatcheries.

"(k) One member shall represent the Oregon Watershed Enhance ment Board and may not be a federal employee.

"(3) In addition to the members appointed under subsection (2) of
 this section, the director shall invite a representative of the federal
 government to serve as a member of the committee.

"(4) The committee shall select one of its members as chairperson
 and another as vice chairperson.

20 "(5) A member serves a four-year term. A member may be reap-21 pointed.

22 "(6) Members of the committee shall serve without compensation.

<u>"SECTION 2.</u> Duties of Oregon Hatchery Research Center Advisory
 <u>Committee.</u> The Oregon Hatchery Research Center Advisory Commit tee established under section 1 of this 2013 Act shall report to the Di rector of the Oregon Hatchery Research Center and:

"(1) Recommend strategic directions and operation objectives for
the Oregon Hatchery Research Center located on Fall Creek, near
Alsea, consistent with ORS 496.275.

30 "(2) Recommend research projects for the center.

1 "(3) Review research conducted at the center and make recom-2 mendations regarding how the research may be enhanced to meet any 3 strategic directions and operations objectives established for the cen-4 ter by the director.

"(4) Recommend research proposals related to the activities of the
center specified in section 3 of this 2013 Act.

"OREGON HATCHERY RESEARCH CENTER

"<u>SECTION 3.</u> (1) The hatchery research center located on Fall
 Creek, near Alsea, is named the Oregon Hatchery Research Center.

12 "(2) The center shall carry out the following activities:

"(a) Conduct research to implement and advance the Oregon Plan
 as defined in ORS 541.890.

15 "(b) Conduct research on methods to minimize the genetic and ec-16 ological risk to naturally produced fish when hatchery produced fish 17 are released in the waters of this state, while also allowing the 18 consumptive harvest of hatchery produced fish.

"(c) Conduct research to determine the genetic and ecological risk
 to naturally produced fish when wild broodstock hatchery produced
 fish are released into the waters of this state.

"(d) Conduct research to determine the effect of hatchery operations on naturally produced fish and the habitat of naturally
produced fish.

"(e) Provide educational and research opportunities for undergrad uate students, graduate students and postgraduate students.

"(f) Provide educational opportunities for the public and for stu dents in grades 1 through 12.

"(g) Consider any recommendations made by the Oregon Hatchery
 Research Center Advisory Committee pursuant to section 2 of this 2013

1 Act.

"(3) As used in this section, 'waters of this state' has the meaning
given that term in ORS 196.800.

"SECTION 4. Director. The chairperson of a department related to
fish and wildlife at Oregon State University, after consultation with
the State Fish and Wildlife Director and the Oregon Hatchery Research Center Advisory Committee established under section 1 of this
2013 Act, shall appoint a Director of the Oregon Hatchery Research
Center.

"MISCELLANEOUS

"SECTION 5. (1) Subject to subsection (2) of this section, no later 13 than January 1, 2014, and in order to carry out the activities of the 14 Oregon Hatchery Research Center specified in section 3 of this 2013 15Act, the State Department of Fish and Wildlife shall, after consulta-16 tion with the Oregon Hatchery Research Center Advisory Committee 17 established under section 1 of this 2013 Act, renegotiate any agreement 18 entered into between the State Board of Higher Education and the 19 State Department of Fish and Wildlife related to the Oregon Hatchery 20**Research Center.** 21

"(2) Any agreement entered into between the State Board of Higher Education and the State Department of Fish and Wildlife related to advisory committees for the Oregon Hatchery Research Center is terminated on the effective date of this 2013 Act and any advisory committees cease to exist.

"<u>SECTION 6.</u> The State Fish and Wildlife Director shall make the
appointments, and extend the invitation, specified in section 1 of this
2013 Act related to members of the Oregon Hatchery Research Center
Advisory Committee no later than January 1, 2014.

"SECTION 7. Notwithstanding the term of office specified in section 1 1 of this 2013 Act, of the members first appointed to the Oregon $\mathbf{2}$ Hatchery Research Center Advisory Committee pursuant to section 1 3 of this 2013 Act: 4 "(1) Five shall serve for a term ending June 30, 2015. $\mathbf{5}$ "(2) Five shall serve for a term ending June 30, 2016. 6 "(3) Four shall serve for a term ending June 30, 2017. 7 "SECTION 8. The unit and section captions used in this 2013 Act 8 are provided only for the convenience of the reader and do not become 9 part of the statutory law of this state or express any legislative intent 10 in the enactment of this 2013 Act. 11 12**"EMERGENCY CLAUSE** 13 14 "SECTION 9. This 2013 Act being necessary for the immediate 15 preservation of the public peace, health and safety, an emergency is 16 declared to exist, and this 2013 Act takes effect on its passage.". 17 18
