5 "Whereas it is important that ex-offenders acquire the skills necessary for 6 gainful employment that allows them to become productive members of so-7 ciety; and

8 "Whereas a successful route to building skills and obtaining gainful em9 ployment is through apprenticeship programs; and

"Whereas many apprenticeship programs require students to have a validdriver license; and

12 "Whereas some ex-offenders have lost their driving privileges and may not 13 have their driving privileges reinstated until the ex-offender has paid signif-14 icant outstanding fines; and

15 "Whereas ex-offenders are unable to pay their financial obligations when16 they are unemployed; and

Whereas ex-offenders are willing to do the hard work that is needed to be successful in an apprenticeship program and secure gainful employment; and

20 "Whereas it is in this state's interests to allow ex-offenders the opportu-21 nity to reinstate their driving privileges contingent upon their enrollment in 22 an apprenticeship program and to begin repaying their fines; now, 1 therefore,".

"809.210. (1) A court may do any of the following if the defendant is
convicted of any traffic offense and fails or refuses to pay a fine imposed by

"(a) Issue a notice of suspension to the Department of Transportation
that directs the department to implement procedures under ORS 809.416.

10 "(b) Order a defendant's driving privileges restricted.

11 "(2) The authority granted in this section is in addition to or instead of 12 any other method authorized by law for enforcing a court order.

"(3) If a court places restrictions on driving privileges under this section:
"(a) The [*judge*] court shall immediately advise the department of the

The court shall grant the 6 motion if the court determines that the person is enrolled in such a 7 program. The person shall provide a statement from the program 8 certifying that the person is enrolled and including the date on which 9 the program ends and a statement that the program will notify the 10 court if the person fails to complete the program. If the court receives 11 a notice from the program that the person has failed to complete the 12 program, the court shall reissue the notice of suspension and imme-13 diately notify the department of the reissuance. The reissuance does 14 not extend the original period of suspension. 15

"(6) A person whose driving privileges are reinstated under sub-16 section (5) of this section shall establish a payment schedule with the 17 court and begin making payments within six months after completing 18 a preapprenticeship program and apprenticeship program, as defined 19 in ORS 660.010, or six months after completing an apprenticeship pro-20gram if the person was never enrolled in a preapprenticeship program. 21The court shall reissue the notice of suspension and immediately no-22tify the department if the person does not establish a payment sched-23ule within the time required under this subsection. The reissuance 24does not extend the original period of suspension. 25

"[(5)] (7) A court [shall] may not issue a notice of suspension under this

A person who is subject under this subsection remains 9 subject until the person presents the department with notice issued by the 10 court showing that the person is no longer subject to this section or until 11 10 years have elapsed, whichever is earlier. This subsection shall not subject 12 a person to ORS 809.415 (4) for any pedestrian offense, bicycling offense or 13 parking offense. Upon receipt of notice from a court, the department shall 14 send a letter by first class mail advising the person that the suspension will 15 commence 60 days from the date of the letter unless the person presents the 16 department with the notice required by this subsection. 17

(6) Upon determination by the department that a person has submitted false information to the department for the purpose of establishing or maintaining qualification to operate a commercial motor vehicle or hold a commercial driver license, the department may suspend the commercial driver
