

# DRAFT

## SUMMARY

Establishes task force to study workforce development in Oregon and to make recommendations for legislation to improve workforce development in this state. Requires task force to submit recommendations to Legislative Assembly by March 1, 2016.

Declares emergency, effective on passage.

## A BILL FOR AN ACT

Relating to workforce development; and declaring an emergency.

**Be It Enacted by the People of the State of Oregon:**

**SECTION 1. (1) The Task Force on Workforce Development in Oregon is established.**

**(2) The task force consists of nine members appointed as follows:**

**(a) The President of the Senate shall appoint one member from among members of the Senate.**

**(b) The Speaker of the House of Representatives shall appoint one member from among members of the House of Representatives.**

**(c) The Governor shall appoint seven members, three of whom shall represent the programs providing workforce development services in this state, three of whom shall represent individuals receiving workforce development assistance in Oregon and one of whom shall represent the interests of the public.**

**(3) The task force shall collect and synthesize information about workforce development activities in this state. The task force shall also make recommendations regarding legislation necessary for the maximization of workforce development activities in this state.**

1 (4) A majority of the members of the task force constitutes a quo-  
2 rum for the transaction of business.

3 (5) Official action by the task force requires the approval of a ma-  
4 jority of the members of the task force.

5 (6) The task force shall elect one of its members to serve as chair-  
6 person.

7 (7) If there is a vacancy for any cause, the appointing authority  
8 shall make an appointment to become immediately effective.

9 (8) The task force shall meet at times and places specified by the  
10 call of the chairperson or of a majority of the members of the task  
11 force.

12 (9) The task force may adopt rules necessary for the operation of  
13 the task force.

14 (10) The task force shall submit a report on the recommendations  
15 described in subsection (3) of this section to the regular session com-  
16 mittees of the Legislative Assembly related to education no later than  
17 March 1, 2016.

18 (11) The Department of Community Colleges and Workforce Devel-  
19 opment shall provide staff support to the task force.

20 (12) Notwithstanding ORS 171.072, members of the task force who  
21 are members of the Legislative Assembly are not entitled to mileage  
22 expenses or a per diem and serve as volunteers on the task force.  
23 Other members of the task force are not entitled to compensation or  
24 reimbursement for expenses and serve as volunteers on the task force.

25 (13) All agencies of state government, as defined in ORS 174.111, are  
26 directed to assist the task force in the performance of its duties and,  
27 to the extent permitted by laws relating to confidentiality, to furnish  
28 such information and advice as the members of the task force consider  
29 necessary to perform their duties.

30 SECTION 2. Section 1 of this 2015 Act is repealed on the date of the  
31 convening of the 2017 regular session of the Legislative Assembly as

1 specified in ORS 171.010.

2 **SECTION 3.** This 2015 Act being necessary for the immediate pres-  
3 ervation of the public peace, health and safety, an emergency is de-  
4 clared to exist, and this 2015 Act takes effect on its passage.
