Chair Monnes Anderson, members of the committee, I am Susan Jorg of Estacada, Oregon and I am a representative of Oregonians for Vaccine Truth and Healthcare Choice with over 1,000 subscribers.

I oppose Bill 442 because we need to stop medical mandates, not strengthen them.

We are told again and again that vaccines are "safe and effective." We are told this by the CDC, the OHA, medical professionals and the nightly news.

<u>Why should I listen to the medical profession</u>? I've learned the medical profession never seeks the most cost effective method. For the first 6 years of my son's life, doctors poked and prodded him with medications and surgery with no noticeable improvement in his health, his health actually deteriorated under their care. Then I listened to my intuition and took my son off dairy products and his health was restored. So again I ask, "Why should I listen to the medical industry which tried to destroy my son?"

<u>Why should I listen to the CDC</u>? Remember H1N1? Every time they have a new vaccine to promote they stir up as much fear as possible in order to drive up sales of that vaccine. Their own senior scientist, Dr. William Thompson, has confessed he was ordered to hide significant data so that the research on MMR reflected the "safe and effective" message. He has since been given whistleblower status by President Obama. Hopefully a speedy, open trial will deliver the truth to the American people.

<u>Why should I listen to NBC health correspondent Dr. Nancy Snyderman</u> when she says, "Just get your damn vaccines!"? When she wouldn't even follow quarantine requirements when she was exposed to Ebola? Have you listened to the hundreds of parents of vaccine-injured children who have responded to her remarks with their reasons for not getting the "Damn Vaccines"? I have! #hearthiswell

Why should I listen to the (OHA) Oregon Health Authority? Any organization that parrots the CDC has no credibility with me.

Who do I listen to?

<u>I listen to the Japanese government.</u> The MMR vaccine was banned in Japan in 1993 after 1.8 million children had been given two types of MMR and a record number developed non-viral meningitis and other adverse reactions. An analysis of vaccinations over a three-month period showed one in every 900 children was experiencing problems. This was over 2,000 times higher than the expected rate of one child in every 100,000 to 200,000. Dr Hiroki Nakatani, director of the Infectious Disease Division at Japan's Ministry of Health and Welfare said that giving individual vaccines cost twice as much as MMR 'but we believe it is worth it'.

<u>I listen to the Infant Mortality Rate statistics</u>. A study by Neil Z Miller and Gary S Goldman showed nations that require the most vaccines for their babies tend to have higher (worse) infant mortality rates. The United States spends more per capita on healthcare than any other country yet 33 nations have better infant mortality rates. All Scandinavian countries and Japan have the fewest vaccine mandates and also the lowest infant mortality rates.

<u>I listen to Brian Hooker, PhD in Bioengineering</u>. He is the father of a vaccine-damaged child. He has been researching vaccines for years, and is uncovering the graft and corruption rife within the CDC and the vaccine industry. He has found the MMR that is given on time will lead to more autism. The MMR that is delayed will lead to less autism. The best MMR, in his opinion, is the one that is not given. His research has led him to state, "The CDC is getting away with fraud, and they know it. Systematically they look at information that does not support

their credo that vaccines are always 'safe and effective' and they reject that information. They are harming children. It is called voluntary manslaughter, and it is a crime."

<u>I listen to the National Coalition of Organized Women</u>. The NCOW states that between 2009 and 2010 the mercury-laden combined flu vaccinations have increased Vaccine Adverse Events Reporting Systems (VAERS) fetal death reports by 4,250 percent in pregnant women. Eileen Dannemann, NCOW's director, said that despite these figures being known to the Centers for Disease Control (CDC), the multiple-strain, inactivated flu vaccine containing mercury (Thimerosal) has once again been recommended to pregnant women as a safe vaccination this season.

Outraged by the CDC's total disregard for human life, Ms. Dannemann accused the CDC of 'willful misconduct,' saying that they are responsible for causing the deaths of thousands of unborn babies. She stated that the CDC deliberately misled the nation's obstetricians and gynecologists and colluded with the *American Journal of Obstetrics and Gynecology* (AJOG) to mislead the public by advertising the flu vaccine as a safe vaccine for pregnant women when they knew full well that it was causing a massive spike in fetal deaths.

<u>I listen to information from the US National Library of Medicine</u>. Published in January 2015 on the Library of Medicine's website, a confidential, 1271 page GlaxoSmithKline document ordered recently by an Italian Court shows that multiple vaccines cause sudden child deaths. The GSK document contains data they chose to hide about deaths occurring as a result of administration of Prevenar 13 vaccine [from Pfizer], Infanrix Hexa from GSK and other vaccines.



Deaths in the first 10 days compared to the next 10 days clearly show 65 deaths in the first 10 days and 2 deaths in the next 10 days. Had the deaths been coincidental and unrelated to the vaccine, the number of deaths in the two 10 day periods should have been the same.

Is Allopathic medicine dying a slow death? Are doctors, politicians, and bureaucrats working frantically to shore it up and force people into medical procedures? Dr. Wakefield has said, *"If you have a vaccination policy in this country (The United States) which mandates, which takes your children away, which puts you at gunpoint, which puts parents in prison for not vaccinating, that is not built upon public trust and confidence; that is a disaster. Public health policy and vaccination policy requires the confidence of the public and they have lost it.*"
