Context

- Oregon Business Plan set a goal reducing poverty to below 10% by 2020
- ECONorthwest authored a December 2013 strategy paper that called for safety net redesign
- An OBC Poverty Taskforce identified TANF redesign as a policy priority for the 2015 legislative session

Oregon's TANF Program

- Unlike most states, caseloads increased during the economic downturn
- Maximum benefit levels are above the US median but have eroded with inflation
- Eligibility ends at low levels of earnings

Nationally, TANF caseloads were unresponsive during the economic downturn

Oregon's maximum TANF benefits are above median but have eroded with inflation
