## HB 2876: Certification of Surgical Technologists

- Scope of practice of surgical technologists
- Certification of surgical technologists practicing in all hospitals and ambulatory surgical centers
  - Graduates of accredited surgical technology programs, AND
  - Certified by the National Board of Surgical Technology and Surgical Assisting
  - Military trained
- Entry to practice model
  - Grandfather provisions (currently working)
  - Exception for licensed professionals
  - Grace period for students
- Continuing education (CST or 15 hours annually)
- Rural/medically underserved exception

## **Types of Public Policy Strategies**

#### • Brute Force

- "You can get a lot farther with a smile and a gun than you can with a smile alone." Al Capone
- Money Talks, Everybody Walks
  - Corporate PACS and Political Influence
- Logrolling and Backscratching
  - Political Patronage, Payola, Perks and the Public Trough
- The Power of Constituency
  - "No single type of political influence activity is nearly as effective as a well-executed effort at the grassroots."

# What Drives Legislative and Public Policy Initiatives?

### **GRASSROOTS!!**

*Grassroots* is individuals coalescing around a <u>specific issue</u> using a <u>common argument</u> and/or message to achieve a <u>common goal</u> guided by a <u>singular strategy.</u>

## So You Want to Be in Politics....

### • You are the experts:

- You have the education
- You have the experience
- You know the issues



Surgical Technology is YOUR profession

- YOUR stories make the issues real
- Your profession is at stake

## Involvement in Public Policy is your Right and Obligation

Set! (Position)
GO!!!!



## READY: Preparing for Grassroots Involvement

- Identify the issues that affect you
- Identify a champion for the issue it could be you!
- Become an expert on the subject matter of the issue
- Identify colleagues, stakeholders, potential coalition members, public agencies affected

## **SET:** Positioning the Issue

- Establish yourself as the expert in the field
  - Goal: "What does AST say?"
- Build networks of those with similar interests
  - Hold interested stakeholder meetings to increase involvement
- Make yourself visible and KNOWN to the decisionmakers
  - Attend committee hearings, study sessions
  - Identify and research key decision makers
  - Volunteer for political campaigns

# **NOW!!** Advancing HB2876

- Rally the troops
- Visit legislators
- Write/call legislators
- Engage stakeholders to support you
- Attention (lots!) to the issue is key
- Make some noise!!

# The 3 "Hs" of Decision-making for Legislators

#### (1) Head

- Is this good policy?
- Is this a smart course of action?
- Does this make logical sense?
- (2) Heart
  - Is this the right thing to do?
  - Is this an issue that I am passionate about?
  - Is this a moral or ethical issue?
- (3) Health
  - Is this a politically healthy thing to do?
  - Will my position on this keep me in office?
  - How will this issue affect my reputation?





# The Oregon Campaign 2015: Five strategies

- Legislative meetings: In-District and Capitol
- Letter writing campaign
- Phone advocacy
- Stakeholder support and involvement
- Uncontested bill
- Whitewater rafting

## SO, HERE'S HOW IT'S DONE Visiting Lawmakers

#### Preparation and execution

- Schedule your appointments
- Do your homework
- Practice, practice, practice
- Be organized stay on point
- Be professional don't argue, or disparage your colleagues or opponents
- Use the power of data
- Make the ASK!
- You helped them get elected; they'll try to help you
- Offer yourself as a resource for follow-up



## **Writing Effective Letters**

- Formal address and salutation
- Bill name and number
- Your profession (surgical technologist) and place of employment
- Purpose for writing the letter
- Your personal story
- A clear "ask"
- A thank you
- Your return address- identifies you as a constituent
- A one-page letter is best. AST WILL ASSIST!!

"A single handwritten letter is seen by the recipient as representing the position of 50 constituents."

# **Making Effective Telephone Calls**

- Capitol office or district depends on time in session
- Don't be intimidated! But practice beforehand.
- State your name and reason (issue) for calling
- Be brief / to the point / professional
- Request support or opposition from decisionmaker (you will probably talk to staff so be clear and concise so that the message is delivered properly)
- Leave contact information
- Request follow-up
- Thank them for their time

## **Stakeholder Support**

- Stakeholders include surgeons, hospital administrators, nurses, OR managers, educators, patients
- OAST champions enlist members to contact stakeholders
- Letter writing campaign
  - AST GAPA can formulate message, collect letters
- Stakeholder testimony at hearings

## **Public Support**

- Mock surgery
- Media: articles/letters
- Visits to Surgical Technology Programs
- Patient groups (AARP, etc.)
- DATA!

## Barriers to Effective Advocacy The "I's" Have It

#### • Ignorance

- "You can educate ignorance, but you can't teach stupid."
- Inertia
  - "I never lost a football game, I just ran out of time." – Joe Paterno
- Inconsistency
  - "I feel strongly both ways."

#### Inattention

- "A bill not considered today is a bill not considered today."
- Indifference
- Interference
- Intimidation
- Intractability

BUT NOT IMPOSSIBILITY!!

## FINAL THOUGHTS: GRASSROOTS STRATEGY FOR ST CERTIFICATION

#### Grow your own grassroots

- State Assembly members and leadership
- Champions become grassroots spearhead committee
- Identify your colleagues and partners
  - Surgeons, OR team members, nurses, OR managers, administrators, educators, patients, other?
  - Set meetings for stakeholders and share ideas
- Become the expert show me the data!!
- Bend the data to your issue
  - ACA, preventable medical errors, HAIs, SSIs
- Become the champion "ham and eggs"
