- part of Travel Oregon work group on agritourism, helped organize Oregon's first Agitourism Summit at a OSU

What I offer as an agritourism farm stay

- chance to connect with the farmer, his/her land, hear her story
- chance to ask questions about what we do, how we do it, why we do it, hands-on experience
- chance to be in nature and experience unplugged lifestyle
- chance to eat farm fresh eggs and produce right from the soil
- education about small scale production, diversified farming techniques

What others offer

- pumpkin patches at E-Z Orchards, flower festivals at Wooden Shoe Tulip festival, you-pick at Fairfield Farm, Plate and Pitchfork dinners, school groups to Molalla elk farm, you-cut Christmas trees, crush parties at vineyards, cattle drives on ranches
- many entrepreneurial ideas to diversify operations so not held hostage to weather or commodity conditions

Why it's important

- rural economic development trickle down to communities in which agritourism operation based
- small farm sustainability economies of scale dictate that small farms hard to make a living, but with diversification into related activity makes it possible to hang on to farm
- state(and country) needs small farms to continue heritage lines for livestock and seeds, refinement of low-tech operations, relationship with consumer that not possible from large-scale operations
- teaches urbanites where food comes from and connects them to it something legislature has been interested in with farm to school and healthy food initiatives
- demonstrates stewardship of land entrusted to us and environmental interests solar panels and composter
