TO: Chair Gelser and Members of the Senate Committee on Human Services and Early Childhood

RE: Support of SB 777

The Association of Oregon Community Mental Health Programs (AOCMHP) supports SB 777, which implements the Achieving a Better Life Experience (ABLE) Act in Oregon.

AOCMHP's membership includes 32 Community Developmental Disability Programs (CDDPs) across Oregon -- often the first contacts in the community for people with I/DD. CDDP programs are operated by either local government, usually through Community Mental Health Programs, or by not-for-profit entities that contract with local government or directly with the State. CDDPs help assure the protection and safety of over 22,000 Oregonians with I/DD in collaboration with families and providers.

The ABLE Act allows families the opportunity to set up a tax-exempt 529A savings account under IRS for disability-related expenses. Families who have children with disabilities will be able to supplement their federal disability benefits and plan for the future. Families can save for or have access to more employment supports, housing expenses, education services not covered such as tuition and tutors, transportation including purchase of or modification of vehicles, health related costs and assistive technology.

A critical benefit is that individuals will no longer risk loss of their Supplemental Security Income and other benefits as the ABLE Act disregards the current \$2000 cap on savings. This is not only an incentive to support individuals become more self-sufficient and independent, but helps families invest in their sons and daughters' futures as they would for any of their other children.

We urge you to pass SB 777 and join the 5 states that have passed legislation and 31 states with pending legislation and support the 22,000 Oregonians with disabilities and their families to achieve greater independence and have a "real life" in the community.

Thank you for the opportunity to provide testimony in support of SB 777.
